5	SECTION 1. Title 12, Business & Commerce Code, is amended by
6	adding Chapter 601A to read as follows:
7	CHAPTER 601A. CANCELLATION OF AGREEMENT FOR TRAVEL CLUB MEMBERSHIP
8	SUBCHAPTER A. GENERAL PROVISIONS
9	Sec. 601A.001. DEFINITIONS. In this chapter:
10	(1) "Purchaser" means an individual who enters into an
11	agreement with a seller to purchase a travel club membership.
12	(2) "Seller" means a person who offers to sell or sells
13	a travel club membership.
14	(3) "Travel club membership" means a membership that
15	gives its members the right to purchase or obtain travel services
16	from or through a seller.
17	(4) "Travel service" means the arranging or booking
18	of:
19	(A) a vacation or travel package;
20	(B) a reservation for rental of a motor vehicle;
21	(C) a ticket for domestic or foreign travel by
22	any mode of transportation; or
23	(D) a hotel or other lodging.

Sec. 601A.002. APPLICABILITY OF CHAPTER. (a) This chapter

- 16 Sec. 601A.051. PURCHASER'S RIGHT TO CANCEL AGREEMENT FOR
- 17 TRAVEL CLUB MEMBERSHIP. (a) In addition to any other rights or
- 18 remedies available, a purchaser may cancel an agreement for a
- 19 travel club membership not later than midnight of the fifth
- 20 business day after the date the purchaser signs the agreement.
- 21 (b) A seller may retain payments made by the purchaser for
- 22 specific travel services used in connection with a travel club
- 23 membership agreement before the date of the cancellation period
- 24 prescribed by Subsection (a).
- Sec. 601A.052. NOTICE OF PURCHASER'S RIGHT TO CANCEL
- 26 REQUIRED. (a) A seller must provide a purchaser with a copy of an
- 27 agreement for a travel club membership at the time of the

2	(b) The copy of the agreement provided under Subsection (a)
3	must:
4	(1) be in the same language as that principally used in
5	the oral sales presentation;
6	(2) contain the date of the agreement;
7	(3) contain the name and address of the seller; and

17	Sec. 601A.053. COMPLETED CANCELLATION FORM REQUIRED. (a)
18	A seller must attach to the copy of a travel club membership
19	agreement a completed notice of cancellation form in duplicate.
20	The form must:
21	(1) be easily detachable;
22	(2) be in the same language as the agreement; and
23	(3) contain the following information and statements
24	in at least 10-point boldfaced font:
25	"NOTICE OF CANCELLATION

1	"YOU MAY CANCEL THIS AGREEMENT FOR TRAVEL CLUB MEMBERSHIP,
2	WITHOUT ANY PENALTY OR OBLIGATION, WITHIN FIVE BUSINESS DAYS AFTER
3	THE ABOVE DATE UNLESS YOU HAVE ALREADY USED ANY TRAVEL SERVICES

10	"IF YOU CANCEL, ANY PAYMENTS MADE BY YOU UNDER THIS AGREEMENT
11	THAT WERE NOT FOR SPECIFIC TRAVEL SERVICES USED WILL BE RETURNED
12	WITHIN 10 BUSINESS DAYS FOLLOWING RECEIPT BY THE SELLER OF YOUR
13	CANCELLATION NOTICE.
14	"TO CANCEL THIS AGREEMENT, MAIL OR DELIVER A SIGNED AND DATED
15	COPY OF THIS CANCELLATION NOTICE OR ANY OTHER WRITTEN NOTICE,
16	INCLUDING BY E-MAIL OR FACSIMILE, TO (name of seller), AT (address,
17	e-mail address, and fax number of seller's place of business) NOT
18	LATER THAN MIDNIGHT OF (date).

7	SUBCHAPTER C. PROHIBITED ACTS BY SELLER
8	Sec. 601A.101. WAIVER OF RIGHTS. A seller may not include
9	in an agreement for a travel club membership a waiver of any of the
10	rights to which a purchaser is entitled under this chapter.
11	Sec. 601A.102. FAILURE TO INFORM OR MISREPRESENTATION OF
12	RIGHT TO CANCEL. A seller may not:
13	(1) at the time the purchaser signs the agreement for a
14	travel club membership fail to inform the purchaser orally of the
15	right to cancel the agreement; or
16	(2) misrepresent in any manner the purchaser's right
17	to cancel.
18	Sec. 601A.103. FAILURE TO TAKE CERTAIN ACTIONS FOLLOWING
19	RECEIPT OF NOTICE OF CANCELLATION. A seller may not:
20	(1) fail or refuse to honor a valid cancellation under
21	this chapter by a purchaser; or
22	(2) fail before the end of the 10th business day after
23	the date the seller receives a valid notice of cancellation to:
24	(A) refund all payments made under the agreement
25	that were not for specific travel services used before the
26	cancellation period; or
27	(B) cancel and return any negotiable instrument

- 4 SUBCHAPTER D. ENFORCEMENT
- 5 Sec. 601A.151. CERTAIN AGREEMENTS VOID. An agreement
- 6 entered into in violation of this chapter is void.
- 7 Sec. 601A.152. LIABILITY FOR DAMAGES. A seller who
- 8 violates this chapter is liable to the purchaser for:
- 9 <u>(1) actual damages suffered by the purchaser as a</u>
- 10 result of the violation;
- 11 (2) reasonable attorney's fees; and
- 12 <u>(3) court costs.</u>
- Sec. 601A.153. DECEPTIVE TRADE PRACTICE. A violation of
- 14 this chapter is a false, misleading, or deceptive act or practice as
- 15 defined by Section 17.46(b). In addition to any remedy under this
- 16 <u>chapter</u>, a remedy under Subchapter E, Chapter 17, is also available
- 17 <u>for a violation of this chapter.</u>
- 18 Sec. 601A.154. INJUNCTION. If the attorney general
- 19 believes that a person is violating or about to violate this
- 20 chapter, the attorney general may bring an action in the name of the
- 21 state to restrain or enjoin the person from violating this chapter.
- 22 SECTION 2. The change in law made by this Act applies only
- 23 to an agreement for a travel club membership entered into on or
- 24 after the effective date of this Act. An agreement for a travel
- 25 club membership that is entered into before the effective date of
- 26 this Act is governed by the law in effect on the date the agreement
- 27 was entered into, and the former law is continued in effect for that
