19 (3) a current or former employee of the Texas 20 Department of Criminal Justice or of the predecessor in function of 21 the department or any division of the department, regardless of 22 whether the current or former employee complies with Section 23 552.1175;

24 (4) a peace officer as defined by Article 2.12, Code of

1 Criminal Procedure, or other law, a reserve law enforcement 2 officer, a commissioned deputy game warden, or a corrections 3 officer in a municipal, county, or state penal institution in this 4 state who was killed in the line of duty, regardless of whether the 5 deceased complied with Section 552.024 or 552.1175;

6 (5) a commissioned security officer as defined by 7 Section 1702.002, Occupations Code, regardless of whether the 8 officer complies with Section 552.024 or 552.1175, as applicable; 9 [or]

10 (6) an officer or employee of a community supervision 11 and corrections department established under Chapter 76 who 12 performs a duty described by Section 76.004(b), regardless of 13 whether the officer or employee complies with Section 552.024 or 14 552.1175; or

15 <u>(7) a current or former employee of the office of the</u> 16 <u>attorney general who is or was assigned to a division of that office</u> 17 <u>the duties of which involve law enforcement, regardless of whether</u> 18 <u>the current or former employee complies with Section 552.024 or</u> 19 <u>552.1175</u>.

20 SECTION 2. Section 552.1175(a), Government Code, is amended 21 to read as follows:

SECTION 3. Section 25.025(a), Tax Code, is amended to read as follows:

and corrections department established under Chapter 76,
Government Code, who performs a duty described by Section 76.004(b)
of that code;

17 (9) a criminal investigator of the United States as
18 described by Article 2.122(a), Code of Criminal Procedure; [and]

19 (10) a police officer or inspector of the United
20 States Federal Protective Service; and

21 (11) a current or former employee of the office of the 22 attorney general who is or was assigned to a division of that office 23 the duties of which involve law enforcement.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this

1 Act takes effect September 1, 2011.
