- aquatic life taken for sporting purposes from waters managed by the Gulf of Mexico Fishery Management Council established under the Magnuson-Stevens Fishery Conservation and Management Act [of 1976] (16 U.S.C. Section 1801 et seq.), unless the person [he] has acquired a fishing license issued under this subchapter, except as provided by Sections 46.0012 and 46.002. The commission by rule may
- 14 prescribe requirements relating to possessing a license required by this subchapter.
- 16 (b) A person in a vessel on tidal water may not possess fish
 17 taken for sporting purposes unless the person holds a fishing
 18 license issued under this subchapter, except as provided by
 19 Sections 46.0012 and 46.002. In this subsection, "tidal water" has
 20 the meaning assigned by Section 47.001.
- SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this
