BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

(a) The governing board of each institution of higher education shall provide for the payment of tuition and <u>mandatory</u> fees for <u>a semester or term of 10 weeks or longer</u> [the fall and 1-14 1**-**15 1**-**16 1-17 spring semesters] through one of the following alternatives:

(c) If after the due date for a student's tuition and <u>mandatory</u> fees is postponed under this section the student becomes ineligible to receive one or more of the delayed financial aid 3-25 3**-**26 3-27 3-28 awards, or the amount awarded is less than the amount of tuition and <u>mandatory</u> fees due, the governing board shall provide the student a reasonable period, not to exceed 30 days, to pay the unpaid amount of tuition and <u>mandatory</u> fees. The board may deny a student credit 3-29 3-30 3-31 for work done in the semester or term [summer session] if the 3-32 3-33 student fails to pay the tuition and mandatory fees by the end of 3-34 that period.

3-46 SECTION 4. This Act takes effect immediately if it receives 3-47 a vote of two-thirds of all the members elected to each house, as 3-48 provided by Section 39, Article III, Texas Constitution. If this 3-49 Act does not receive the vote necessary for immediate effect, this 3-50 Act takes effect September 1, 2011.
