## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the coverage by health benefit plans of expenses or
3	procedures that violate certain religious convictions.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle A, Title 8, Insurance Code, is amended
6	by adding Chapter 1219 to read as follows:
7	CHAPTER 1219. COVERAGE FOR HEALTH CARE SERVICE THAT VIOLATES
8	CERTAIN RELIGIOUS CONVICTIONS
9	Sec. 1219.001. APPLICABILITY OF CHAPTER. (a) This chapter
10	applies only to a health benefit plan that provides benefits for
11	medical or surgical expenses incurred as a result of a health
12	condition, accident, or sickness, including an individual, group,
13	blanket, or franchise insurance policy or insurance agreement, a
14	group hospital service contract, or an individual or group evidence
15	of coverage or similar coverage document that is offered by:
16	(1) an insurance company;
17	(2) a group hospital service corporation operating
18	under Chapter 842;
19	(3) a fraternal benefit society operating under
20	Chapter 885;
21	(4) a stipulated premium company operating under
22	Chapter 884;
23	(5) an exchange operating under Chapter 942;
24	(6) a health maintenance organization operating under

- 1 <u>Chapter 843;</u>
- 2 (7) a multiple employer welfare arrangement that holds
- 3 a certificate of authority under Chapter 846; or
- 4 (8) an approved nonprofit health corporation that
- 5 holds a certificate of authority under Chapter 844.
- 6 (b) This chapter applies to group health coverage made
- 7 available by a school district in accordance with Section 22.004,
- 8 Education Code.
- 9 (c) Notwithstanding Section 172.014, Local Government Code,
- 10 or any other law, this chapter applies to health and accident
- 11 coverage provided by a risk pool created under Chapter 172, Local
- 12 Government Code.
- 13 (d) Notwithstanding any provision in Chapter 1551, 1575,
- 14 1579, or 1601 or any other law, this chapter applies to:
- 15 (1) a basic coverage plan under Chapter 1551;
- 16 (2) a basic plan under Chapter 1575;
- 17 (3) a primary care coverage plan under Chapter 1579;
- 18 and
- 19 (4) basic coverage under Chapter 1601.
- 20 (e) Notwithstanding Section 1501.251 or any other law, this
- 21 chapter applies to coverage under a small or large employer health
- 22 <u>benefit plan subject to Chapter 1501.</u>
- 23 (f) Notwithstanding Section 1507.003 or 1507.053, this
- 24 chapter applies to a standard health benefit plan provided under
- 25 Chapter 1507.
- Sec. 1219.002. RELIGIOUS CONVICTIONS. (a) A health
- 27 benefit plan may limit or exclude coverage for any medical,

- 1 surgical, or other health care service that violates the religious
- 2 convictions of the issuer.
- 3 (b) A policyholder or sponsor of a group health benefit plan
- 4 or an employer or other entity that provides health benefit plan
- 5 coverage for its employees or members may decline or refuse to
- 6 purchase health benefit plan coverage that violates the religious
- 7 convictions of the policyholder, sponsor, employer, or other
- 8 entity.
- 9 (c) An issuer of a health benefit plan that excludes or
- 10 <u>limits coverage for a medical, surgical, or other health care</u>
- 11 service under Subsection (a) shall state the exclusion or
- 12 limitation in:
- 13 (1) the plan's coverage document;
- 14 (2) the plan's statement of benefits;
- 15 (3) plan brochures; and
- 16 (4) other informational materials for the plan.
- 17 (d) A policyholder, sponsor, employer, or other entity that
- 18 declines or refuses to purchase health benefit plan coverage under
- 19 Subsection (b) shall provide written notice of the declination or
- 20 refusal to the employees or members of the policyholder, sponsor,
- 21 employer, or other entity.
- 22 SECTION 2. This Act applies only to a health benefit plan
- 23 that is delivered, issued for delivery, or renewed on or after
- 24 January 1, 2012. A health benefit plan that is delivered, issued
- 25 for delivery, or renewed before January 1, 2012, is governed by the
- 26 law as it existed immediately before the effective date of this Act,
- 27 and that law is continued in effect for that purpose.
