5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8249 to read as follows:
8	CHAPTER 8249. CASE CREEK MUNICIPAL UTILITY DISTRICT NO. 1 OF
9	GRAYSON COUNTY
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8249.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the district's board of directors.
13	(2) "Commission" means the Texas Commission on
14	Environmental Quality.
15	(3) "Director" means a board member.
16	(4) "District" means the Case Creek Municipal Utility
17	District No. 1 of Grayson County.
18	Sec. 8249.002. NATURE OF DISTRICT. The district is a
19	municipal utility district created under Section 59, Article XVI,
20	Texas Constitution.
21	Sec. 8249.003. CONFIRMATION AND DIRECTORS' ELECTION
22	REQUIRED. The temporary directors shall hold an election to
23	confirm the creation of the district and to elect five permanent
24	directors as provided by Section 49.102, Water Code.

1	Sec. 8249.004. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
2	The district is created to serve a public purpose and benefit.
3	(b) The district is created to accomplish the purposes of:
4	(1) a municipal utility district as provided by
5	general law and Section 59, Article XVI, Texas Constitution; and
6	(2) Section 52, Article III, Texas Constitution, that
7	relate to the construction, acquisition, improvement, operation,
8	or maintenance of macadamized, graveled, or paved roads, or
9	improvements, including storm drainage, in aid of those roads.
10	Sec. 8249.005. INITIAL DISTRICT TERRITORY. (a) The
11	district is initially composed of the territory described by
12	Section 2 of the Act enacting this chapter.
13	(b) The boundaries and field notes contained in Section 2 of
14	the Act enacting this chapter form a closure. A mistake made in the
15	field notes or in copying the field notes in the legislative process
16	does not affect the district's:
17	(1) organization, existence, or validity;
18	(2) right to issue any type of bond for the purposes
19	for which the district is created or to pay the principal of and
20	interest on a bond;
21	(3) right to impose a tax; or
22	(4) legality or operation.

24	SUBCHAPTER B. BOARD OF DIRECTORS
25	Sec. 8249.051. GOVERNING BODY; TERMS. (a) The district is
26	governed by a board of five elected directors.
27	(b) Except as provided by Section 8249.052, directors serve

- 1 staggered four-year terms.
- 2 Sec. 8249.052. TEMPORARY DIRECTORS. (a) On or after
- 3 September 1, 2011, the owner or owners of a majority of the assessed
- 4 value of the real property in the district may submit a petition to
- 5 the commission requesting that the commission appoint as temporary
- 6 directors the five persons named in the petition. The commission
- 7 shall appoint as temporary directors the five persons named in the
- 8 petition.
- 9 (b) Temporary directors serve until the earlier of:
- 10 (1) the date permanent directors are elected under
- 11 Section 8249.003; or
- 12 (2) September 1, 2015.
- 13 (c) If permanent directors have not been elected under
- 14 Section 8249.003 and the terms of the temporary directors have
- 15 expired, successor temporary directors shall be appointed or
- 16 reappointed as provided by Subsection (d) to serve terms that
- 17 expire on the earlier of:
- 18 (1) the date permanent directors are elected under
- 19 Section 8249.003; or
- 20 (2) the fourth anniversary of the date of the
- 21 appointment or reappointment.
- 22 (d) If Subsection (c) applies, the owner or owners of a
- 23 majority of the assessed value of the real property in the district
- 24 may submit a petition to the commission requesting that the
- 25 commission appoint as successor temporary directors the five
- 26 persons named in the petition. The commission shall appoint as
- 27 successor temporary directors the five persons named in the

1 petition. 2 [Sections 8249.053-8249.100 reserved for expansion] 3 SUBCHAPTER C. POWERS AND DUTIES Sec. 8249.101. GENERAL POWERS AND DUTIES. The district has 4 5 the powers and duties necessary to accomplish the purposes for which the district is created. 6 Sec. 8249.102. MUNICIPAL UTILITY DISTRICT POWERS 7 8 DUTIES. The district has the powers and duties provided by the general law of this state, including Chapters 49 and 54, Water Code, 9 10 applicable to municipal utility districts created under Section 59, Article XVI, Texas Constitution. 11 12 Sec. 8249.103. AUTHORITY FOR ROAD PROJECTS. Under Section 52, Article III, Texas Constitution, the district may design, 13 acquire, construct, finance, issue bonds for, improve, operate, 14 maintain, and convey to this state, a county, or a municipality for 15 operation and maintenance macadamized, graveled, or paved roads, or 16 17 improvements, including storm drainage, in aid of those roads. Sec. 8249.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road 18 19 project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of each municipality in 20 whose corporate limits or extraterritorial jurisdiction the road 21 22 project is located.

(b) If a road project is not located in the corporate limits

or extraterritorial jurisdiction of a municipality, the road

project must meet all applicable construction standards,

subdivision requirements, and regulations of each county in which

- 1 (c) If the state will maintain and operate the road, the
- 2 Texas Transportation Commission must approve the plans and
- 3 specifications of the road project.
- 4 Sec. 8249.105. COSTS OF ROAD PROJECT. The district shall
- 5 bear the cost of maintaining, improving, operating, and repairing a
- 6 road located in the district and authorized by Section 8249.103 in
- 7 <u>accordance</u> with all applicable ordinances and rules of the
- 8 political subdivision authorized to exercise jurisdiction over the
- 9 road, regardless of whether the district conveys the road to this
- 10 state, a county, or a municipality.
- 11 Sec. 8249.106. LIMITATION ON USE OF EMINENT DOMAIN. The
- 12 district may not exercise the power of eminent domain outside the
- 13 district to acquire a site or easement for:
- 14 (1) a road project authorized by Section 8249.103; or
- 15 (2) a recreational facility as defined by Section
- 16 <u>49.462</u>, Water Code.
- 17 Sec. 8249.107. LIMITATION ON WATER SUPPLY AND WASTEWATER
- 18 SERVICES; USE OF DISTRICT FACILITIES BY TWO WAY SPECIAL UTILITY
- 19 DISTRICT. (a) The district may not act as a retail provider of
- 20 water or wastewater services in the district except as provided by
- 21 this section.
- (b) Except as provided by Subsection (c), the district shall
- 23 convey or otherwise assign the district's water supply facilities
- 24 and wastewater facilities to Two Way Special Utility District.
- 25 (c) If Two Way Special Utility District refuses or is unable
- 26 to provide water supply or wastewater service to customers located
- 27 in the district, the district may retain the necessary facilities

- 1 and provide water supply or wastewater service, as applicable, to
- 2 those customers.
- 3 [Sections 8249.108-8249.150 reserved for expansion]
- 4 SUBCHAPTER D. DIVISION OF DISTRICT INTO MULTIPLE DISTRICTS
- 5 Sec. 8249.151. DIVISION OF DISTRICT; PREREQUISITES. The
- 6 district may be divided into two or more new districts only if the
- 7 district:
- 8 (1) has no outstanding bonded debt; and
- 9 (2) is not imposing ad valorem taxes.
- 10 Sec. 8249.152. LAW APPLICABLE TO NEW DISTRICT. This
- 11 chapter applies to any new district created by division of the
- 12 district, and a new district has all the powers and duties of the
- 13 district.
- 14 Sec. 8249.153. LIMITATION ON AREA OF NEW DISTRICT. A new
- 15 district created by the division of the district may not, at the
- 16 time the new district is created, contain any land outside the area
- 17 described by Section 2 of the Act enacting this chapter.
- 18 Sec. 8249.154. DIVISION PROCEDURES. (a) The board, on its
- 19 own motion or on receipt of a petition signed by the owner or owners
- 20 of a majority of the assessed value of the real property in the
- 21 district, may adopt an order dividing the district.
- (b) The board may adopt an order dividing the district
- 23 before or after the date the board holds an election under Section
- 24 8249.003 to confirm the district's creation.
- 25 <u>(c) An order dividing the district must:</u>
- 26 (1) name each new district;
- 27 (2) include the metes and bounds description of the

- 1 territory of each new district; 2 (3) appoint temporary directors for each new district; 3 and 4 (4) provide for the division of assets and liabilities between the new districts. 5 6 (d) On or before the 30th day after the date of adoption of 7 an order dividing the district, the district shall file the order 8 with the commission and record the order in the real property records of each county in which the district is located. 10 Sec. 8249.155. CONFIRMATION ELECTION FOR NEW DISTRICT. (a) A new district created by the division of the district shall hold a 11 confirmation and directors' election as required by Section 12 13 8249.003. 14 (b) If the creation of the new district is confirmed, the 15 new district shall provide the election date and results to the 16 commission. 17 Sec. 8249.156. TAX OR BOND ELECTION. Before a new district created by the division of the district may impose a maintenance tax 18 19 or issue bonds payable wholly or partly from ad valorem taxes, the new district must hold an election as required by this chapter to 20

- 24 Sec. 8249.201. ELECTIONS REGARDING TAXES OR BONDS. (a) The

7	taxes to finance a road project unless the issuance is approved by a
8	vote of a two-thirds majority of the district voters voting at an

10	Sec. 8249.202. OPERATION AND MAINTENANCE TAX. (a) If
11	authorized at an election held under Section 8249.201, the district
12	may impose an operation and maintenance tax on taxable property in
13	the district in accordance with Section 49.107, Water Code.
14	(b) The board shall determine the tax rate. The rate may not
15	exceed the rate approved at the election.
16	Sec. 8249.203. CONTRACT TAXES. (a) In accordance with
17	Section 49.108, Water Code, the district may impose a tax other than
18	an operation and maintenance tax and use the revenue derived from
19	the tax to make payments under a contract after the provisions of
20	the contract have been approved by a majority of the district voters
21	voting at an election held for that purpose.
22	(b) A contract approved by the district voters may contain a
23	provision stating that the contract may be modified or amended by
24	the board without further voter approval.

26	SUBCHAPTER F. BONDS AND OTHER OBLIGATIONS
27	Sec. 8249.251. AUTHORITY TO ISSUE BONDS AND OTHER

- 1 OBLIGATIONS. The district may issue bonds or other obligations
- 2 payable wholly or partly from ad valorem taxes, impact fees,
- 3 revenue, contract payments, grants, or other district money, or any
- 4 combination of those sources, to pay for any authorized district
- 5 purpose.
- 6 Sec. 8249.252. TAXES FOR BONDS. At the time the district
- 7 issues bonds payable wholly or partly from ad valorem taxes, the
- 8 board shall provide for the annual imposition of a continuing
- 9 direct ad valorem tax, without limit as to rate or amount, while all
- 10 or part of the bonds are outstanding as required and in the manner
- 11 provided by Sections 54.601 and 54.602, Water Code.
- 12 Sec. 8249.253. BONDS FOR ROAD PROJECTS. At the time of
- 13 issuance, the total principal amount of bonds or other obligations
- 14 issued or incurred to finance road projects and payable from ad
- 15 valorem taxes may not exceed one-fourth of the assessed value of the
- 16 <u>real property in the district.</u>
