8	department shall evaluate highway use in this state by oversize or		
9	overweight vehicles, calculate the cost of damage to highways in		
10	this state caused by those vehicles, and determine whether:		
11	(1) the fees charged for permits issued under this		
12	chapter are adequate to offset the costs of damage to highways		
13	caused by those vehicles and recommend any fee adjustments for the		
14	permits to reflect the costs of damage to highways caused by those		
15	vehicles; and		
16	(2) vehicles currently exempt from permit		
17	requirements under this chapter should be required to obtain a		
18	permit to operate on roads or highways in this state.		
19	(b) Not later than October 1 of each even-numbered year, the		
20	department shall report its findings to:		
21	(1) the Legislative Budget Board; and		
22	(2) the governor.		
23	SECTION 2. Section 623.077, Transportation Code, is amended

(b) <u>The department shall adopt rules to implement this</u> section and establish a schedule of rates, based on miles traveled, for all vehicle weight categories that provides for an increase in the rates according to the weight of a vehicle.

15 (c) The department shall send each fee collected under 16 Subsection (a) to the comptroller for deposit to the credit of the 17 state highway fund.

18 SECTION 3. (a) The Texas Department of Transportation 19 shall adopt rules implementing Section 623.077, Transportation 20 Code, as amended by this Act, not later than January 1, 2012.

21 (b) Section 623.077(a), Transportation Code, as amended by this Act, applies only to an application for a permit submitted 22 23 under Subchapter D, Chapter 623, Transportation Code, to the Texas 24 Department of Transportation on or after January 1, 2012. An application for a permit submitted before January 1, 2012, is 25 governed by the law in effect on the date the application was 26 submitted, and that law is continued in effect for that purpose. 27
