H.B. No. 1710

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Rio de Vida Planning and Improvement District No. 1; providing authority to levy an assessment, impose a tax, and issue bonds.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle C, Title 4, Special District Local Laws Code, is amended by adding Chapter 3867 to read as follows:

CHAPTER 3867. RIO DE VIDA PLANNING AND IMPROVEMENT

DISTRICT NO. 1

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 3867.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "City" means the City of Austin, Texas.

(3) "County" means Travis County.

(4) "Director" means a board member.

(5) "District" means the Rio de Vida Planning and Improvement District No. 1.

(6) "Improvement project" means a project authorized by Section 3867.102 or Subchapter C-1.

Sec. 3867.002. CREATION AND NATURE OF DISTRICT. The district is a special district created under Section 59, Article XVI, Texas Constitution.

Sec. 3867.003. PURPOSE; DECLARATION OF INTENT. (a) The creation of the district is essential to accomplish the purposes of

1 Sections 52 and 52-a, Article III, and Section 59, Article XVI,
2 Texas Constitution, and other public purposes stated in this
3 chapter. By creating the district and in authorizing the city, the
4 county, and other political subdivisions to contract with the
5 district, the legislature has established a program to accomplish
6 the public purposes set out in Section 52-a, Article III, Texas
7 Constitution.

8 (b) The creation of the district is necessary to promote,
9 develop, encourage, and maintain employment, commerce,
10 transportation, housing, tourism, recreation, the arts,
11 entertainment, economic development, safety, and the public
12 welfare in the district.

13 (c) This chapter and the creation of the district may not be
14 interpreted to relieve the city or the county from providing the
15 level of services provided as of the effective date of the Act
16 enacting this chapter to the area in the district. The district is
17 created to supplement and not to supplant city and county services
18 provided in the district.

19 Sec. 3867.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
20 The district is created to serve a public use and benefit.

21 (b) All land and other property included in the district
22 will benefit from the improvements and services to be provided by
23 the district under powers conferred by Sections 52 and 52-a,
24 Article III, and Section 59, Article XVI, Texas Constitution, and
25 other powers granted under this chapter.

26 (c) The creation of the district is in the public interest
27 and is essential to further the public purposes of:

1 (1) developing and diversifying the economy of the
2 state;

3 (2) eliminating unemployment and underemployment; and

4 (3) developing or expanding transportation and
5 commerce.

6 (d) The district will:

7 (1) promote the health, safety, and general welfare of
8 residents, employers, potential employees, employees, visitors,
9 and consumers in the district, and of the public;

10 (2) provide needed funding for the district to
11 preserve, maintain, and enhance the economic health and vitality of
12 the district territory as a community and business center; and

13 (3) promote the health, safety, welfare, and enjoyment
14 of the public by providing pedestrian ways and public gardens and by
15 landscaping and developing certain areas in the district, which are
16 necessary for the restoration, preservation, and enhancement of
17 scenic beauty.

18 (e) Pedestrian ways along or across a street, whether at
19 grade or above or below the surface, and street lighting, street
20 landscaping, parking, and street art objects are parts of and
21 necessary components of a street and are considered to be a street
22 or road improvement.

23 (f) The district will not act as the agent or
24 instrumentality of any private interest even though the district
25 will benefit many private interests as well as the public.

26 Sec. 3867.005. DISTRICT TERRITORY. (a) The district is
27 composed of the territory described by Section 2 of the Act enacting

this chapter, as that territory may have been modified under
Section 3867.110 or other law.

(b) The boundaries and field notes of the district contained
in Section 2 of the Act enacting this chapter form a closure. A
mistake in the field notes of the district contained in Section 2 of
the Act enacting this chapter or in copying the field notes in the
legislative process does not affect the district's:

(1) organization, existence, or validity;

(2) right to issue any type of bond or other obligation
for a purpose for which the district is created or to pay the
principal of and interest on the bond;

(3) right to impose or collect an assessment or tax; or

(4) legality or operation.

Sec. 3867.006. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
All or any part of the area of the district is eligible to be
included in:

(1) a tax abatement reinvestment zone created under
Chapter 312, Tax Code;

(2) an enterprise zone created under Chapter 2303,
Government Code; or

(3) an industrial district created under Chapter 42,
Local Government Code.

Sec. 3867.007. MUNICIPAL CONSENT REQUIRED. (a) The
district may not hold an election under Subchapter E until each
municipality in whose corporate limits or extraterritorial
jurisdiction the district is located consents by ordinance or
resolution to:

1 (1) the district's creation; and
2 (2) the inclusion of the municipality's land in the
3 district.

4 (b) Consent issued by the city under Subsection (a) may
5 include terms relating to:

6 (1) annexation by the city under Subchapter J; and
7 (2) the continuation of all or a portion of the
8 district's operations after annexation by the city under Subchapter
9 J.

10 Sec. 3867.008. APPLICABILITY OF MUNICIPAL MANAGEMENT
11 DISTRICTS LAW. Except as otherwise provided by this chapter,
12 Chapter 375, Local Government Code, applies to the district.

13 Sec. 3867.009. LIBERAL CONSTRUCTION OF CHAPTER. This
14 chapter shall be liberally construed in conformity with the
15 findings and purposes stated in this chapter.

16 [Sections 3867.010-3867.050 reserved for expansion]

17 SUBCHAPTER B. BOARD OF DIRECTORS

18 Sec. 3867.051. GOVERNING BODY; TERMS. The district is
19 governed by a board of five voting directors who serve staggered
20 terms of four years, with two or three directors' terms expiring
21 June 1 of each odd-numbered year.

22 Sec. 3867.052. APPOINTMENT OF DIRECTORS. (a) Except as
23 provided by Subsection (c), the members of the governing body of the
24 city shall appoint four directors from persons recommended by the
25 board and one director who has at least 15 years of experience in
26 the commercial real estate industry.

27 (b) A person is appointed if a majority of the members of the

governing body vote to appoint the person.

(c) Beginning on January 1, 2041, the members of the governing body of the city may appoint directors without the recommendation of the board. This subsection applies only to a director whose term expires on or after January 1, 2041.

Sec. 3867.053. QUALIFICATIONS. To be qualified to serve as a director, a person must:

(1) reside in the district; or

(2) own real property in the district.

Sec. 3867.054. QUORUM. For purposes of determining the requirements for a quorum of the board, the following are not counted:

(1) a board position vacant for any reason, including death, resignation, or disqualification; or

(2) a director who is abstaining from participation in a vote because of a conflict of interest.

Sec. 3867.055. COMPENSATION. A director is entitled to receive fees of office and reimbursement for actual expenses as provided by Section 49.060, Water Code. Sections 375.069 and 375.070, Local Government Code, do not apply to the board.

Sec. 3867.056. INITIAL DIRECTORS. (a) The initial board consists of:

2 (b) Of the initial directors, the terms of directors serving
3 in positions 1, 2, and 3 expire June 1, 2013, and the terms of
4 directors serving in positions 4 and 5 expire June 1, 2015.

5 (c) Section 3867.052 does not apply to the initial
6 directors.

7 (d) This section expires September 1, 2015.

8 [Sections 3867.057-3867.100 reserved for expansion]

9 SUBCHAPTER C. POWERS AND DUTIES

10 Sec. 3867.101. GENERAL POWERS AND DUTIES. The district has
11 the powers and duties necessary to accomplish the purposes for
12 which the district is created.

13 Sec. 3867.102. IMPROVEMENT PROJECTS AND SERVICES. The
14 district may provide, design, construct, acquire, improve,
15 relocate, operate, maintain, or finance an improvement project or
16 service using money available to the district, or contract with a
17 governmental or private entity to provide, design, construct,
18 acquire, improve, relocate, operate, maintain, or finance an
19 improvement project or service authorized under this chapter,
20 including a project or service described by Subchapter C-1, or
21 under Chapter 375, Local Government Code.

22 Sec. 3867.103. NONPROFIT CORPORATION. (a) The board by
23 resolution may authorize the creation of a nonprofit corporation to
24 assist and act for the district in implementing a project or
25 providing a service authorized by this chapter.

26 (b) The nonprofit corporation:

27 (1) has each power of and is considered to be a local

government corporation created under Subchapter D, Chapter 431, Transportation Code; and

(2) may implement any project and provide any service authorized by this chapter.

(c) The board shall appoint the board of directors of the nonprofit corporation. The board of directors of the nonprofit corporation shall serve in the same manner as the board of directors of a local government corporation created under Subchapter D, Chapter 431, Transportation Code, except that a board member is not required to reside in the district.

Sec. 3867.104. AGREEMENTS; GRANTS. (a) As provided by Chapter 375, Local Government Code, the district may make an agreement with or accept a gift, grant, or loan from any person.

(b) The implementation of a project is a governmental function or service for the purposes of Chapter 791, Government Code.

Sec. 3867.105. LAW ENFORCEMENT SERVICES. To protect the public interest, the district may contract with a qualified party, including the county or the city, to provide law enforcement services in the district for a fee.

Sec. 3867.106. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The district may join and pay dues to a charitable or nonprofit organization that performs a service or provides an activity consistent with the furtherance of a district purpose.

Sec. 3867.107. ECONOMIC DEVELOPMENT. (a) The district may engage in activities that accomplish the economic development purposes of the district.

1 (b) The district may establish and provide for the
2 administration of one or more programs to promote state or local
3 economic development and to stimulate business and commercial
4 activity in the district, including programs to:

5 (1) make loans and grants of public money; and

6 (2) provide district personnel and services.

7 (c) The district may create economic development programs
8 and exercise the economic development powers that:

9 (1) Chapter 380, Local Government Code, provides to a
10 municipality; and

11 (2) Subchapter A, Chapter 1509, Government Code,
12 provides to a municipality.

13 Sec. 3867.108. PARKING FACILITIES. (a) The district may
14 acquire, lease as lessor or lessee, construct, develop, own,
15 operate, and maintain parking facilities or a system of parking
16 facilities, including lots, garages, parking terminals, or other
17 structures or accommodations for parking motor vehicles off the
18 streets and related appurtenances.

19 (b) The district's parking facilities serve the public
20 purposes of the district and are owned, used, and held for a public
21 purpose even if leased or operated by a private entity for a term of
22 years.

23 (c) The district's parking facilities are parts of and
24 necessary components of a street and are considered to be a street
25 or road improvement.

26 (d) The development and operation of the district's parking
27 facilities may be considered an economic development program.

1 Sec. 3867.109. STRATEGIC PARTNERSHIP AGREEMENT. The
2 district may negotiate and enter into a written strategic
3 partnership agreement with a municipality under Section 43.0751,
4 Local Government Code.

5 Sec. 3867.110. ANNEXATION OR EXCLUSION OF LAND. (a) The
6 district may annex land as provided by Subchapter J, Chapter 49,
7 Water Code.

8 (b) The district may exclude land as provided by Subchapter
9 J, Chapter 49, Water Code. Section 375.044(b), Local Government
10 Code, does not apply to the district.

11 Sec. 3867.111. NO EMINENT DOMAIN POWER. The district may
12 not exercise the power of eminent domain.

13 [Sections 3867.112-3867.150 reserved for expansion]

14 SUBCHAPTER C-1. IMPROVEMENT PROJECTS

15 Sec. 3867.151. IMPROVEMENT PROJECTS. In addition to the
16 general authority provided by Section 3867.102, the district may
17 provide, or it may contract with a governmental or private entity to
18 provide, an improvement project described by this subchapter or
19 activities in support of or incidental to those projects.

20 Sec. 3867.152. WATER OR SEWER FACILITY. An improvement
21 project may include the planning, design, construction,
22 improvement, maintenance, and operation of a water or sewer
23 facility.

24 Sec. 3867.153. POTABLE WATER. An improvement project may
25 include a supply and distribution facility or system to provide
26 potable water to district residents and businesses.

27 Sec. 3867.154. NONPOTABLE WATER. An improvement project

1 may include a facility or system designed to enable approved use of
2 nonpotable water, including wastewater supply, collection,
3 treatment, transmission, and distribution to district residents
4 and businesses.

5 Sec. 3867.155. WASTEWATER. An improvement project may
6 include a facility or system to provide wastewater collection,
7 treatment, and disposal to serve district residents and businesses.

8 Sec. 3867.156. DRAINAGE. An improvement project may
9 include the planning, design, construction, improvement, and
10 maintenance of a drainage facility for the district.

11 Sec. 3867.157. STORM WATER. An improvement project may
12 include protection and improvement of the quality of storm water
13 that flows through the district and may include the planning,
14 design, construction, improvement, and maintenance of a storm water
15 detention improvement.

16 Sec. 3867.158. WETLANDS. An improvement project may
17 include the planning, design, construction, improvement,
18 maintenance, and operation of a facility for wetlands enhancement.

19 Sec. 3867.159. RECREATION. An improvement project may
20 include a recreational facility, including public boat ramps and
21 docks on the district's Colorado River frontage.

22 Sec. 3867.160. POWER GENERATION. An improvement project
23 may include the planning, design, construction, improvement,
24 maintenance, and operation of an alternative power generation
25 facility located in or outside of the district, including:

26 (1) a facility for solar, geothermal, or wind power;
27 and

1 (2) appurtenant transmission facilities.

2 Sec. 3867.161. ROADS. An improvement project may include a
3 paved road or street inside and outside the district, to the extent
4 authorized by Section 52, Article III, Texas Constitution.

5 Sec. 3867.162. PARKING OR HELIPORT. An improvement project
6 may include the planning, design, construction, improvement,
7 maintenance, and operation of an off-street parking facility or
8 heliport.

9 Sec. 3867.163. EDUCATION AND CULTURE. An improvement
10 project may include the planning and acquisition of:

11 (1) public art and sculpture and related exhibits and
12 facilities; or

13 (2) an educational facility and a cultural exhibit or
14 facility.

15 Sec. 3867.164. CONVENTION CENTER. An improvement project
16 may include the planning, design, construction, acquisition,
17 lease, rental, improvement, maintenance, installation, and
18 management of and provision of furnishings for a facility for:

19 (1) a conference, convention, or exhibition;

20 (2) a manufacturer, consumer, or trade show;

21 (3) a civic, community, or institutional event; or

22 (4) an exhibit, display, attraction, special event, or
23 seasonal or cultural celebration or holiday.

24 Sec. 3867.165. DEMOLITION. An improvement project may
25 include the removal, razing, demolition, or clearing of land or
26 improvements in connection with an improvement project, including
27 mass grading to reclaim a site from the site's present state.

1 Sec. 3867.166. MITIGATION OF ENVIRONMENTAL EFFECTS. An
2 improvement project may include the acquisition and improvement of
3 land or other property for the mitigation of the environmental
4 effects of an improvement project.

5 Sec. 3867.167. ACQUISITION OF PROPERTY. An improvement
6 project may include the acquisition of property or an interest in
7 property in connection with an improvement project.

8 Sec. 3867.168. SPECIAL OR SUPPLEMENTAL SERVICES. An
9 improvement project may include a special or supplemental service
10 for the improvement and promotion of the district or an area
11 adjacent to the district or for the protection of public health and
12 safety in or adjacent to the district, including:

13 (1) advertising;
14 (2) promotion;
15 (3) tourism;
16 (4) health and sanitation;
17 (5) public safety;
18 (6) security;
19 (7) fire protection or emergency medical services;
20 (8) business recruitment;
21 (9) development;
22 (10) the elimination of traffic congestion; and
23 (11) recreational, educational, or cultural
24 improvements, enhancements, and services.

25 Sec. 3867.169. MISCELLANEOUS DESIGN, CONSTRUCTION, AND
26 MAINTENANCE. An improvement project may include the planning,
27 design, construction, improvement, and maintenance of:

- 1 (1) landscaping;
- 2 (2) highway right-of-way or transit corridor
- 3 beautification and improvement;
- 4 (3) lighting, banners, and signs;
- 5 (4) a street or sidewalk;
- 6 (5) a hiking and cycling path or trail;
- 7 (6) a pedestrian walkway, skywalk, crosswalk, or
- 8 tunnel;
- 9 (7) a park, lake, garden, recreational facility,
- 10 sports facility, open space, scenic area, or related exhibit or
- 11 preserve;
- 12 (8) a fountain, plaza, or pedestrian mall; or
- 13 (9) a drainage or storm water detention improvement.

14 Sec. 3867.170. SIMILAR IMPROVEMENT PROJECTS. An

15 improvement project may include a public improvement, facility, or

16 service similar to a project described by this subchapter.

17 [Sections 3867.171-3867.200 reserved for expansion]

18 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS; ASSESSMENTS

19 Sec. 3867.201. TAX AND ASSESSMENT ABATEMENTS. The district

20 may designate reinvestment zones and may grant abatements of a tax

21 or assessment on property in the zones.

22 Sec. 3867.202. DISBURSEMENTS AND TRANSFERS OF MONEY. The

23 board by resolution shall establish the number of directors'

24 signatures and the procedure required for a disbursement or

25 transfer of district money.

26 Sec. 3867.203. MONEY USED FOR IMPROVEMENTS OR SERVICES.

27 The district may acquire, construct, finance, operate, maintain, or

1 provide any improvement or service authorized under this chapter or
2 Chapter 375, Local Government Code, using any money available to
3 the district.

4 Sec. 3867.204. PETITION REQUIRED FOR FINANCING SERVICES AND
5 IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a
6 service or improvement project with assessments under this chapter
7 unless a written petition requesting that service or improvement
8 has been filed with the board.

9 (b) A petition filed under Subsection (a) must be signed by:

10 (1) the owners of a majority of the assessed value of
11 real property in the district subject to assessment according to
12 the most recent certified tax appraisal roll for the county; or

13 (2) at least 25 persons who own real property in the
14 district subject to assessment, if more than 25 persons own real
15 property in the district subject to assessment as determined by the
16 most recent certified tax appraisal roll for the county.

17 Sec. 3867.205. METHOD OF NOTICE FOR HEARING. The district
18 may mail the notice required by Section 375.115(c), Local
19 Government Code, by certified or first class United States mail.
20 The board shall determine the method of notice.

21 Sec. 3867.206. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
22 The board by resolution may impose and collect an assessment for any
23 purpose authorized by this chapter in all or any part of the
24 district.

25 (b) An assessment, a reassessment, or an assessment
26 resulting from an addition to or correction of the assessment roll
27 by the district, penalties and interest on an assessment or

reassessment, an expense of collection, and reasonable attorney's fees incurred by the district are:

(1) a first and prior lien against the property assessed;

(2) superior to any other lien or claim other than a lien or claim for county, school district, or municipal ad valorem taxes; and

(3) the personal liability of and a charge against the owners of the property even if the owners are not named in the assessment proceedings.

(c) The lien is effective from the date of the board's resolution imposing the assessment until the date the assessment is paid. The board may enforce the lien in the same manner that the board may enforce an ad valorem tax lien against real property.

(d) The board may make a correction to or deletion from the assessment roll that does not increase the amount of assessment of any parcel of land without providing notice and holding a hearing in the manner required for additional assessments.

Sec. 3867.207. RESIDENTIAL PROPERTY NOT EXEMPT. Section 375.161, Local Government Code, does not apply to:

(1) a tax authorized or approved by district voters;
or

(2) a required payment for a service provided by the district, including water and sewer service.

Sec. 3867.208. COMPETITIVE BIDDING. Subchapter I, Chapter 49, Water Code, applies to the district. Sections 375.221 and 375.223, Local Government Code, do not apply to the district.

[Sections 3867.209-3867.250 reserved for expansion]

SUBCHAPTER E. TAXES AND BONDS

Sec. 3867.251. ELECTIONS REGARDING CERTAIN TAXES AND BONDS.

(a) The district may issue, without an election, bonds, notes, and other obligations secured by:

(1) revenue other than ad valorem taxes; or

(2) contract payments described by Section 3867.253.

(b) The district must hold an election in the manner provided by Subchapter L, Chapter 375, Local Government Code, to obtain voter approval before the district may impose an ad valorem tax or sales and use tax or issue bonds payable from ad valorem taxes.

(c) Section 375.243, Local Government Code, does not apply to the district.

(d) All or any part of any facilities or improvements that may be acquired by a district by the issuance of district bonds may be included in one single proposition to be voted on at the election or the bonds may be submitted in several propositions.

Sec. 3867.252. OPERATION AND MAINTENANCE TAX. (a) If authorized by a majority of the district voters voting at an election held under Section 3867.251, the district may impose an operation and maintenance tax on taxable property in the district in accordance with Section 49.107, Water Code, for any district purpose, including to:

(1) operate and maintain the district;

(2) construct or acquire improvements; or

(3) provide a service.

1 (b) The board shall determine the tax rate. The rate may not
2 exceed the rate approved at the election.

3 (c) The board may impose the tax authorized by this section
4 after full-purpose annexation by the city under Subchapter J. The
5 board may use the tax revenue to pay for maintaining parks, wet
6 ponds, and other open space amenities in the district. To the
7 extent of a conflict between this subsection and any other law, this
8 subsection controls.

9 Sec. 3867.253. CONTRACT TAXES. (a) In accordance with
10 Section 49.108, Water Code, the district may impose a tax other than
11 an operation and maintenance tax and use the revenue derived from
12 the tax to make payments under a contract after the provisions of
13 the contract have been approved by a majority of the district voters
14 voting at an election held for that purpose.

15 (b) A contract approved by the district voters may contain a
16 provision stating that the contract may be modified or amended by
17 the board without further voter approval.

18 Sec. 3867.254. AUTHORITY TO BORROW MONEY AND TO ISSUE BONDS
19 AND OTHER OBLIGATIONS. (a) The district may borrow money on terms
20 determined by the board. Section 375.205, Local Government Code,
21 does not apply to a loan, line of credit, or other borrowing from a
22 bank or financial institution secured by revenue other than ad
23 valorem taxes.

24 (b) The district may issue bonds, notes, or other
25 obligations payable wholly or partly from ad valorem taxes, sales
26 and use taxes, assessments, impact fees, revenue, contract
27 payments, grants, or other district money, or any combination of

1 those sources of money, to pay for any authorized district purpose.

2 (c) The limitation on the outstanding principal amount of
3 bonds, notes, and other obligations provided by Section 49.4645,
4 Water Code, does not apply to the district.

5 Sec. 3867.255. TAXES FOR BONDS. At the time the district
6 issues bonds payable wholly or partly from ad valorem taxes, the
7 board shall provide for the annual imposition of a continuing
8 direct ad valorem tax, without limit as to rate or amount, for each
9 year that all or part of the bonds are outstanding as required and
10 in the manner provided by Sections 54.601 and 54.602, Water Code.

11 [Sections 3867.256-3867.300 reserved for expansion]

12 SUBCHAPTER F. DEFINED AREAS

13 Sec. 3867.301. AUTHORITY TO ESTABLISH DEFINED AREAS OR
14 DESIGNATED PROPERTY. The district may define areas or designate
15 certain property of the district to pay for improvements,
16 facilities, or services that primarily benefit that area or
17 property and do not generally and directly benefit the district as a
18 whole.

19 Sec. 3867.302. PROCEDURE FOR ELECTION. (a) Before the
20 district may impose an ad valorem tax or issue bonds payable from ad
21 valorem taxes of the defined area or designated property, the board
22 shall hold an election in the defined area or in the designated
23 property only.

24 (b) The election shall be conducted as provided by Section
25 3867.251.

26 (c) The board may submit the issues to the voters on the same
27 ballot to be used in another election.

1 Sec. 3867.303. DECLARING RESULT AND ISSUING ORDER. (a) If
2 a majority of the voters voting at the election approve the
3 proposition or propositions, the board shall declare the results
4 and, by order, shall establish the defined area and describe it by
5 metes and bounds or designate the specific property.

6 (b) A court may not review the board's order except on the
7 ground of fraud, palpable error, or arbitrary and confiscatory
8 abuse of discretion.

9 Sec. 3867.304. TAXES FOR IMPROVEMENTS AND FACILITIES IN
10 DEFINED AREAS OR DESIGNATED PROPERTY. On voter approval and
11 adoption of the order described by Section 3867.303, the district
12 may apply separately, differently, equitably, and specifically its
13 taxing power and lien authority to the defined area or designated
14 property to provide money to construct, administer, maintain, and
15 operate services, improvements, and facilities that primarily
16 benefit the defined area or designated property.

17 Sec. 3867.305. ISSUANCE OF BONDS FOR DEFINED AREA OR
18 DESIGNATED PROPERTY. After the order under Section 3867.303 is
19 adopted, the district may issue bonds to provide for any land,
20 improvements, facilities, plants, equipment, and appliances for
21 the defined area or designated property.

23 SUBCHAPTER G. SALES AND USE TAX

24 Sec. 3867.351. APPLICABILITY OF CERTAIN TAX CODE
25 PROVISIONS. (a) Chapter 321, Tax Code, governs the imposition,
26 computation, administration, enforcement, and collection of the
27 sales and use tax authorized by this subchapter except to the extent

1 Chapter 321, Tax Code, is inconsistent with this chapter.

2 (b) A reference in Chapter 321, Tax Code, to a municipality
3 or the governing body of a municipality is a reference to the
4 district or the board, respectively.

5 Sec. 3867.352. ELECTION; ADOPTION OF TAX. (a) The district
6 may adopt a sales and use tax if authorized by a majority of the
7 voters of the district voting at an election held for that purpose.

8 (b) The board by order may call an election to authorize the
9 adoption of the sales and use tax. The election may be held on any
10 uniform election date and in conjunction with any other district
11 election.

12 (c) The district shall provide notice of the election and
13 shall hold the election in the manner prescribed by Section
14 3867.251.

15 (d) The ballot shall be printed to provide for voting for or
16 against the proposition: "Authorization of a sales and use tax in
17 the Rio de Vida Planning and Improvement District No. 1 at a rate
18 not to exceed ____ percent" (insert rate of one or more increments
19 of one-eighth of one percent).

20 Sec. 3867.353. SALES AND USE TAX RATE. (a) Not later than
21 the 10th day after the date the results are declared of an election
22 held under Section 3867.352, at which the voters approved
23 imposition of the tax authorized by this subchapter, the board
24 shall determine the initial rate of the tax, which must be in one or
25 more increments of one-eighth of one percent.

26 (b) After the election held under Section 3867.352, the
27 board may decrease the rate of the tax by one or more increments of

one-eighth of one percent. The board may not decrease the rate of the tax if the decrease would impair the repayment of any outstanding debt or obligation payable from the tax.

(c) The initial rate of the tax or any rate resulting from subsequent decreases may not exceed the lesser of:

(1) the maximum rate authorized by the district voters at the election held under Section 3867.352; or

(2) a rate that, when added to the rates of all sales and use taxes imposed by other political subdivisions with territory in the district, would result in the maximum combined rate prescribed by Section 321.101(f), Tax Code, at any location in the district.

(d) In determining whether the combined sales and use tax rate under Subsection (c)(2) would exceed the maximum combined rate prescribed by Section 321.101(f), Tax Code, at any location in the district, the board shall include:

(1) any sales and use tax imposed by a political subdivision whose territory overlaps all or part of the district;

(2) any sales and use tax to be imposed by a municipality or county as a result of an election held on the same date as the election held under Section 3867.352; and

(3) any increase to an existing sales and use tax imposed by a municipality or county as a result of an election held on the same date as the election held under Section 3867.352.

(e) This subsection applies only to a political subdivision that is not a municipality or county. If the voters of a political subdivision approve the adoption or increase of a sales and use tax

at an election held on the same date as an election under Section 3867.352, and after the board sets the district's initial tax rate under Subsection (a), the combined rate of all sales and use taxes imposed by the district and by other political subdivisions having territory in the district exceed the combined maximum rate prescribed by Section 321.101(f), Tax Code, the election held by the political subdivision on that date has no effect.

(f) The board shall notify the comptroller of any changes made to the tax rate in the same manner the municipal secretary provides notice to the comptroller under Section 321.405(b), Tax Code.

Sec. 3867.354. USE OF REVENUE. Revenue from the sales and use tax imposed under this subchapter is for the use and benefit of the district and may be used for any district purpose. The district may pledge all or part of the revenue to the payment of bonds, notes, or other obligations, and that pledge of revenue may be in combination with other revenue, including tax revenue, available to the district.

Sec. 3867.355. ABOLITION OF TAX. (a) Except as provided by Subsection (b), the board may abolish the tax imposed under this subchapter without an election.

(b) The board may not abolish the tax imposed under this subchapter if the district has outstanding debt secured by the tax and repayment of the debt would be impaired by the abolition of the tax.

(c) If the board abolishes the tax, the board shall notify the comptroller of that action in the same manner the municipal

secretary provides notice to the comptroller under Section 321.405(b), Tax Code.

(d) If the board abolishes the tax or decreases the tax rate to zero, a new election to authorize a sales and use tax must be held under Section 3867.352 before the district may subsequently impose the tax.

SUBCHAPTER H. HOTEL OCCUPANCY TAX

Sec. 3867.401. DEFINITION. In this subchapter, "hotel" has the meaning assigned by Section 156.001, Tax Code.

Sec. 3867.402. APPLICABILITY OF CERTAIN TAX CODE PROVISIONS. (a) In this subchapter:

(1) a reference in Subchapter A, Chapter 352, Tax Code, to a county is a reference to the district; and

(2) a reference in Subchapter A, Chapter 352, Tax Code, to the commissioners court is a reference to the board.

(b) Except as inconsistent with this subchapter, Subchapter A, Chapter 352, Tax Code, governs a hotel occupancy tax authorized by this subchapter, including the collection of the tax, subject to the limitations prescribed by Sections 352.002(b) and (c), Tax Code.

Sec. 3867.403. TAX AUTHORIZED; USE OF REVENUE. The district may impose a hotel occupancy tax for any district purpose, including to:

(1) operate and maintain the district;

(2) construct or acquire improvements; and

(3) provide a service.

1 Sec. 3867.404. TAX RATE. (a) The amount of the hotel
2 occupancy tax may not exceed seven percent of the price paid for a
3 room in a hotel.

4 Sec. 3867.405. INFORMATION. The district may examine and
5 receive information related to the imposition of hotel occupancy
6 taxes to the same extent as if the district were a county.

7 [Sections 3867.406-3867.450 reserved for expansion]

8 SUBCHAPTER I. DIVISION OF DISTRICT INTO MULTIPLE DISTRICTS

9 Sec. 3867.451. DIVISION OF DISTRICT; PREREQUISITES. (a)
10 The district may be divided into two or more new districts only if
11 the district:

12 (1) has no outstanding bonded debt;

13 (2) is not imposing ad valorem taxes; and

14 (3) complies with Subsection (b), if applicable.

15 (b) This subsection applies only to a district located

21 Sec. 3867.452. LAW APPLICABLE TO NEW DISTRICT. This

23 district, and a new district has all the powers and duties of the
24 district.

25 Sec. 3867.453. LIMITATION ON AREA OF NEW DISTRICT. A new
26 district created by the division of the district may not, at the
27 time the new district is created, contain any land outside the area

1 described by Section 2 of the Act enacting this chapter.

2 Sec. 3867.454. DIVISION PROCEDURES. (a) The board, on its
3 own motion or on receipt of a petition signed by the owner or owners
4 of a majority of the assessed value of the real property in the
5 district, may adopt an order dividing the district.

6 (b) The board may adopt an order dividing the district
7 before or after the date the board holds an election under Section
8 3867.251(b) to authorize the issuance of bonds payable from ad
9 valorem taxes.

10 (c) An order dividing the district must:

11 (1) name each new district;

12 (2) include the metes and bounds description of the
13 territory of each new district;

14 (3) appoint temporary directors for each new district;
15 and

16 (4) provide for the division of assets and liabilities
17 between the new districts.

18 (d) On or before the 30th day after the date of adoption of
19 an order dividing the district, the district shall file the order
20 with the Texas Commission on Environmental Quality and record the
21 order in the real property records of each county in which the
22 district is located.

23 Sec. 3867.455. TAX OR BOND ELECTION. Before a new district
24 created by the division of the district may impose a sales and use
25 tax or an operation and maintenance tax or issue bonds payable
26 wholly or partly from ad valorem taxes, the new district must hold
27 an election as required by this chapter to obtain voter approval.

SUBCHAPTER J. MUNICIPAL ANNEXATION AND DISSOLUTION

Sec. 3867.501. MUNICIPAL ANNEXATION. (a) The city may annex the district:

(1) according to the terms specified in a consent agreement entered into by the city and the district; and

(2) only after the district's development entity has been reimbursed to the extent allowed under:

(A) Chapters 49 and 54, Water Code; and

(B) the rules of the Texas Commission on Environmental Quality.

(b) Sections 43.0561 and 43.0562, Local Government Code, do not apply to the annexation of the district.

(c) A conveyance of real property in the district must be accompanied by a recorded notice to purchasers that describes the city's authority to annex the district when the conditions in Subsection (a) apply.

Sec. 3867.502. CONTINUATION OF DISTRICT AFTER ANNEXATION. The district is not required to be dissolved if the city annexes the district. The district and the city may enter into a development agreement that authorizes the district to continue all or a portion of the district's operations after the city annexes the district.

Sec. 3867.503. LIMITATION ON DISSOLUTION NOT APPLICABLE. Section 375.264, Local Government Code, does not apply to the dissolution of the district by a municipality.

15 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
16 Government Code.

17 (b) The governor, one of the required recipients, has
18 submitted the notice and Act to the Texas Commission on
19 Environmental Quality.

20 (c) The Texas Commission on Environmental Quality has filed
21 its recommendations relating to this Act with the governor,
22 lieutenant governor, and speaker of the house of representatives
23 within the required time.

24 (d) The general law relating to consent by political
25 subdivisions to the creation of districts with conservation,
26 reclamation, and road powers and the inclusion of land in those
27 districts has been complied with.

1 (e) All requirements of the constitution and laws of this
2 state and the rules and procedures of the legislature with respect
3 to the notice, introduction, and passage of this Act have been
4 fulfilled and accomplished.

5 SECTION 4. This Act takes effect immediately if it receives
6 a vote of two-thirds of all the members elected to each house, as
7 provided by Section 39, Article III, Texas Constitution. If this
8 Act does not receive the vote necessary for immediate effect, this
9 Act takes effect September 1, 2011.
