## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the expansion of faith- and community-based health and 3 human services initiatives. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 535.051, Government Code, is amended by amending Subsection (b) and adding Subsection (c) to read as 6 7 follows: (b) The chief administrative officer of each of the 8 9 following state agencies, in consultation with the governor, shall designate one employee from the agency to serve as a liaison for 10 11 faith- and community-based organizations: the <u>Texas Department</u> [Office] of Rural [Community] 12 (1)13 Affairs; 14 (2) the Texas Commission on Environmental Quality; the Texas Department of Criminal Justice; 15 (3) 16 (4) the Texas Department of Housing and Community Affairs; 17 18 (5) the Texas Education Agency; the Texas Juvenile Probation Commission; 19 (6) the Texas Veterans Commission; 20 (7)21 (8) the Texas Workforce Commission; 22 (9) the Texas Youth Commission; 23 (10) the office of the governor; 24 (11) the Department of Public Safety;

1	(12) the Texas Department of Insurance;
2	(13) the Public Utility Commission of Texas;

17	SECTION 2. Sections 535.053(a) and (b), Government Code,
18	are amended to read as follows:
19	(a) The interagency coordinating group for faith- and
20	community-based initiatives is composed of each faith- and
21	community-based liaison designated under Section 535.051 and a
22	liaison from the State Commission on National and Community
23	Service. The commission shall provide administrative support to

25	(b) The liaison from the State Commission on National and
26	Community Service [commission employee designated as a liaison
27	under Section 535.051] is the presiding officer of the interagency

coordinating group. If the State Commission on National and 1 Community Service is abolished, the liaison from the governor's 2 office is the presiding officer of the interagency coordinating 3 4 group. 5 SECTION 3. Section 535.054, Government Code, is amended to read as follows: 6 REPORT [REPORTS]. 7 Sec. 535.054. (a) Not later than 8 December 1 of each year, the interagency coordinating group shall submit a report to the legislature that describes in detail the 9 activities, goals, and progress of the interagency coordinating 10 group. [A liaison designated under Section 535.051 shall: 11 12 [(1) provide periodic reports to the executive commissioner or other chief executive officer who designated the 13 14 liaison, as applicable, on a schedule determined by the person who 15 designated the liaison; and 16 [(2) report annually to the governor's office of 17 faith- and community-based initiatives and as necessary to the State Commission on National and Community Service regarding the 18 liaison's efforts to comply with the duties imposed under Sections 19 535.052 and 535.053.] 20 21 <u>The</u> [Each] report made under Subsection (a) [(a)(2)](b) must be made available to the public through posting on the office 22 of the governor's Internet website[, and the reports may be 23 24 aggregated into a single report for that purpose]. SECTION 4. Subchapter B, Chapter 535, Government Code, is 25

26 amended by adding Section 535.055 to read as follows:

27 Sec. 535.055. TASK FORCE ON IMPROVING RELATIONS WITH

NONPROFITS. (a) The interagency coordinating group task force is 1 established to help direct the interagency coordinating group in 2 carrying out the group's duties under this section. The commission 3 shall provide administrative support to the task force. 4 (b) The executive commissioner, in consultation with the 5 presiding officer of the interagency coordinating group, shall 6 7 appoint as members of the task force one representative from each of the following groups and entities: 8 9 (1) a statewide nonprofit organization; 10 (2) local governments; (3) faith-based groups; 11 12 (4) community-based groups; (5) consultants to nonprofit corporations; 13 14 (6) experts in grant writing; and 15 (7) a statewide association of nonprofit 16 organizations. 17 (c) In addition to the interagency coordinating group's other duties, the interagency coordinating group, in coordination 18 19 with the task force, shall: 20 (1) develop and implement a plan for improving 21 contracting relationships between state agencies and faith- and 22 community-based organizations; (2) develop best practices for cooperating and 23 24 collaborating with faith- and community-based organizations; (3) identify and address duplication of services 25 26 provided by the state and faith- and community-based organizations; 27 and

1 (4) identify and address gaps in state services that 2 faith- and community-based organizations could fill. 3 (d) The task force shall prepare a report describing actions taken or not taken by the interagency coordinating group under this 4 5 section and include in the report any recommendations relating to legislation necessary to address an issue identified by the group 6 7 under this section. The task force shall present the report to the House Committee on Human Services or its successor, the House 8 Committee on Public Health or its successor, and the Senate Health 9 and Human Services Committee or its successor not later than 10 September 1, 2012. 11

(e) This section expires September 1, 2013.

13 SECTION 5. Not later than October 1, 2011, the executive 14 commissioner of the Health and Human Services Commission shall 15 appoint members to the interagency coordinating group task force in 16 accordance with Section 535.055, Government Code, as added by this 17 Act.

SECTION 6. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2011.
