Sections 535.053(a) and (b), Government Code, 17 SECTION 2. are amended to read as follows: 18 The interagency coordinating group for faith-19 community-based initiatives is composed of each faith-20 21 community-based liaison designated under Section 535.051 and a liaison from the State Commission on National and Community 22 The commission shall provide administrative support to 23 Service. 24 the interagency coordinating group. 25 The liaison from the State Commission on National and (b) 26 Community Service [commission employee designated as a liaison

- 5 SECTION 3. Section 535.054, Government Code, is amended to

- 8 December 1 of each year, the interagency coordinating group shall
- 9 submit a report to the legislature that describes in detail the
- 10 activities, goals, and progress of the interagency coordinating
- 11 group. [A liaison designated under Section 535.051 shall:
- 12 [(1) provide periodic reports to the executive
- 13 commissioner or other chief executive officer who designated the
- 14 liaison, as applicable, on a schedule determined by the person who
- 15 designated the liaison; and
- 16 [(2) report annually to the governor's office of

- 19 liaison's efforts to comply with the duties imposed under Sections

- (b) The [Each] report made under Subsection (a)  $\frac{(a)(2)}{(a)(2)}$
- 22 must be made available to the public through posting on the office
- 23 of the governor's Internet website  $[ \frac{1}{7} ]$  and the reports may be
- 24 aggregated into a single report for that purpose].
- SECTION 4. Subchapter B, Chapter 535, Government Code, is
- 26 amended by adding Section 535.055 to read as follows:
- 27 Sec. 535.055. TASK FORCE ON IMPROVING RELATIONS WITH

- 1 NONPROFITS. (a) The interagency coordinating group task force is
- 2 established to help direct the interagency coordinating group in
- 3 carrying out the group's duties under this section. The commission
- 4 shall provide administrative support to the task force.
- 5 (b) The executive commissioner, in consultation with the
- 6 presiding officer of the interagency coordinating group, shall
- 7 appoint as members of the task force one representative from each of
- 8 the following groups and entities:
- 9 (1) a statewide nonprofit organization;
- 10 (2) local governments;
- 11 (3) faith-based groups;
- 12 (4) community-based groups;
- 13 (5) consultants to nonprofit corporations;
- 14 (6) experts in grant writing; and
- 15 (7) a statewide association of nonprofit
- 16 organizations.
- 17 (c) In addition to the interagency coordinating group's
- 18 other duties, the interagency coordinating group, in coordination
- 19 with the task force, shall:
- 20 (1) develop and implement a plan for improving
- 21 contracting relationships between state agencies and faith- and
- 22 community-based organizations;
- 23 (2) develop best practices for cooperating and

- 1 (4) identify and address gaps in state services that
- 2 <u>faith- and community-based organizations could fill.</u>
- 3 (d) The task force shall prepare a report describing actions
- 4 taken or not taken by the interagency coordinating group under this
- 5 section and include in the report any recommendations relating to
- 6 legislation necessary to address an issue identified by the group
- 7 under this section. The task force shall present the report to the
- 8 House Committee on Human Services or its successor, the House
- 9 Committee on Public Health or its successor, and the Senate Health
- 10 and Human Services Committee or its successor not later than
- 11 September 1, 2012.
- 12 (e) This section expires September 1, 2013.
- SECTION 5. Not later than October 1, 2011, the executive
- 14 commissioner of the Health and Human Services Commission shall
- 15 appoint members to the interagency coordinating group task force in
- 16 accordance with Section 535.055, Government Code, as added by this
- 17 Act.
- SECTION 6. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2011.
