SECTION 2. Section 85.066, Health and Safety Code, is repealed.

SECTION 3. (a) The executive commissioner of the Health and Human Services Commission shall appoint the initial members of the Texas HIV Medication Advisory Committee as provided by Section 85.272, Health and Safety Code, as added by this Act, as promptly as possible after the effective date of this Act. The executive commissioner may appoint, but is not required to appoint, initial members to the committee who served on the advisory committee previously established under Section 85.066, Health and Safety Code, as repealed by this Act.

(b) The members of the Texas HIV Medication Advisory Committee shall, at the first meeting of the committee, select a presiding officer and an assistant presiding officer, and notwithstanding Section 85.275(b), Health and Safety Code, as added by this Act, the initial terms of those officers begin on the date of selection.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2011.
