- 12 SECTION 1.02. INTERAGENCY TASK FORCE FOR CHILDREN WITH
- 13 SPECIAL NEEDS. Section 115.012, Health and Safety Code, as added by

- 5 ARTICLE 3. ENTITIES REMOVED FROM SPECIFIC SUNSET REVIEW
- 6 SECTION 3.01. BOARD OF DIRECTORS OF THE OFFICIAL CITRUS
- 7 PRODUCERS' PEST AND DISEASE MANAGEMENT CORPORATION. Section
- 8 80.028, Agriculture Code, is amended to read as follows:
- 9 Sec. 80.028. DISSOLUTION [SUNSET] PROVISION. (a) [The
- 10 board of directors of the official citrus producers' pest and
- 11 disease management corporation is subject to Chapter 325,
- 12 Government Code (Texas Sunset Act). Unless continued in existence
- 13 as provided by that chapter, the board is abolished and this chapter
- 14 expires September 1, 2021.
- 15 $\left[\frac{b}{b}\right]$ The commissioner may order the dissolution of the
