A BILL TO BE ENTITLED

1 AN ACT

2 relating to the abolition of the Coastal Coordination Council and

3 the transfer of its functions to the General Land Office.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 201.026(g), Agriculture Code, is amended

6 to read as follows:

7 (g) In an area that the state board identifies as having or

8 having the potential to develop agricultural or silvicultural

9 nonpoint source water quality problems or an area within the

10 "coastal zone" designated by the commissioner of the General Land

11 Office [Coastal Coordination Council], the state board shall

12 establish a water quality management plan certification program

13 that provides, through local soil and water conservation districts,

14 for the development, supervision, and monitoring of individual

15 water quality management plans for agricultural and silvicultural

16 lands. Each plan must be developed, maintained, and implemented

17 under rules and criteria adopted by the state board and comply with

18 state water quality standards established by the Texas Commission

19 on Environmental Quality. The state board shall certify a plan

20 that satisfies the state board's rules and criteria and complies

21 with state water quality standards established by the Texas

22 Commission on Environmental Quality under the commission's

23 exclusive authority to set water quality standards for all water in

24 the state.

- 21 (b) In developing the program, the land office shall act as
- 22 the lead agency to coordinate and develop a long-term plan for the
- 23 management of uses affecting coastal natural resource areas, in
- 24 cooperation with other state agencies that have duties relating to
- 25 coastal matters[, including those agencies represented on the
- 26 council]. The program shall implement the policies stated in
- 27 Section 33.202 [of this code] and shall include the elements listed

- 1 in Section 33.053 [of this code].
- 2 SECTION 6. Section 33.052(e), Natural Resources Code, is
- 3 amended to read as follows:
- 4 (e) This section does not add to or subtract from the duties

- 9 Sec. 33.055. PUBLIC HEARINGS TO CONSIDER COASTAL MANAGEMENT
- 10 PROGRAM. In developing, reviewing, or amending the coastal
- 11 management program, after due notice to affected persons and the
- 12 public generally, the commissioner [and the council] shall hold or
- 13 have held public hearings as the commissioner determines [and the
- 14 council determine] to be appropriate.
- 15 SECTION 8. Sections 33.204(a), (e), (f), and (g), Natural
- 16 Resources Code, are amended to read as follows:
- 17 (a) The commissioner [council] by rule shall adopt goals and
- 18 policies of the coastal management program. A goal or policy may
- 19 not require an agency or subdivision to perform an action that would
- 20 exceed the constitutional or statutory authority of the agency or
- 21 subdivision to which the goal or policy applies.
- 22 (e) In conducting reviews under Section 33.205 [of this
- 23 code], the commissioner [council] shall receive and consider the
- 24 oral or written testimony of any person regarding the coastal
- 25 management program as the testimony relates to the agency or
- 26 subdivision action or federal agency action or activity or outer
- 27 continental shelf plan under review. The commissioner [council]

- 1 may reasonably limit the length and format of the testimony and the time at which it will be received. Notice of the period during 2 3 which the testimony will be received shall be published in the Texas Register and in a newspaper of general circulation in each county 4 5 directly affected by the matter under review before commencement of that period. The commissioner [council] shall 6 consider only the record before the agency or subdivision involved 7 8 in the matter under review, the agency's or subdivision's findings, applicable laws and rules, any additional information provided by 9 that agency or subdivision, and public testimony under this 10 subsection, provided that if the agency or subdivision did not hold 11 12 a hearing, make a record, or make findings, the commissioner [council] may hold a hearing and make findings necessary to a 13 14 complete and thorough review.
- 15 (f) [The land office shall assist the council in carrying out its duties. The council members may not receive compensation 16 17 for services but may receive reimbursement for actual and necessary expenses.] The land office, in coordination with other agencies 18 19 subdivisions, shall prepare an annual report 20 effectiveness of the coastal management program. [The land office shall submit the report to the council for approval. On or before 21 January 15 of each odd-numbered year, the land office shall send to 22 23 the legislature each of the previous two annual reports.
- (g) The <u>commissioner</u> [council] may award grants to projects
 that further the goals and policies of the <u>commissioner with regard</u>
 to the coastal management program [council]. The <u>commissioner</u>
 [council] shall establish the procedures for making any

- 2 SECTION 9. Section 33.2041, Natural Resources Code, is
- 3 amended to read as follows:
- 4 Sec. 33.2041. COASTAL COORDINATION ADVISORY COMMITTEE
- 5 [COMPOSITION OF COUNCIL; TERMS]. (a) The commissioner by rule
- 6 shall establish the Coastal Coordination Advisory Committee to
- 7 advise the commissioner on matters related to the coastal
- 8 management program. The committee [council] shall consist of:
- 9 (1) a representative of each of the following entities
- 10 <u>designated</u> by the presiding officer of that entity [ex officio
- 11 members]:
- 12 (A) the land office [commissioner];
- 13 (B) the [presiding officer of the] Parks and
- 14 Wildlife Department [Commission or a member of the commission
- 15 designated by the presiding officer];
- 16 (C) the [presiding officer of the] Texas
- 17 Commission on Environmental Quality [Natural Resource Conservation
- 18 Commission or a member of the commission designated by the

- 5 amended by amending Subsections (c), (d), (e), (f), (g), and (h) and
- 6 adding Subsections (f-1) and (f-2) to read as follows:
- 7 (c) The <u>commissioner</u> [council] may not review a proposed
- 8 action subject to the requirements of Subsections (a) and (b) [of
- 9 this section] for consistency with the goals and policies of the
- 10 coastal management program unless:
- 11 (1) the consistency determination for the proposed
- 12 action was contested by:
- 13 (A) a member of the committee [a council member]
- 14 or an agency that was a party in a formal hearing under Chapter
- 15 2001, Government Code, or in an alternative dispute resolution
- 16 process; or
- 17 (B) another [a council member or other] person by
- 18 the filing of written comments with the agency before the action was

- 9 satisfied and:
- 10 (1) if the proposed action is one for which a formal
- 11 hearing under Chapter 2001, Government Code, is available:

- 13 and the agency's consistency determination was contested in a
- 14 formal hearing or in an alternative dispute resolution process; or
- 15 (B) the action does not exceed the applicable

- (e) The commissioner [council] must consider and act on a
- 25 matter referred under Subsection (c) or (d) before the 26th day
- 26 after the date the agency or subdivision proposed the action. For
- 27 purposes of this section, an action subject to the contested case

- 1 provisions of Chapter 2001, Government Code, is proposed when
- 2 notice of a decision or order is issued under Section 2001.142,
- 3 Government Code.
- 4 (f) The commissioner [council] by rule shall establish a
- 5 process by which an applicant for a permit or other proposed action
- 6 described in Section 33.2053, or an agency or subdivision proposing
- 7 an action, may request and receive a preliminary consistency
- 8 review. The rules shall:
- 9 (1) create a permitting assistance group composed of
- 10 representatives of committee [council] member agencies and other
- 11 interested committee [council] members to coordinate the
- 12 preliminary reviews; and
- 13 (2) require that the following written information be
- 14 produced not later than the 45th day after the date of the request
- 15 for preliminary review:
- 16 (A) a statement from each agency or subdivision
- 17 required to permit or approve the project as to whether the agency
- 18 or subdivision anticipates approving or denying the application;
- 19 (B) if an agency or subdivision intends to deny
- 20 an application, the agency's or subdivision's explanation of the

- 5 (f-1) Not later than January 1, 2012, the commissioner shall
- 6 evaluate the functions, including any pending initiatives,
- 7 membership, and usefulness of the permitting assistance group
- 8 established under Subsection (f). The evaluation must include
- 9 input from all members of the permitting assistance group. This
- 10 subsection expires April 1, 2012.
- 11 (f-2) The commissioner may adopt rules as necessary to:
- 12 <u>(1) restructure or abolish the permitting assistance</u>

- 7 other approvals administratively complete;
- 8 (E) assistance in completing the applications as
- 9 needed; and
- 10 (F) if enough information is already available, a
- 11 preliminary finding as to whether the project is likely to be found
- 12 consistent with the goals and policies of the coastal management
- 13 program.
- 14 (h) If an agency, subdivision, or applicant has received a
- 15 preliminary finding of consistency under Subsection (f)(2)(C) or
- 16 (g)(2)(F) and a request for referral was filed on that action under
- 17 Subsection (c)(2), the commissioner [council] may accept the
- 18 request for referral only if the agency or subdivision has
- 19 substantially changed the permit or proposed action since the
- 20 preliminary finding was issued.
- 21 SECTION 12. Section 33.2051(e), Natural Resources Code, is
- 22 amended to read as follows:
- (e) The <u>commissioner</u> [council] may not review a proposed
- 24 rule of the [Texas] Department of Agriculture.
- 25 SECTION 13. Section 33.2052, Natural Resources Code, is
- 26 amended to read as follows:
- Sec. 33.2052. CERTIFICATION OF AGENCY RULES; AGENCY ACTIONS

- 1 CONSIDERED CONSISTENT. (a) The <u>commissioner</u> [council] by rule
- 2 shall establish a process by which an agency may submit rules and
- 3 rule amendments described by Section 33.2051 to the commissioner
- 4 [council] for review and certification for consistency with the
- 5 goals and policies of the coastal management program.
- 6 (b) The process must provide that an agency may submit to
- 7 the commissioner [council] consistency review thresholds for the
- 8 agency's actions described in Section 33.2053. After the
- 9 commissioner [council] certifies that an agency's rules are
- 10 consistent and approves the agency's thresholds, the agency's
- 11 consistency determination under Section 33.205(b) for an action is
- 12 final and is not subject to referral and review, except as provided
- 13 by Section 33.205(d).
- (c) The commissioner [council] by rule shall provide that
- 15 the <u>commissioner</u> [<u>council</u>] may revoke <u>the commissioner's</u> [<u>its</u>]
- 16 certification under Subsection (b) if the commissioner [council]
- 17 finds that an agency has:
- 18 (1) implemented certified rules in a manner that
- 19 conflicts with the goals and policies of the coastal management

- 6 (B) result in relocation of an outfall to a
- 7 critical area;
- 8 (2) for solid, hazardous, or nonhazardous waste
- 9 permits, if the action is not a Class III modification under rules
- 10 of the Texas [Natural Resource Conservation] Commission on
- 11 Environmental Quality; or
- 12 (3) for any other action, if the action:
- 13 (A) only extends the period of the existing
- 14 authorization and does not authorize new or additional work or
- 15 activity; or
- 16 (B) is not directly relevant to Sections
- 17 33.205(a) and (b).
- 18 (k) The commissioner [council] shall establish a program
- 19 boundary to limit the geographic area in which the requirements of
- 20 Sections 33.205(a) and (b) apply. The boundary is the coastal
- 21 facility designation line as defined by Appendix 1 to 31 TAC Section
- 22 19.2 as that appendix existed on the effective date of this section,
- 23 as modified by Section 33.203(7). Except as provided by
- 24 Subsections (f)(8)-(10), this subchapter does not apply to an
- 25 agency action authorizing an activity outside the program boundary.
- 26 SECTION 15. Section 33.206, Natural Resources Code, is
- 27 amended to read as follows:

- Sec. 33.206. [COUNCIL] ACTION BY COMMISSIONER. (a) A proposed action is consistent with the goals and policies of the coastal management program and approved by the commissioner [council] unless[, on the affirmative vote of at least two-thirds of the members of the council,] the commissioner [council] determines the action to be inconsistent with the coastal management program and protests the action.
- 8 If the commissioner [council] protests the proposed action, the commissioner [council] shall report the commissioner's 9 [its] findings on the matter to the agency or subdivision. 10 The report shall specify how the proposed action is inconsistent with 11 the goals and policies of the coastal management program and 12 include specific recommendations of the commissioner [council] 13 14 regarding how the proposed action may be modified or amended to make 15 it consistent with the program. Before the 21st day after the date the agency or subdivision receives the report, the agency or 16 17 subdivision shall review the findings and recommendations and determine whether to modify or amend the proposed action to make it 18 consistent with the goals and policies of the coastal management 19 program and shall notify the commissioner [council] of 20 its 21 decision.
- (c) If an agency or subdivision does not modify or amend a proposed action to be consistent with the goals and policies of the coastal management program, the <u>commissioner</u> [council] shall request the attorney general to issue an opinion on the consistency of the proposed action with the coastal management program. The agency or subdivision is stayed from taking the proposed action

- 1 until the attorney general issues the opinion. The attorney
- 2 general shall issue an opinion before the 26th day after the date
- 3 the commissioner [council] requests the opinion.
- 4 (d) The commissioner [council] shall adopt procedural rules
- 5 for the review of federal actions, activities, and outer
- 6 continental shelf plans that incorporate the provisions of federal
- 7 regulations governing those reviews. The rules shall provide that
- 8 the commissioner [chair or any three members] may request
- 9 additional information from a federal agency or additional time for
- 10 review as provided by the federal regulations.
- 11 (e) The <u>commissioner</u> [council] shall review any federal
- 12 action, activity, or outer continental shelf plan that the
- 13 commissioner determines presents [any three members of the council
- 14 agree presents] a significant unresolved issue regarding
- 15 consistency with the goals and policies of the coastal management
- 16 program [and place the matter on the agenda of a meeting of the
- 17 council for review].
- 18 (f) If an activity requiring an agency or subdivision action
- 19 described by Section 33.2053 that falls below thresholds in effect
- 20 under Section 33.2052 also requires an equivalent federal permit or
- 21 license, the commissioner [council] may only determine the agency
- 22 or subdivision action's consistency. If an activity requiring an
- 23 agency or subdivision action above thresholds requires an
- 24 equivalent federal permit or license, the commissioner [council]
- 25 may determine the consistency of the agency or subdivision action
- 26 or the federal license or permit, but not both. The determination
- 27 regarding the consistency of an action made by the commissioner

- 1 [council] under this subsection constitutes the state's
- 2 determination regarding consistency of the equivalent agency or
- 3 subdivision action or federal action.
- 4 (g) If, after review, the commissioner [council] finds a
- 5 proposed federal agency action or activity or outer continental
- 6 shelf plan is inconsistent with the coastal management program, and
- 7 the federal agency does not modify the action, activity, or outer
- 8 continental shelf plan to achieve consistency with the program, the
- 9 governor, with the assistance of the commissioner [chair of the
- 10 council], may seek mediation of the matter in accordance with
- 11 federal law.
- (h) The commissioner [council] may not protest a proposed
- 13 action by an agency or subdivision pertaining to an application
- 14 filed with that agency or subdivision before the date the coastal
- 15 management program is adopted.
- 16 SECTION 16. Section 33.207, Natural Resources Code, is
- 17 amended to read as follows:
- 18 Sec. 33.207. COMMISSIONER [COUNCIL] RECOMMENDATIONS. In
- 19 addition to the report required by Section 33.206, the commissioner
- 20 [council]:
- 21 (1) may periodically submit recommendations to an
- 22 agency or subdivision designed to encourage the agency or
- 23 subdivision to carry out its functions in a manner consistent with
- 24 the coastal management program, including recommendations for
- 25 methods to simplify governmental procedures and changes in
- 26 applicable rules or statutes; and
- 27 (2) shall report to the legislature on:

- 1 (A) recommended statutory changes needed to make
- 2 more effective and efficient use of public funds and provide for
- 3 more effective and efficient management of coastal natural resource
- 4 areas, including recommendations on methods to simplify
- 5 governmental procedures;
- 6 (B) agency or subdivision actions that are not
- 7 consistent with the coastal management program; and
- 8 (C) population growth of, infrastructure needs
- 9 of, and use of resources on the coast.
- SECTION 17. Sections 33.208(b) and (c), Natural Resources
- 11 Code, are amended to read as follows:
- 12 (b) If the attorney general issues an opinion under Section
- 13 33.206(c) that a proposed agency or subdivision action is
- 14 inconsistent with the coastal management program and the agency or
- 15 subdivision fails to implement the commissioner's [council's]
- 16 recommendation regarding the action, the attorney general shall
- 17 file suit in a district court of Travis County to enforce this
- 18 subchapter. The court shall consider the attorney general's
- 19 opinion in determining whether the proposed action is consistent
- 20 with the coastal management program.
- 21 (c) Notwithstanding the request of an opinion from, or the
- 22 filing of suit by, the attorney general, the commissioner [council]
- 23 and the agency or subdivision may enter into a settlement agreement
- 24 with regard to the proposed action. If the commissioner [council]
- 25 and the agency or subdivision enter into a settlement agreement,
- 26 the commissioner [council] may rescind the commissioner's [its]
- 27 request for an opinion from the attorney general.

- 1 SECTION 18. Section 33.209, Natural Resources Code, is
- 2 amended to read as follows:
- 3 Sec. 33.209. PROHIBITION ON SPECIAL AREA MANAGEMENT PLANS.
- 4 The land office [council] may not develop or approve a special area
- 5 management plan, including a plan for an area designated under the
- 6 national estuary program.
- 7 SECTION 19. Sections 33.004(13), 33.052(c), 33.203(20),
- 8 33.204(b), (c), and (d), 33.2042, 33.2043, 33.2044, 33.2045,
- 9 33.2053(g), 33.211, and 33.212, Natural Resources Code, are
- 10 repealed.
- 11 SECTION 20. (a) Effective September 1, 2011, the Coastal
- 12 Coordination Council is abolished and the powers and duties of the
- 13 council are transferred to the General Land Office in accordance
- 14 with Chapter 33, Natural Resources Code, as amended by this Act.

- 16 Act, the presiding officers of the appropriate entities shall

- 23 the council is continued in effect as provided by the law in effect
- 24 immediately before the effective date of this Act. A complaint,
- 25 investigation, contested case, or other proceeding pending on the
- 26 effective date of this Act is continued without change in status
- 27 after the effective date of this Act. An activity conducted by the

- 1 council is considered to be an activity conducted by the land 2 office.
- 3 (d) A reference in another law or an administrative rule to 4 the Coastal Coordination Council means the General Land Office.
- (e) On September 1, 2011, or as soon as is possible after that date, the commissioner of the General Land Office shall adopt a comprehensive plan to ensure the smooth transition of all programs
- 8 operated by the Coastal Coordination Council before September 1,
- 9 2011, from the council to the land office. During the transition,
- 10 the General Land Office shall consult with the National Oceanic and
- 11 Atmospheric Administration as necessary to ensure continued
- 12 compliance with federal requirements and to maintain federal
- 13 approval of the Texas Coastal Management Program.
- 14 (f) All money, records, property, and equipment in the
- 15 possession of the Coastal Coordination Council on September 1,
- 16 2012, shall be transferred to the possession of the General Land
- 17 Office on September 1, 2012, or as soon as possible after that date.
- 18 SECTION 21. This Act takes effect September 1, 2011.
