## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the authority of the commissioners court of a county to create a law enforcement technology fund and to require certain 3 defendants to pay court costs for deposit in the fund. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Subchapter A, Chapter 102, Code of Criminal 6 7 Procedure, is amended by adding Article 102.0175 to read as 8 follows: Art. 102.0175. COURT COSTS; LAW ENFORCEMENT TECHNOLOGY 9 FUND. (a) The commissioners court of a county by order may create a 10 law enforcement technology fund. 11 12 (b) If a fund is created as described by Subsection (a), a defendant convicted of a misdemeanor offense in a justice court or 13 14 county court at law shall pay a \$2 law enforcement technology fee as a cost of court. 15 16 (c) In this article, a person is considered convicted if: (1) a sentence is imposed on the person; 17 18 (2) the person is placed on community supervision, including deferred adjudication community supervision; or 19 (3) the court defers final disposition of the person's 20 21 case. (d) The clerks of the courts described by Subsection (b) 22 23 shall collect the fee and pay the fee to the county treasurer, or to any other official who discharges the duties commonly delegated to 24

2 <u>fund.</u>

3 (e) A fund created under this article may be used only to 4 finance the purchase and maintenance of technological enhancements 5 for a county law enforcement agency and shall be administered by or 6 under the direction of the commissioners court of the county.

7 SECTION 2. Section 102.061, Government Code, as amended by 8 Chapters 87 (S.B. 1969), 1172 (H.B. 3389), and 1183 (H.B. 3637), 9 Acts of the 81st Legislature, Regular Session, 2009, is reenacted 10 and amended to read as follows:

9 (10) a law enforcement technology fee, if authorized
10 by the county commissioners court (Art. 102.0175, Code of Criminal
11 Procedure) . . . \$2.

12 SECTION 4. To the extent of any conflict, this Act prevails 13 over another Act of the 82nd Legislature, Regular Session, 2011, 14 relating to nonsubstantive additions to and corrections in enacted 15 codes.

16 SECTION 5. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2011.
