H.B. No. 2363

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Bearpen Creek Municipal Utility District of Hunt County; providing authority to impose a tax and issue bonds; granting a limited power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8363 to read as follows:

CHAPTER 8363. BEARPEN CREEK MUNICIPAL UTILITY DISTRICT

OF HUNT COUNTY

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8363.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "City" means a municipality in whose corporate limits or extraterritorial jurisdiction the district is located.

(3) "Commission" means the Texas Commission on Environmental Quality.

(4) "Director" means a board member.

(5) "District" means the Bearpen Creek Municipal Utility District of Hunt County.

Sec. 8363.002. NATURE OF DISTRICT. The district is a municipal utility district created under Section 59, Article XVI, Texas Constitution.

Sec. 8363.003. CONFIRMATION AND DIRECTORS' ELECTION REQUIRED. The temporary directors shall hold an election to

1 confirm the creation of the district and to elect five permanent  
2 directors as provided by Section 49.102, Water Code.

3 Sec. 8363.004. CONSENT OF MUNICIPALITY REQUIRED. The  
4 temporary directors may not hold an election under Section 8363.003  
5 until each municipality in whose corporate limits or  
6 extraterritorial jurisdiction the district is located has  
7 consented by ordinance or resolution to the creation of the  
8 district and to the inclusion of land in the district.

9 Sec. 8363.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)  
10 The district is created to serve a public purpose and benefit.

11 (b) The district is created to accomplish the purposes of:  
12 (1) a municipal utility district as provided by  
13 general law and Section 59, Article XVI, Texas Constitution; and  
14 (2) Section 52, Article III, Texas Constitution, that  
15 relate to the construction, acquisition, improvement, operation,  
16 or maintenance of macadamized, graveled, or paved roads, or  
17 improvements, including storm drainage, in aid of those roads.

18 Sec. 8363.006. INITIAL DISTRICT TERRITORY. (a) The  
19 district is initially composed of the territory described by  
20 Section 2 of the Act enacting this chapter.

21 (b) The boundaries and field notes contained in Section 2 of  
22 the Act enacting this chapter form a closure. A mistake made in the  
23 field notes or in copying the field notes in the legislative process  
24 does not affect the district's:

25 (1) organization, existence, or validity;  
26 (2) right to issue any type of bond for the purposes  
27 for which the district is created or to pay the principal of and

1 interest on a bond;

2 (3) right to impose a tax; or

3 (4) legality or operation.

5 SUBCHAPTER B. BOARD OF DIRECTORS

6 Sec. 8363.051. GOVERNING BODY; TERMS. (a) The district is  
7 governed by a board of five elected directors.

8 (b) Except as provided by Section 8363.052, directors serve  
9 staggered four-year terms.

10 Sec. 8363.052. TEMPORARY DIRECTORS. (a) The temporary  
11 board consists of:

12 (1) Jessica Shae Ewy;

13 (2) Jason Michael Farmer;

14 (3) Charles Richard Johns;

15 (4) Warren Jacob Loftis; and

16 (5) Martin Jacob Newman.

17 (b) Temporary directors serve until the earlier of:

18 (1) the date permanent directors are elected under  
19 Section 8363.003; or

20 (2) the fourth anniversary of the effective date of  
21 the Act enacting this chapter.

22 (c) If permanent directors have not been elected under  
23 Section 8363.003 and the terms of the temporary directors have  
24 expired, successor temporary directors shall be appointed or  
25 reappointed as provided by Subsection (d) to serve terms that  
26 expire on the earlier of:

27 (1) the date permanent directors are elected under

1 Section 8363.003; or

2 (2) the fourth anniversary of the date of the  
3 appointment or reappointment.

4 (d) If Subsection (c) applies, the owner or owners of a  
5 majority of the assessed value of the real property in the district  
6 may submit a petition to the commission requesting that the  
7 commission appoint as successor temporary directors the five  
8 persons named in the petition. The commission shall appoint as  
9 successor temporary directors the five persons named in the  
10 petition.

12 SUBCHAPTER C. POWERS AND DUTIES

13 Sec. 8363.101. GENERAL POWERS AND DUTIES. The district has  
14 the powers and duties necessary to accomplish the purposes for  
15 which the district is created.

16 Sec. 8363.102. MUNICIPAL UTILITY DISTRICT POWERS AND  
17 DUTIES. The district has the powers and duties provided by the  
18 general law of this state, including Chapters 49 and 54, Water Code,  
19 applicable to municipal utility districts created under Section 59,  
20 Article XVI, Texas Constitution.

21 Sec. 8363.103. AUTHORITY FOR ROAD PROJECTS. Under Section  
22 52, Article III, Texas Constitution, the district may design,  
23 acquire, construct, finance, issue bonds for, improve, operate,  
24 maintain, and convey to this state, a county, or a municipality for  
25 operation and maintenance macadamized, graveled, or paved roads, or  
26 improvements, including storm drainage, in aid of those roads.

27 Sec. 8363.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road

1 project must meet all applicable construction standards, zoning and  
2 subdivision requirements, and regulations of each municipality in  
3 whose corporate limits or extraterritorial jurisdiction the road  
4 project is located.

5 (b) If a road project is not located in the corporate limits  
6 or extraterritorial jurisdiction of a municipality, the road  
7 project must meet all applicable construction standards,  
8 subdivision requirements, and regulations of each county in which  
9 the road project is located.

10 (c) If the state will maintain and operate the road, the  
11 Texas Transportation Commission must approve the plans and  
12 specifications of the road project.

13 Sec. 8363.105. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE  
14 OR RESOLUTION. The district shall comply with all applicable  
15 requirements of any ordinance or resolution that is adopted under  
16 Section 54.016 or 54.0165, Water Code, and that consents to the  
17 creation of the district or to the inclusion of land in the  
18 district.

19 Sec. 8363.106. LIMITATION ON USE OF EMINENT DOMAIN. The  
20 district may not exercise the power of eminent domain outside the  
21 district to acquire a site or easement for:

- 22 (1) a road project authorized by Section 8363.103; or  
23 (2) a recreational facility as defined by Section  
24 49.462, Water Code.

26 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

27 Sec. 8363.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The

1 district may issue, without an election, bonds and other  
2 obligations secured by:

3 (1) revenue other than ad valorem taxes; or

4 (2) contract payments described by Section 8363.153.

5 (b) The district must hold an election in the manner  
6 provided by Chapters 49 and 54, Water Code, to obtain voter approval  
7 before the district may impose an ad valorem tax or issue bonds  
8 payable from ad valorem taxes.

9 (c) The district may not issue bonds payable from ad valorem  
10 taxes to finance a road project unless the issuance is approved by a  
11 vote of a two-thirds majority of the district voters voting at an  
12 election held for that purpose.

13 Sec. 8363.152. OPERATION AND MAINTENANCE TAX. (a) If  
14 authorized at an election held under Section 8363.151, the district  
15 may impose an operation and maintenance tax on taxable property in  
16 the district in accordance with Section 49.107, Water Code.

17 (b) The board shall determine the tax rate. The rate may not  
18 exceed the rate approved at the election.

19 Sec. 8363.153. CONTRACT TAXES. (a) In accordance with  
20 Section 49.108, Water Code, the district may impose a tax other than  
21 an operation and maintenance tax and use the revenue derived from  
22 the tax to make payments under a contract after the provisions of  
23 the contract have been approved by a majority of the district voters  
24 voting at an election held for that purpose.

25 (b) A contract approved by the district voters may contain a  
26 provision stating that the contract may be modified or amended by  
27 the board without further voter approval.

2 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

3 Sec. 8363.201. AUTHORITY TO ISSUE BONDS AND OTHER  
4 OBLIGATIONS. (a) Except as provided by Subsection (b), the  
5 district may issue bonds or other obligations payable wholly or  
6 partly from ad valorem taxes, impact fees, revenue, contract  
7 payments, grants, or other district money, or any combination of  
8 those sources, to pay for any authorized district purpose.

9 (b) The district may not issue bonds until the governing  
10 body of the city approves a bond issuance plan authorizing and  
11 setting forth the limitations on the issuance of the bonds.

12 Sec. 8363.202. TAXES FOR BONDS. At the time the district  
13 issues bonds payable wholly or partly from ad valorem taxes, the  
14 board shall provide for the annual imposition of a continuing  
15 direct ad valorem tax, without limit as to rate or amount, while all  
16 or part of the bonds are outstanding as required and in the manner  
17 provided by Sections 54.601 and 54.602, Water Code.

18 Sec. 8363.203. BONDS FOR ROAD PROJECTS. At the time of  
19 issuance, the total principal amount of bonds or other obligations  
20 issued or incurred to finance road projects and payable from ad  
21 valorem taxes may not exceed one-fourth of the assessed value of the  
22 real property in the district.

24 SUBCHAPTER F. DISSOLUTION OF DISTRICT

25 Sec. 8363.251. DISSOLUTION BY CITY ORDINANCE. (a) The city  
26 may dissolve the district by ordinance after provision is made for  
27 all debts incurred by the district if:

1           (1) not later than the 90th day after the effective  
2 date of the Act enacting this chapter, the city receives one or more  
3 petitions requesting annexation of all territory in the district  
4 remaining in the extraterritorial jurisdiction of the city;

5           (2) not later than the last day of the ninth month  
6 after the effective date of the Act enacting this chapter, the city  
7 adopts one or more ordinances annexing all territory in the  
8 district remaining in the city's extraterritorial jurisdiction;

9           (3) not later than the last day of the third year after  
10 the effective date of the Act enacting this chapter, the commission  
11 issues an order approving the sale and transfer of a certificate of  
12 public convenience and necessity authorizing the city to provide  
13 retail water service to territory in the district; or

14           (4) by the end of the fifth year after the effective  
15 date of the Act enacting this chapter, the district has not  
16 completed construction of internal streets and water and sanitary  
17 sewer facilities sufficient to serve at least 100 residential lots  
18 in the district.

19           (b) If the city dissolves the district under Subsection (a):

20           (1) any district assets that remain after the payment  
21 of debts shall be transferred to the city; and

22           (2) the organization of the district shall be  
23 maintained until all the debts are paid or assumed and remaining  
24 assets are transferred.

25           (c) This section does not limit the authority of the city to  
26 dissolve the district under Chapter 43, Local Government Code, or  
27 other general law.



1 SECTION 2. The Bearpen Creek Municipal Utility District of  
2 Hunt County initially includes all the territory contained in the  
3 following area:

4 A metes and bounds description of a 960.90 acre tract of land  
5 situated in the James May Survey, Abstract No. 1297, the James Roads  
6 Survey, Abstract No. 872, the G.W. McCafferty Survey, Abstract No.  
7 1298, the Shelby County School Land Survey, Abstract No. 946, and  
8 the John Stone Survey, Abstract No. 198, Hunt County, Texas, and  
9 being that land described by deeds to Bearpen Creek, L.P, as  
10 recorded in Volume 1184, Page 63, Volume 1184, Page 68, Volume 1184,  
11 Page 54, Volume 1184, Page 73, Volume 1184, Page 59, Volume 1184,  
12 Page 59, Volume 1184, Page 36, Volume 1184, Page 50, Volume 1184,  
13 Page 41, Volume 1184, Page 45, and Volume 1184, Page 32, Deed  
14 Records, Hunt County, Texas.

15 BEGINNING at a point for the south right-of-way line of U.S.  
16 Interstate 30, being the northwest corner of said deed recorded in  
17 Volume 1184, Page, 63 and being the northeast corner of a tract of  
18 land described by deed to Sharon McCall, as recorded in Volume 897,  
19 Page 372, Deed Records, Hunt County, Texas;

20 THENCE North 88°51'12" East along the said south right-of-way  
21 line, a distance of 1284.70 feet to a point for corner being the  
22 northwest corner of a tract of land described by deed to Crawford,  
23 as recorded in Volume 178, Page 743, Deed Records, Hunt County,  
24 Texas;

25 THENCE South 01°06'57" East leaving said right-of-way and  
26 along the west line of said Crawford tract, a distance of 943.75  
27 feet to a point for corner, being an el corner of this tract and the

1 southwest corner of said Crawford tract and being near the center of  
2 County Road 2515;

3       THENCE North 88°53'22" East along the south line of said  
4 Crawford tract being in said County Road, a distance of 723.00 feet  
5 to a point for corner, being the southeast corner of said Crawford  
6 tract and being the southwest corner of a tract of land described by  
7 deed to Action Inc., as recorded in Volume 453, Page 845, Deed  
8 Records, Hunt County, Texas;

9       THENCE North 76°06'29" East along the south line of said  
10 Action Inc., a distance of 135.68 feet to a point for corner, being  
11 the northwest corner of a remainder of a tract of land described by  
12 deed to Leonard H. Daniel, as recorded in Volume 99, Page 548, Deed  
13 Records, Hunt County, Texas;

14       THENCE South 00°06'22" East leaving said County Road and the  
15 south line of said Action Inc, and along the west line of said  
16 Daniel remainder tract, a distance of 748.00 feet to a point for  
17 corner;

18       THENCE North 89°08'43" East along the south line of said  
19 Daniel remainder tract, a distance of 395.42 feet to a point for  
20 corner being in the west line of a tract of land described by deed to  
21 Leonard H. Daniel, as recorded in Volume 859, Page 497, Deed  
22 Records, Hunt County, Texas;

23       THENCE South 00°18'34" East along the west line of said Daniel  
24 tract, a distance of 740.51 feet to a point for corner, being an el  
25 corner of this tract and the southwest corner of said Daniel tract  
26 and the northwest corner of a tract of land described by said deed

2 Daniel tract, a distance of 1230.31 feet to a point for corner,

7 Holmes tract, a distance of 1610.64 feet to a point for corner,

10 Hunt County, Texas;

11           THENCE North 89°01'45" East along the south line of said  
12 Magnolia Place, a distance of 402.32 feet to a point for corner,  
13 being the northeast corner of said tract of land recorded in Volume

17 and a tract of land described by deed to Mariana G. Daffron as  
18 recorded in Volume 771, Page 515, Hunt County, Texas, a distance of  
19 1902.70 feet to a point for corner, being the northwest corner of  
20 said tract of land recorded in Volume 1184, Page 45 and being in  
21 County Road 2595;

22           THENCE North 89°57'07" East with said County Road and along  
23 the south line of the tract of land described by deed to Jimmy Joe  
24 Herndon as recorded Volume 515, Page 292, Deed Records, Hunt  
25 County, Texas, a distance of 1988.16 feet to a point for corner,  
26 being in the north line of said tract of land recorded in Volume  
27 1184, Page 36, being the southeast corner of said Herndon tract, and

1 being the southwest corner of said tract of land recorded in Volume,  
2 1184 Page 54;

3       THENCE North 00°17'49" West leaving said County Road and along  
4 the west line of said tract of land recorded in Volume 1184 Page 54  
5 and the east line of the said Herndon tract, a distance of 1807.59  
6 feet to a point for corner, being the southeast corner of said tract  
7 of land recorded in Volume 1184, Page 68 and the northeast corner of  
8 said Herndon tract;

9       THENCE South 89°37'15" West leaving the west line of said  
10 tract of land recorded in Volume 1184, Page 54 and along the said  
11 Herndon tract and along the north line of the tracts of land  
12 described by deed to Jimmy Joe Herndon as recorded in Volume 390,  
13 Page 584, and Volume 57, Page 513, Deed Records, Hunt County, Texas  
14 and along the south line of said tract of land recorded in Volume  
15 1184, Page 68 and south line of said tract of land recorded in  
16 Volume 1184, Page 32, a distance of 3880.16 feet to a point for  
17 corner, being the southwest corner of said tract of land recorded in  
18 Volume 1184, Page 32 and being in the east right-of-way line of Farm  
19 to Market Road 35;

20       THENCE North 25°20'14" West along east line of said F.M. Road  
21 and along the west line of said tract of land recorded in Volume  
22 1184, Page 32, a distance of 547.80 feet to a point for corner;

23       THENCE North 00°37'50" West continuing along said lines, a  
24 distance of 197.10 feet to a point for corner, being the northwest  
25 corner of said tract of land recorded in Volume 1184, Page 32, the

27 Inc. as recorded in Volume 269, Page 489, Deed Records, Hunt County,

3 tract and the north line of said tract of land recorded in Volume

5 being the southeast corner of the White tract, the northeast corner  
6 of said tract of land recorded in Volume 1184, Page 32 and in the  
7 east line of said tract of land recorded in Volume 1184, Page 68;

8           THENCE North 00°16'55" East along the east line of the White  
9 tract and the west line of said tract of land recorded in Volume

11 being in the south line of said tract of land recorded in Volume

13           THENCE South 88°53'22" West continuing along north line of  
14 said White tract and the south line of said tract of land recorded

16 corner, being the southwest corner of said tract of land recorded in  
17 Volume 1184, Page 63 and the southeast corner of said McCall tract;

18           THENCE North 01°06'57" West along west line of said tract of  
19 land recorded in Volume 1184, Page 63 and the east line of said  
20 McCall tract, a distance of 942.94 feet to the POINT OF BEGINNING  
21 and containing 960.90 acres of land, more or less.

22           SECTION 3. (a) The legal notice of the intention to  
23 introduce this Act, setting forth the general substance of this  
24 Act, has been published as provided by law, and the notice and a  
25 copy of this Act have been furnished to all persons, agencies,  
26 officials, or entities to which they are required to be furnished  
27 under Section 59, Article XVI, Texas Constitution, and Chapter 313,



1 Government Code.

2 (b) The governor, one of the required recipients, has  
3 submitted the notice and Act to the Texas Commission on  
4 Environmental Quality.

5 (c) The Texas Commission on Environmental Quality has filed  
6 its recommendations relating to this Act with the governor, the  
7 lieutenant governor, and the speaker of the house of  
8 representatives within the required time.

9 (d) All requirements of the constitution and laws of this  
10 state and the rules and procedures of the legislature with respect  
11 to the notice, introduction, and passage of this Act are fulfilled  
12 and accomplished.

13 SECTION 4. (a) Section 8363.106, Special District Local  
14 Laws Code, as added by Section 1 of this Act, takes effect only if  
15 this Act receives a two-thirds vote of all the members elected to  
16 each house.

17 (b) If this Act does not receive a two-thirds vote of all the  
18 members elected to each house, Subchapter C, Chapter 8363, Special  
19 District Local Laws Code, as added by Section 1 of this Act, is  
20 amended by adding Section 8363.106 to read as follows:

21 Sec. 8363.106. NO EMINENT DOMAIN POWER. The district may  
22 not exercise the power of eminent domain.

23 (c) This section is not intended to be an expression of a  
24 legislative interpretation of the requirements of Section 17(c),  
25 Article I, Texas Constitution.

26 SECTION 5. Except as provided by Section 4 of this Act:

27 (1) this Act takes effect immediately if it receives a

1 vote of two-thirds of all the members elected to each house, as  
2 provided by Section 39, Article III, Texas Constitution; and

3 (2) if this Act does not receive the vote necessary for  
4 immediate effect, this Act takes effect September 1, 2011.
