- 16 (2) the types of research and development incentives
- 17 available in other states.
- 18 (b) The Legislative Budget Board may seek the assistance of
- 19 other state agencies in conducting the study, but the study must be
- 20 completed using existing resources available to the Legislative
- 21 Budget Board and any assisting agencies.
- (c) The Legislative Budget Board shall report the results of
- 23 the study to the legislature not later than January 1, 2013.
- 24 (d) This section expires September 1, 2013.

- 1 SECTION 2. This Act takes effect immediately if it receives
- 2 a vote of two-thirds of all the members elected to each house, as
- 3 provided by Section 39, Article III, Texas Constitution. If this
- 4 Act does not receive the vote necessary for immediate effect, this
- 5 Act takes effect September 1, 2011.
