(1) pledge the sales and use tax proceeds identified

in Subsection (f) from a sales and use tax imposed by an election held under this section after May 21, 1999, to one or more series of sales and use tax revenue bonds issued under Subchapter H; and (2) enter into an agreement or contractual arrangement under Subsection (k) [without the necessity of an election]. SECTION 2. This Act takes effect September 1, 2011.
