## A BILL TO BE ENTITLED

## AN ACT

2 relating to health care information submitted to the Department of3 State Health Services.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 108.009, Health and Safety Code, is 6 amended by amending Subsections (a) and (c) and adding Subsection 7 (d-1) to read as follows:

(a) The council may collect, and, except as provided by 8 Subsections (c), [and] (d), and (d-1), providers shall submit to 9 the council or another entity as determined by the council, all data 10 required by this section. The data shall be collected according to 11 12 uniform submission formats, coding systems, and other technical specifications necessary to make the incoming data substantially 13 14 valid, consistent, compatible, and manageable using electronic data processing, if available. 15

16 (c) A rural provider <u>or a hospital</u> may, but is not required 17 to, provide the data required by this chapter. [A hospital may, but 18 is not required to, provide the data required by this chapter if the 19 hospital:

20 [(1) is exempt from state franchise, sales, ad 21 valorem, or other state or local taxes; and

22 [(2) does not seek or receive reimbursement for 23 providing health care services to patients from any source, 24 including:
