- 24 (b) Section 1302.255, Occupations Code, as amended by this
- 25 Act, applies only to an application for a license or registration
- 26 under that section submitted to the Texas Department of Licensing
- 27 and Regulation on or after November 1, 2012. An application for a

- 1 license, registration, or certification submitted under that
- 2 section before that date is governed by the law in effect on the
- 3 date the application was submitted, and the former law is continued
- 4 in effect for that purpose.
- 5 SECTION 27. This Act takes effect immediately if it
- 6 receives a vote of two-thirds of all the members elected to each
