A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to validating certain acts and proceedings of Harris
- 3 County Improvement District No. 5 and to the boundaries of the
- 4 district.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. BOUNDARIES. (a) The boundaries of Harris County
- 7 Improvement District No. 5 are enlarged to include the following
- 8 tracts of land:
- 9 TRACT 1-COMMENCING at the existing boundary of Harris County
- 10 Improvement District No. 5 at the intersection of N ROW of Bissonnet
- 11 St and E ROW of US 59 (Southwest Fwy) Access Road N/B;
- 12 THENCE, northeast along E ROW of US 59 (Southwest Fwy) Access
- 13 Road N/B to W ROW of S Gessner Rd;
- 14 THENCE, south along W ROW of S Gessner Rd to S ROW of
- 15 Bissonnet Rd;
- 16 THENCE, northeast along S ROW of Bissonnet Rd to E ROW
- 17 Hillcroft St;
- THENCE, along E ROW of Hillcroft St to N ROW of N. Braeswood
- 19 Blvd where it intersects the existing boundary of Harris County
- 20 Improvement District No. 5;
- 21 THENCE, west along the existing boundary of Harris County
- 22 Improvement District No. 5 to THE POINT OF BEGINNING.
- 23 Tract 2-COMMENCING at the existing boundary of Harris County
- 24 Improvement District No. 5 at intersection of E ROW of Hillcroft St

- 1 Blvd and N ROW of Willowbend Blvd;
- THENCE, north along E ROW of Hillcroft St to S boundary of
- 3 utility easement;
- 4 THENCE, east along the S boundary of utility easement to the E
- 5 ROW of S Post Oak Rd;
- 6 THENCE, south along the E ROW of S Post Oak Rd to NW corner of
- 7 0.375 acre parcel (TR 5K ABST 135 W N BRONAUGH);
- 8 THENCE, east along N boundary of 0.375 acre parcel (TR 5K ABST
- 9 135 W N BRONAUGH) to NE corner of said parcel;
- THENCE, south along E boundary of 0.375 acre parcel (TR 5K
- 11 ABST 135 W N BRONAUGH) to SE corner of said parcel and N boundary of
- 12 0.45 acre parcel (TR 5C (001*TR 5E-1) (WILLOW WATERHOLE DETENTION)
- 13 ABST 135 W N BRONAUGH);
- 14 THENCE, east along N boundary of 0.45 acre parcel (TR 5C
- 15 (001*TR 5E-1) (WILLOW WATERHOLE DETENTION) ABST 135 W N BRONAUGH)
- 16 to NE corner of said parcel;
- 17 THENCE, southeast along E boundary 0.45 acre parcel (TR 5C
- 18 (001*TR 5E-1) (WILLOW WATERHOLE DETENTION) ABST 135 W N BRONAUGH)
- 19 to SE corner of said parcel and N boundary of 5.0 acre parcel (TRS
- 20 6D-3 & 6G ABST 135 W N BRONAUGH);
- THENCE, east along N boundary of 5.0 acre parcel (TRS 6D-3 &
- 22 6G ABST 135 W N BRONAUGH) to NE corner of said parcel;
- THENCE, south along E boundary of 5.0 acre parcel (TRS 6D-3 &
- 24 6G ABST 135 W N BRONAUGH) to SE corner of said parcel and adjacent NE
- 25 corner of 52 acre parcel (TRS 6 & 6D ABST 135 W N BRONAUGH);
- THENCE, south and southeast along E boundary of 52 acre
- 27 parcel (TRS 6 & 6D ABST 135 W N BRONAUGH) to N ROW of So. Pacific

- 1 Rail line;
- THENCE, southwest along N ROW of So. Pacific Rail line to SE
- 3 corner of 52 acre parcel (TRS 6 & 6D ABST 135 W N BRONAUGH);
- 4 THENCE, west along S boundary of 52 acre parcel (TRS 6 & 6D
- 5 ABST 135 W N BRONAUGH) and S ROW of Gasmer Dr to E ROW of S Post Oak
- 6 Rd;
- 7 THENCE, south along E ROW of S Post Oak Rd to N ROW of So.
- 8 Pacific Rail line;
- 9 THENCE, southwest along N ROW of So. Pacific Rail line to E
- 10 ROW of Haviland St to the existing boundary of Harris County
- 11 Improvement District No. 5;
- 12 THENCE, north and east along the existing boundary TO THE
- 13 POINT OF BEGINNING.
- 14 (b) The boundaries and field notes contained in Subsection
- 15 (a) of this section form a closure. A mistake in the field notes or
- 16 in copying the field notes in the legislative process does not
- 17 affect the district's:
- 18 (1) organization, existence, or validity;
- 19 (2) right to issue any type of bond for the purposes
- 20 for which the district is created or to pay the principal of and
- 21 interest on a bond;
- 22 (3) right to impose a tax; or
- 23 (4) legality or operation.
- SECTION 2. VALIDATION. (a) The legislature validates and
- 25 confirms all governmental acts and proceedings of the Harris County
- 26 Improvement District No. 5 that were taken before the effective
- 27 date of this Act. An act or proceeding may not be held invalid

- 1 because the act or proceeding was not in accordance with Chapter
- 2 3834, Special District Local Laws Code, or other law.
- 3 (b) This section does not apply to any matter that on the
- 4 effective date of this Act:
- 5 (1) is involved in litigation if the litigation
- 6 ultimately results in the matter being held invalid by a final court
- 7 judgment; or
- 8 (2) has been held invalid by a final court judgment.
- 9 SECTION 3. NOTICE. (a) The legal notice of the intention
- 10 to introduce this Act, setting forth the general substance of this
- 11 Act, has been published as provided by law, and the notice and a
- 12 copy of this Act have been furnished to all persons, agencies,
- 13 officials, or entities to which they are required to be furnished
- 14 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 15 Government Code.
- 16 (b) The governor, one of the required recipients, has
- 17 submitted the notice and Act to the Texas Commission on
- 18 Environmental Quality.
- 19 (c) The Texas Commission on Environmental Quality has filed
- 20 its recommendations relating to this Act with the governor,
- 21 lieutenant governor, and speaker of the house of representatives
- 22 within the required time.
- 23 (d) The general law relating to consent by political
- 24 subdivisions to the creation of districts with conservation,
- 25 reclamation, and road powers and the inclusion of land in those
- 26 districts has been complied with.
- (e) All requirements of the constitution and laws of this

- 1 state and the rules and procedures of the legislature with respect
- 2 to the notice, introduction, and passage of this Act have been
- 3 fulfilled and accomplished.
- 4 SECTION 4. EFFECTIVE DATE. This Act takes effect
- 5 immediately if it receives a vote of two-thirds of all the members
- 6 elected to each house, as provided by Section 39, Article III, Texas
- 7 Constitution. If this Act does not receive the vote necessary for
- 8 immediate effect, this Act takes effect September 1, 2011.
