## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the regulation of orthotists and prosthetists.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Sections 605.002(14) and (18), Occupations Code,
- 5 are amended to read as follows:
- 6 (14) "Orthotics" means the science and practice of
- 7 measuring, designing, fabricating, assembling, fitting, adjusting,
- 8 or servicing an orthosis under an order from a licensed physician,
- 9 chiropractor, or podiatrist, or an advanced practice nurse or
- 10 physician assistant acting under the delegation and supervision of
- 11 a licensed physician as provided by Subchapter B, Chapter 157, and
- 12 rules adopted by the Texas Medical Board, for the correction or
- 13 alleviation of a neuromuscular or musculoskeletal dysfunction,
- 14 disease, injury, or deformity.
- 15 (18) "Prosthetics" means the science and practice of
- 16 measuring, designing, fabricating, assembling, fitting, adjusting,
- 17 or servicing a prosthesis under an order from a licensed physician,
- 18 chiropractor, or podiatrist, or an advanced practice nurse or
- 19 physician assistant acting under the delegation and supervision of
- 20 a licensed physician as provided by Subchapter B, Chapter 157, and
- 21 rules adopted by the Texas Medical Board.

- 1 person licensed to practice orthotics or prosthetics who measures, designs, fabricates, fits, assembles, adjusts, or services an 2 3 orthosis or a prosthesis under an order from a licensed physician, chiropractor, or podiatrist, or an advanced practice nurse or 4 5 physician assistant acting under the delegation and supervision of a licensed physician as provided by Subchapter B, Chapter 157, and 6 7 rules adopted by the Texas Medical Board, for a specific patient is 8 exempt from licensing as a device manufacturer under Subchapter L, Chapter 431, Health and Safety Code. A person licensed to practice 9 10 orthotics or prosthetics who fabricates or assembles an orthosis or a prosthesis without an order from a licensed physician, 11 12 chiropractor, or podiatrist, or an advanced practice nurse or physician assistant acting under the delegation and supervision of 13 14 a licensed physician as provided by Subchapter B, Chapter 157, and 15 rules adopted by the Texas Medical Board, for a specific patient is required to be licensed as a device manufacturer under Subchapter 16 L, Chapter 431, Health and Safety Code. 17
