## A BILL TO BE ENTITLED

## AN ACT

relating to the salary paid to certain professional employees of public schools.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
SECTION 1. Section 21.402, Education Code, is amended by amending Subsections (c) and (d) and adding Subsections (c-4) and (c-5) to read as follows:
(c) The salary factors per step are as follows:

(c-4) Notwithstanding Subsection (a), for the 2011-2012 school year, a classroom teacher, full-time librarian, full-time counselor certified under Subchapter B, or full-time school nurse is entitled to a monthly salary that is at least equal to the sum of :
(1) the monthly salary the employee would have received for the 2011-2012 school year under the district's salary

schedule for the 2010-2011 school year, if that schedule had been in effect for the 2011-2012 school year, including any local supplement and any money representing a career ladder supplement the employee would have received in the $2011-2012$ school year; and (2) $\$ 300$.
(c-5) Subsection (c-4) and this subsection expire September 1, 2012.
(d) A classroom teacher, full-time speech pathologist, full-time librarian, full-time counselor certified under Subchapter $B$, or full-time school nurse employed by a school district in the 2011-2012 [2010-2011] school year is, as long as the employee is employed by the same district, entitled to a salary that is at least equal to the salary the employee received for the 2011-2012 [z2010-2011] school year.

SECTION 2. Section 42.2516, Education Code, is amended by adding Subsection (e-1) to read as follows:
(e-1) The amount of state aid or credit to which a school district is entitled under Section 42.25111 is in addition to the amount of revenue to which the district is entitled under Subsection (b).

SECTION 3. Subchapter E, Chapter 42, Education Code, is amended by adding Section 42.25111 to read as follows:

Sec. 42.25111. ADDITIONAL STATE AID OR CREDIT AGAINST COST OF ATTENDANCE CREDITS FOR PROFESSIONAL STAFF SALARIES. (a) A school district, including a school district that is otherwise ineligible for state aid under this chapter, is entitled to state aid in an amount, as determined by the commissioner, equal to the

product of $3,000 multiplied by the number of classroom teachers,
    full-time librarians, full-time counselors certified under
    Subchapter B, Chapter 21, and full-time school nurses employed by
    the district and entitled to a minimum salary under Section 21.402.
    (b) A school district that is required to take action under
    Chapter 41 to reduce its wealth per student to the equalized wealth
    level is entitled to a credit, in the amount of state aid to which
    the district is entitled under this section, against the total
    amount required under Section 41.093 for the district to purchase
    attendance credits.
    (c) A determination by the commissioner under this section
is final and may not be appealed.
    (d) The commissioner may adopt rules to implement this
    section.
    SECTION 4. This Act applies beginning with the 2011-2012
    school year.
    SECTION 5. This Act takes effect September 1, 2011.
