- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 521.041(b), Transportation Code, is
- 8 amended to read as follows:
- 9 (b) The department shall maintain suitable indexes, in
- 10 alphabetical or numerical order, that contain:
- 11 (1) each denied application and the reasons for the
- 12 denial;
- 13 (2) each application that is granted; [and]
- 14 (3) the name of each license holder whose license has
- 15 been suspended, canceled, or revoked and the reasons for that
- 16 action; and
- 17 (4) the citizenship status of each holder of a license
- 18 or personal identification certificate.
- 19 SECTION 2. Section 521.101, Transportation Code, is amended
- 20 by adding Subsections (d-1), (f-2), and (f-3) and amending
- 21 Subsection (f) to read as follows:
- 22 (d-1) Unless the information has been previously provided
- 23 to the department, the department shall require each applicant for
- 24 an original, renewal, or duplicate personal identification

- 1 <u>certificate to furnish to the department:</u>
- 2 (1) proof of the applicant's United States
- 3 citizenship; or
- 4 (2) documentation described by Subsection (f-2).
- 5 (f) A personal identification certificate expires:
- 6 <u>(1)</u> on a date specified by the department, <u>if the</u>
- 7 applicant is a citizen or legal permanent resident of the United
- 8 States or a refugee or asylee lawfully admitted into the United
- 9 States; or
- 10 (2) for an applicant not described by Subdivision (1),
- 11 on:
- 12 (A) the expiration date of the applicant's
- 13 authorized stay in the United States; or
- 14 (B) the first anniversary of the date of
- 15 issuance, if there is no definite expiration date for the
- 16 applicant's authorized stay in the United States [except that a
- 17 certificate issued to a person 60 years of age or older does not
- 18 expire].
- 19 (f-2) An applicant who is not a citizen of the United States
- 20 must present to the department documentation issued by the United
- 21 States agency responsible for citizenship and immigration that
- 22 authorizes the applicant to be in the United States.
- 23 <u>(f-3) The department may not issue a personal</u>
- 24 identification certificate to an applicant who fails or refuses to
- 25 comply with Subsection (f-2).
- SECTION 3. Section 521.103, Transportation Code, is amended
- 27 by adding Subsection (c) to read as follows:

- 1 (c) Sections 521.101(f-2) and (f-3) apply to a personal
- 2 identification certificate for which application is made under this
- 3 section.
- 4 SECTION 4. Sections 521.142(a) and (e), Transportation
- 5 Code, are amended to read as follows:
- 6 (a) An application for an original license must state the
- 7 applicant's full name and place and date of birth. This information
- 8 must be verified by presentation of proof of identity satisfactory
- 9 to the department. An applicant who is not a citizen of the United
- 10 States must present to the department documentation issued by the
- 11 United States agency responsible for citizenship and immigration
- 12 that authorizes the applicant to be in the United States before the
- 13 <u>applicant may be issued a driver's license.</u> The department must
- 14 accept as satisfactory proof of identity under this subsection an
- 15 offender identification card or similar form of identification
- 16 issued to an inmate by the Texas Department of Criminal Justice if
- 17 the applicant also provides supplemental verifiable records or
- 18 documents that aid in establishing identity.
- 19 (e) The application must include any other information the
- 20 department requires to determine the applicant's identity,
- 21 <u>residency</u>, competency, and eligibility <u>as required by the</u>
- 22 <u>department or state law</u>.
- SECTION 5. Section 521.1425, Transportation Code, is
- 24 amended by amending Subsection (a) and adding Subsection (c) to
- 25 read as follows:
- 26 (a) Except as provided by Subsections [Subsection] (b) and
- 27 (c), the department may require each applicant for an original,

- 1 renewal, or duplicate driver's license to furnish to the department
- 2 the information required by Section 521.142.
- 3 (c) Unless the information has been previously provided to
- 4 the department, the department shall require each applicant for an
- 5 original, renewal, or duplicate driver's license to furnish to the
- 6 department:
- 7 (1) proof of the applicant's United States
- 8 citizenship; or
- 9 (2) documentation described by Section 521.142(a).
- 10 SECTION 6. Section 521.271, Transportation Code, is amended
- 11 by amending Subsections (a) and (b) and adding Subsections (a-2),
- 12 (a-3), and (a-4) to read as follows:
- 13 (a) Each original driver's license, [and] provisional
- 14 license, instruction permit, or occupational license issued to an
- 15 applicant who is a citizen or legal permanent resident of the United
- 16 States or a refugee or asylee lawfully admitted into the United
- 17 States expires as follows:
- 18 (1) except as provided by Section 521.2711, a driver's
- 19 license expires on the first birthday of the license holder
- 20 occurring after the sixth anniversary of the date of the
- 21 application;
- 22 (2) a provisional license expires on the 18th
- 23 birthday of the license holder;
- 24 (3) an instruction permit expires on the 18th birthday
- 25 of the license holder;
- 26 (4) an occupational license expires on the first
- 27 anniversary of the court order granting the license; and

(5) unless an earlier date is otherwise provided, a 1 driver's license issued to a person whose residence or domicile is a 2 correctional facility or a parole facility expires on the first 3 birthday of the license holder occurring after the 4 5 anniversary of the date of issuance. 6 (a-2) Each original driver's license issued to an applicant 7 who is not a citizen or legal permanent resident of the United States or a refugee or asylee lawfully admitted into the United 8 States expires on: 9 10 (1) the earlier of: (A) the first birthday of the license holder 11 12 occurring after the sixth anniversary of the date of 13 application; or 14 (B) the expiration date of the license holder's 15 lawful presence in the United States as determined by the United States agency responsible for citizenship and immigration in 16 17 compliance with federal law; or (2) the first anniversary of the date of issuance, if 18 19 there is no definite expiration date for the applicant's authorized stay in the United States. 20 21 (a-3) Each original provisional license or instruction permit issued to an applicant who is not a citizen or legal 22 permanent resident of the United States or a refugee or asylee 23 24 lawfully admitted into the United States expires on the earliest

2 (3) the expiration of the license holder's lawful presence in the United States as determined by the United States 3 agency responsible for citizenship and immigration in compliance 4 5 with federal law. 6 (a-4) Each original occupational license issued to an applicant who is not a citizen or legal permanent resident of the 7 United States or a refugee or asylee lawfully admitted into the 8 United States expires on the earlier of: 9 (1) the first anniversary of the date of issuance; or 10 (2) the expiration of the license holder's lawful 11 12 presence in the United States as determined by the United States agency responsible for citizenship and immigration in compliance 13 14 with federal law. 15 (b) Except as provided by Section 521.2711, a driver's license that is renewed expires on the earlier of: 16 17 (1) the sixth anniversary of the expiration date before renewal if the applicant is a citizen or legal permanent 18 19 resident of the United States or a refugee or asylee lawfully admitted into the United States; 20 21 (1-a) for an applicant not described by Subdivision 22 (1):23 (A) the earlier of: 24 (i) the sixth anniversary of the expiration 25 date before renewal; or 26 (ii) the expiration date of the applicant's authorized stay in the United States; or 27

- 20 driver's license, personal identification certificate, commercial
- 21 driver's license, or commercial driver learner's permit issued or
- 22 renewed before the effective date of this Act is governed by the law
- 23 in effect when the license, certificate, or permit was issued, and
- 24 the former law is continued in effect for that purpose.
- 25 SECTION 15. This Act takes effect September 1, 2011.
