- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 7
- SECTION 1. Sections 66.08(d) and (e), Education Code, are 8
- amended to read as follows: 9
- The board of directors of the corporation shall have 10
- 11 nine members, determined as follows:
- 12 (1) six[. The board shall appoint and remove all]
- 13 members appointed by the board, of whom [of the board of directors
- 14 of the corporation. At least] three must be members of the board
- and the other three must have a substantial background and 15
- 16 expertise in investments;
- (2) [and] the chancellor of The University of Texas 17
- System; and 18
- (3) two members appointed by the board of regents of 19
- The Texas A&M University System, at least one of whom must have a 20
- substantial background and expertise in investments [shall be 21
- appointed as directors]. 22
- (e) Each appointed member of the board of directors of the 23
- corporation is subject to removal and replacement by and at the 24

- 1 pleasure of the appointing entity [The board shall select one or
- 2 more of the members of the board of directors of the corporation
- 3 from a list of candidates with substantial background and expertise
- 4 in investments that is submitted to the board by the board of
- 5 regents of The Texas A&M University System].
- 6 SECTION 2. (a) This section applies to the corporation
- 7 described by Section 66.08, Education Code, and governs the
- 8 implementation of the changes in law made by this Act to the board
- 9 of directors of the corporation.
- 10 (b) This Act does not affect the terms of office of members
- 11 of the corporation's board of directors who are serving on the
- 12 effective date of this Act.
- 13 (c) The board of regents of The Texas A&M University System
- 14 shall appoint two directors as required by Section 66.08(d)(3),
- 15 Education Code, as added by this Act, as follows:
- 16 (1) one director on the expiration of the term of
- 17 office of a director serving on the effective date of this Act who,
- 18 under prior law, was appointed to that position on recommendation
- 19 of that board of regents; and
- 20 (2) one director on the first expiration after the
- 21 effective date of this Act of a term of office of any director,
- 22 other than:
- 23 (A) the director described by Subdivision (1) of
- 24 this subsection; and
- 25 (B) any director who also serves as a member of
- 26 the board of regents of a university system, as defined by Section
- 27 61.003, Education Code.

- 1 (d) As soon as practicable after the effective date of this
- 2 Act, the board of directors of the corporation and the board of
- 3 regents of The University of Texas System shall amend the bylaws of
- 4 the corporation as necessary to give effect to the requirements of
- 5 this Act.
- 6 SECTION 3. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2011.
