17	Sec. 552.309. TIMELINESS OF ACTION BY ELECTRONIC
18	SUBMISSION. (a) When this subchapter requires a request, notice,
19	or other document to be submitted or otherwise given to the attorney
20	general within a specified period, the requirement is met in a
21	timely fashion if the document is submitted to the attorney general
22	through the attorney general's designated electronic filing system
23	within that period.
24	(b) The attorney general may electronically transmit a

notice, decision, or other document. When this subchapter requires 1 the attorney general to deliver a notice, decision, or other 2 document within a specified period, the requirement is met in a 3 timely fashion if the document is electronically transmitted by the 4 5 attorney general within that period. 6 (c) This section does not affect the right of a person or 7 governmental body to submit information to the attorney general 8 under Section 552.308. SECTION 3. The fee prescribed by Section 402.006(d), 9

9 SECTION 3. The fee prescribed by Section 402.006(d), 10 Government Code, as added by this Act, applies only to a document 11 electronically submitted to the office of the attorney general on 12 or after the effective date of this Act.

13 SECTION 4. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect September 1, 2011.
