AN ACT

2 relating to the elimination of certain required reports prepared by
3 state agencies and institutions of higher education.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 201.023(b), Agriculture Code, is amended
6 to read as follows:

7 (b) The financial transactions of the state board are
8 subject to audit by the state auditor in accordance with Chapter
9 321, Government Code. ~~[The board shall file annually with the~~
10 ~~governor and the presiding officer of each house of the legislature~~
11 ~~a complete and detailed written report that accounts for all funds~~
12 ~~received and disbursed by the board during the preceding year. The~~
13 ~~form of the annual report and the time for the report shall be~~
14 ~~prescribed in the General Appropriations Act.]~~

15 SECTION 2. Section 21.040, Education Code, is amended to
16 read as follows:

17 Sec. 21.040. GENERAL POWERS AND DUTIES OF BOARD. The board
18 shall:

- 19 (1) supervise the executive director's performance;
- 20 (2) approve an operating budget for the board and make
21 a request for appropriations;
- 22 (3) appoint the members of any advisory committee to
23 the board;
- 24 (4) for each class of educator certificate, appoint an

1 advisory committee composed of members of that class to recommend
2 standards for that class to the board;

3 (5) provide to its members and employees, as often as
4 necessary, information regarding their qualifications for office
5 or employment under this chapter and their responsibilities under
6 applicable laws relating to standards of conduct for state officers
7 or employees;

8 (6) develop and implement policies that clearly define
9 the respective responsibilities of the board and the board's staff;
10 and

11 (7) ~~[file annually with the governor and the presiding~~
12 ~~officer of each house of the legislature a complete and detailed~~
13 ~~written report, in the form and within the time provided by the~~
14 ~~General Appropriations Act, accounting for all funds received and~~

10 SECTION 7. Section 501.007, Government Code, is amended to
11 read as follows:

12 Sec. 501.007. INMATE CLAIMS FOR LOST OR DAMAGED PROPERTY.
13 The department may pay from the miscellaneous funds appropriated to
14 the division claims made by inmates housed in facilities operated
15 by the department for property lost or damaged by the division. The
16 department shall maintain a record of all transactions made under
17 this section [~~and shall send a copy of that record to the state~~
18 ~~auditor at least annually~~]. The record must show the amount of each
19 claim paid, the identity of each claimant, and the purpose for which
20 each claim was made. The department may not pay under this section
21 more than \$500 on a claim.

22 SECTION 8. Section 508.036(b), Government Code, is amended
23 to read as follows:

24 (b) The board shall:

25 (1) adopt rules relating to the decision-making
26 processes used by the board and parole panels;

20 (2) inform the governor and the legislature of federal
21 programs that may be carried out in the state or that affect state
22 programs;

23 (3) provide federal agencies and the United States
24 Congress with information about state policy and state conditions
25 on matters that concern the federal government;

26 (4) provide the legislature with information useful in
27 measuring the effect of federal actions on the state and local

1 programs;

2 (5) prepare and supply to the governor and all members
3 of the legislature an annual report that:

4 (A) describes the office's operations;

5 (B) contains the office's priorities and
6 strategies for the following year;

7 (C) details projects and legislation pursued by
8 the office;

9 (D) discusses issues in the following
10 congressional session of interest to this state; and

11 (E) contains an analysis of federal funds
12 availability and formulae;

12 the system. At the end of each fiscal biennium the department shall

9 created by the office under Section 131.003(a)(2), the office
10 shall:

11 (1) review rules, policies, contracts, grants, and
12 funding mechanisms relating to transportation services of each
13 health and human services agency that provides, purchases, or
14 otherwise funds transportation services for clients to determine
15 whether the rules, policies, contracts, grants, and funding
16 mechanisms are consistent with the plan; and

17 (2) make recommendations for revisions to rules,
18 policies, contracts, grants, and funding mechanisms determined
19 under Subdivision (1) to be inconsistent with the plan[~~, and~~

20 ~~(3) not later than September 30 of each even-numbered~~
21 ~~year, submit a report by electronic mail and by hand delivery to the~~

5 SECTION 17. This Act takes effect immediately if it
6 receives a vote of two-thirds of all the members elected to each
7 house, as provided by Section 39, Article III, Texas Constitution.
8 If this Act does not receive the vote necessary for immediate
9 effect, this Act takes effect September 1, 2011.
