- 17 SECTION 2. Section 504.504(b), Transportation Code, is
- 18 amended to read as follows:
- 19 (b) An owner is not required to register a vehicle that is
- 20 used only temporarily on the highways if the vehicle is:
- 21 (1) a farm trailer or farm semitrailer with a gross
- 22 weight of more than 4,000 pounds but not more than 34,000 pounds
- 23 that is used exclusively [to transport]:
- 24 (A) to transport seasonally harvested

- 1 agricultural products or livestock from the place of production to
- 2 the place of processing, market, or storage; [ex]
- 3 (B) to transport farm supplies from the place of
- 4 loading to the farm; or
- 5 (C) for the purpose of participating in equine
- 6 <u>activities or attending livestock shows</u>, as defined by Section
- 7 87.001, Civil Practice and Remedies Code;
- 8 (2) machinery used exclusively for the purpose of
- 9 drilling water wells; or
- 10 (3) construction machinery that is not designed to
- 11 transport persons or property on a public highway.
- 12 SECTION 3. This Act takes effect immediately if it receives
- 13 a vote of two-thirds of all the members elected to each house, as
- 14 provided by Section 39, Article III, Texas Constitution. If this
- 15 Act does not receive the vote necessary for immediate effect, this
- 16 Act takes effect September 1, 2011.
