- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Title 3, Agriculture Code, is amended by adding

## 7 CHAPTER 50E. URBAN FARMING PILOT PROGRAM AND SELECT COMMITTEE

- 8 SUBCHAPTER A. URBAN FARMING PILOT PROGRAM
- 9 Sec. 50E.001. DEFINITION. In this chapter, "program" means
- 10 the urban farming pilot program established under this chapter.
- 11 Sec. 50E.002. ESTABLISHMENT OF URBAN FARMING PILOT PROGRAM.
- 12 (a) The department by rule shall develop and implement an urban
- 13 farming pilot program through which the department will award
- 14 grants if funding for grants is available to urban farmers in this
- 15 state to establish new urban farms and expand existing urban farms.
- 16 (b) The department by rule shall define "urban farm" and
- 17 "urban farmer" for purposes of this chapter.
- 18 <u>(c) The department may operate the program in an area</u>
- 19 <u>designated as an enterprise zone under Chapter 2303, Government</u>
- 20 Code, in a municipality with a population of 500,000 or more.
- Sec. 50E.003. USE OF AWARDED GRANT MONEY. A grant recipient
- 22 may use grant money awarded under the program only to cover costs
- 23 that are approved by the department.
- Sec. 50E.004. GRANT RECIPIENT REPORTING REQUIREMENTS. A

- 1 grant recipient shall report information related to the program to
- 2 the department in the form and manner and at regular intervals as
- 3 prescribed by the department.
- 4 Sec. 50E.005. EVALUATION BY DEPARTMENT. The department
- 5 shall monitor and periodically evaluate:
- 6 (1) the performance of each grant recipient under the
- 7 program;
- 8 (2) how each grant recipient uses the grant money
- 9 awarded under the program; and
- 10 (3) the effect of the program on the grant recipient
- 11 and on the residents of the municipality in which the grant
- 12 recipient uses grant money.
- Sec. 50E.006. FUNDING. (a) The department may seek,
- 14 accept, and spend any funds received through grants or donations
- 15 from public or private sources for the purposes of the program.
- 16 (b) The department is not required to implement the program
- 17 unless the department has sufficient funding from a source other
- 18 than an appropriation of general revenue.
- 19 (c) State money may not be used for purposes of the program.

- 21 SUBCHAPTER B. SELECT COMMITTEE ON URBAN FARMING
- Sec. 50E.011. DEFINITION. In this chapter, "committee"
- 23 means the Select Committee on Urban Farming.
- Sec. 50E.012. COMPOSITION. (a) The Select Committee on
- 25 Urban Farming is composed of:
- 26 (1) three members appointed by the president of
- 27 Prairie View A&M University;

1	(2) three members appointed by the board of regents of

3	(3) three members appointed by the director of the						
4	Texas AgriLife Extension Service.						
5	(b) The committee shall elect a presiding officer from among						
6	its members.						
7	Sec. 50E.013. COMPENSATION. A person is not entitled to						
8	compensation or reimbursement for serving as a committee member.						
9	Sec. 50E.014. COMMITTEE DUTIES. (a) The committee shall:						
10	(1) meet at the call of the presiding officer; and						
11	(2) conduct an interim study and make recommendations						
12	to the legislature regarding:						
13	(A) the performance and operation of the program;						
14	(B) the continuation, elimination, or expansion						
15	of the program;						
16	(C) urban farming trends, including farming in						
17	sustainable living communities, cooperative crop production, and						
18	vertical integration farming;						
19	(D) capacity for urban farming in this state; and						
20	(E) potential effects of urban farming on the						
21	population of this state and on enterprise zones.						
22	(b) The committee may request the assistance of state						
23	agencies, departments, or offices to carry out its duties.						
24	Sec. 50E.015. REPORT. Not later than December 1, 2012, the						
25	committee shall submit a report based on its findings to:						
26	(1) the governor;

- 3 <u>SUBCHAPTER C. EXPIRATION OF CHAPTER</u>
- 4 Sec. 50E.021. EXPIRATION. This chapter expires and the
- 5 committee is abolished September 1, 2013.
- 6 SECTION 2. (a) Not later than January 1, 2012, the
- 7 Department of Agriculture shall implement the urban farming pilot
- 8 program established under Chapter 50E, Agriculture Code, as added
- 9 by this Act.
- 10 (b) Not later than October 1, 2011, the appointing entities
- 11 listed in Section 50E.012, Agriculture Code, as added by this Act,
- 12 shall make the appointments required by that section.
- 13 (c) Not later than October 15, 2011, the commissioner of
- 14 agriculture shall call the first meeting of the Select Committee on
- 15 Urban Farming to permit the committee to elect a presiding officer
- 16 as required by Section 50E.012(b), Agriculture Code, as added by
- 17 this Act.
- SECTION 3. This Act takes effect September 1, 2011.
