## A BILL TO BE ENTITLED

	AN ACT

- 19 same victim as a victim of an offense under Section 20A.02, a
- 20 <u>defendant may not be convicted of the offense under Section 20A.02</u>
- 21 in the same criminal action as the offense under Subsection (a),
- 22 unless the offense under Section 20A.02:

- 5 purposes of this section, an offense was committed before the
- 6 effective date of this Act if any element of the offense occurred
- 7 before that date.
