9	(1) the waiver is underwritten and delivered or issued
10	for delivery by an insurer to which Chapters 2251 and 2301,

12	(2) the rate used to price the damage waiver is not
13	disapproved under Chapter 2251, Insurance Code; and
14	(3) the form of the damage waiver has been approved by
15	the commissioner of insurance under Chapter 2301, Insurance Code.

- 2 provision of this chapter, rates for pricing damage waivers sold or

- 6 (b) A vehicle rental company may not sell or provide a
- 7 damage waiver unless the rate used to price the damage waiver is
- 8 filed with the department by the insurer underwriting the waiver

- Sec. 2301.102. FILING AND APPROVAL OF WAIVERS. An insurer
- 23 may not deliver or issue for delivery in this state a damage waiver
- 24 for use by a vehicle rental company, and a vehicle rental company
- 25 may not sell or provide a damage waiver in this state, unless the
- 26 form of the waiver has been filed with and approved by the
- 27 commissioner in the same manner as an insurance policy described by

- 2 <u>Sec. 2301.103.</u> RULES. The commissioner shall adopt rules
- 3 <u>necessary to implement and enforce this chapter.</u>
- 4 SECTION 4. This Act applies only to a damage waiver sold or
- 5 provided by a rental company subject to Chapter 91, Business &
- 6 Commerce Code, on or after January 1, 2012.
- 7 SECTION 5. This Act takes effect September 1, 2011.
