| 13 | to read as follows:  |
| 14 | (a) The driver's license must include:                               |
| 15 | (1) a distinguishing number assigned by the department               |
| 16 | to the license holder;   |
| 17 | (2) a color <u>or grayscale</u> photograph of the entire face        |
| 18 | of the holder;   |
| 19 | (3) the full name and date of birth of the holder;                   |
| 20 | (4) a brief description of the holder; and                           |
| 21 | (5) the license holder's residence address or, for a                 |
| 22 | license holder using the procedure under Subsection (c), the street  |
| 23 | address of the courthouse in which the license holder or license     |
| 24 | holder's spouse serves as a federal judge or state judge.            |

CONTENT OF LICENSE. 3 A commercial driver's license must: 4 5 (1)be marked "Commercial Driver License" or "CDL"; (2) be, to the extent practicable, tamper-proof; and 6 7 include: (3) 8 (A) the name and mailing address of the person to whom it is issued; 9 the person's color or grayscale photograph; 10 (B) a physical description of the person, 11 (C) 12 including sex, height, and eye color; the person's date of birth; 13 (D) 14 (E) а number or identifier the department 15 considers appropriate; 16 (F) the person's signature; each class of commercial motor vehicle that 17 (G) the person is authorized to drive, with any endorsements or 18 19 restrictions; (H) the name of this state; and 20 the dates between which the license is valid. 21 (I) SECTION 4. The changes in law made by this Act apply only to 2.2 23 driver's license, personal identification certificate, а or 24 commercial driver's license issued or renewed on or after the 25 effective date of this Act. A driver's license, personal identification certificate, or commercial driver's license issued 26 or renewed before the effective date of this Act is governed by the 27

3 SECTION 5. To the extent of any conflict, this Act prevails 4 over another Act of the 82nd Legislature, Regular Session, 2011, 5 relating to nonsubstantive additions to and corrections in enacted 6 codes.

7 SECTION 6. This Act takes effect September 1, 2011.
