- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5
- 6 ARTICLE 1. HIGHER EDUCATION COORDINATING BOARD RESPONSIBILITY FOR
- ADULT EDUCATION AND LITERACY PROGRAMS 7
- SECTION 1.01. Chapter 61, Education Code, is amended by 8
- 9 adding Subchapter HH to read as follows:
- SUBCHAPTER HH. ADULT EDUCATION AND LITERACY PROGRAMS 10
- Sec. 61.9791. DEFINITIONS. In this subchapter: 11
- 12 (1) "Adult" means any individual who is over the age of
- 13 compulsory school attendance prescribed by Section 25.085.
- (2) "Adult education" means services and instruction 14
- provided below the college level for adults by public local 15
- education agencies, public nonprofit agencies, or community-based 16
- 17 organizations.
- (3) "Community-based organization" has the meaning 18
- assigned by 20 U.S.C. Section 7801. 19
- Sec. 61.9792. BOARD DUTIES. (a) The board shall: 20
- 21 (1) provide adequate staffing to develop, administer,
- 22 and support a comprehensive statewide adult education program and
- 23 coordinate related federal and state programs for the education and
- 24 training of adults;

- 1 (2) develop the mechanism and guidelines for the
- 2 coordination of comprehensive adult education and related skill
- 3 training services for adults with other organizations, including
- 4 public agencies and private organizations, in planning,
- 5 developing, and implementing related programs;
- 6 (3) administer all state and federal funds for adult
- 7 education and related skill training services in this state, other
- 8 than funds that another entity is specifically authorized to
- 9 administer under other law;
- 10 (4) prescribe and administer standards and
- 11 accrediting policies for adult education;
- 12 (5) prescribe and administer rules for teacher
- 13 certification for adult education;
- 14 (6) accept and administer grants, gifts, services, and
- 15 funds from available sources for use in adult education;
- 16 (7) adopt or develop and administer a standardized
- 17 assessment mechanism for assessing all adult education program
- 18 participants who need literacy instruction, adult basic education,
- 19 or secondary education leading to an adult high school diploma or
- 20 the equivalent; and
- 21 (8) monitor and evaluate educational and employment
- 22 <u>outcomes of students who participate in the board's adult education</u>
- 23 <u>and literacy programs.</u>
- 24 (b) The assessment mechanism prescribed by Subsection
- 25 (a)(7) must include an initial basic skills screening instrument
- 26 and must provide comprehensive information concerning baseline
- 27 student skills before and student progress after participation in

1 an adult education program. 2 Sec. 61.9793. PROVISION OF ADULT EDUCATION PROGRAMS. Adult education programs must be provided by public school districts, 3 public junior colleges, public technical institutes, public state 4 5 colleges, general academic teaching institutions, public nonprofit agencies, and community-based organizations approved in accordance 6 7 with state law and with rules adopted by the board. The programs 8 must be designed to meet the education and training needs of adults to the extent possible using available public and private 9 resources. Bilingual education may be used to instruct students 10 who do not function satisfactorily in English whenever it is 11 12 appropriate for those students' optimum development. Sec. 61.9794. ADULT EDUCATION AND LITERACY ADVISORY 13 14 COMMITTEE. (a) The board shall establish an adult education and 15 literacy advisory committee composed of not more than nine members appointed by the board. Members of the advisory committee must have 16 17 expertise in the field of adult education and literacy. The advisory committee must include three representatives from public 18 junior or community colleges and may include adult educators, 19 providers, advocates, and current or former adult education and 20 21 literacy program students. 22 The advisory committee shall: 23 (1) meet at least quarterly; 24 report to the board at least annually; and (3) advise the board on: 25 26 (A) the development of policies and program priorities that support the development of an educated and skilled 27

- 1 workforce in this state;
- 2 (B) the development of statewide curriculum
- 3 quidelines and standards for adult education and literacy services
- 4 that ensure a balance of education and workplace skill development;
- 5 and
- 6 (C) any other issue the board considers
- 7 <u>appropriate</u>.
- 8 (c) Chapter 2110, Government Code, does not apply to the
- 9 size, composition, or duration of the advisory committee.
- Sec. 61.9795. STATE FUNDING. (a) Funds shall be
- 11 appropriated to implement statewide adult basic education, adult
- 12 bilingual education, high school equivalency, and high school
- 13 credit programs to eliminate illiteracy in this state and to
- 14 implement and support a statewide program to meet the total range of
- 15 adult needs for adult education and related skill training. The
- 16 board shall ensure that public local education agencies, public
- 17 nonprofit agencies, and community-based organizations have direct
- 18 and equitable access to those funds.
- 19 (b) In addition to any amount appropriated under Subsection
- 20 (a), the legislature may appropriate an additional amount to the
- 21 board for the purpose of skill training in direct support of
- 22 industrial expansion and new business development, and to those
- 23 locations, industries, and occupations designated by the board, if
- 24 the training supports the basic purposes of this subchapter. To
- 25 support the basic purposes of this subchapter, the legislature may
- 26 also appropriate an additional amount to the board for skill
- 27 training that is conducted to support the expansion of civilian

- 1 employment opportunities on United States military reservations.
- 2 Sec. 61.9796. BIENNIAL REPORT TO THE LEGISLATURE. Not
- 3 later than December 1 of each even-numbered year, the board shall
- 4 report to the legislature regarding the educational and employment
- 5 outcomes of students who participate in the adult education and
- 6 literacy programs under this subchapter.
- 7 Sec. 61.9797. RULES. The board may adopt rules as necessary
- 8 to administer this subchapter.
- 9 ARTICLE 2. TEXAS EDUCATION AGENCY RESPONSIBILITY FOR COMMUNITY
- 10 EDUCATION PROGRAMS; CONFORMING CHANGES
- 11 SECTION 2.01. The heading to Subchapter H, Chapter 29,

Sec. 29.255. STATE FUNDING. $\left[\frac{a}{a}\right]$ 1 Funds shall be appropriated to implement statewide community [adult basic] 2 education[, adult bilingual education, high school equivalency, 3 and high school credit] programs, including [to eliminate 4 5 illiteracy in this state and to implement and support a statewide program to meet the total range of adult needs for adult education, 6 related skill training, and] pilot programs to demonstrate the 7 8 effectiveness of the community education concept. The agency shall ensure that public local education agencies, public nonprofit 9 agencies, and community-based organizations have direct and 10 equitable access to those funds. [An additional sum of money may be 11 appropriated to the Texas Department of Commerce for the purpose of 12 skill training in direct support of industrial expansion and 13 start-up, and those locations, industries, and occupations 14 15 designated by the Texas Department of Commerce, when such training is also in support of the basic purposes of this subchapter. To 16 17 fulfill the basic purposes of this subchapter, an additional sum of money may be appropriated for skill training that is conducted to 18 support the expansion of civilian employment opportunities on 19 United States military reservations. 20 21 [(b) The agency, in conjunction with the Texas Department of Commerce, may adopt rules to administer skill training programs for 22 which the agency is responsible, and the Texas Department of 23 24 Commerce may adopt rules to administer skill training programs for 25 which it is responsible. - 5 ARTICLE 3. TRANSITION PROVISIONS; EFFECTIVE DATE
- 6 SECTION 3.01. (a) On January 1, 2012:
- 7 (1) the administration of adult education and literacy
- 8 programs shall be transferred from the Texas Education Agency to
- 9 the Texas Higher Education Coordinating Board;
- 10 (2) all rules, policies, procedures, and decisions of
- 11 the Texas Education Agency relating to the administration of adult
- 12 education and literacy programs are continued in effect as rules,
- 13 policies, procedures, and decisions of the Texas Higher Education
- 14 Coordinating Board until superseded by a rule or other appropriate

- 1 transfer on January 1, 2012, of all powers, duties, obligations,
- 2 rights, contracts, leases, records, real or personal property, and
- 3 unspent and unobligated appropriations and other funds relating to
- 4 the administration of adult education and literacy programs from
- 5 the Texas Education Agency to the Texas Higher Education
- 6 Coordinating Board; and
- 7 (2) measures to ensure against any unnecessary
- 8 disruption to adult education and literacy services provided at the
- 9 local level.
- 10 SECTION 3.02. This Act takes effect September 1, 2011.
