## A BILL TO BE ENTITLED

- 2 relating to the administration and business affairs of public
- 3 institutions of higher education.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 ARTICLE 1. FINANCIAL MANAGEMENT
- 6 SECTION 1.01. Section 51.003, Education Code, is amended by
- 7 amending Subsection (b) and adding Subsection (f) to read as
- 8 follows:
- 9 (b) The funds shall either be deposited in the depository
- 10 bank or banks or invested as authorized by Chapter 2256, Government
- 11 Code (Public Funds Investment Act). Funds that are to be deposited
- 12 in the depository bank or banks must be deposited within seven days
- 13 from the date of receipt by the institution [collection].
- 14 (f) Notwithstanding any other provision of this section,
- 15 the governing board of each institution may maintain unsecured
- 16 deposits in a foreign bank as necessary to support the
- 17 institution's operations in a foreign country. The foreign bank
- 18 <u>must:</u>
- 19 (1) be licensed and supervised by a central bank;
- 20 (2) be audited annually by an accounting firm that
- 21 follows international financial reporting standards; and
- 22 (3) maintain a capital to total assets ratio that is
- 23 not less than the greater of four percent or the minimum tier 1
- 24 capital to total assets ratio required for depository institutions

- 1 <u>insured by the Federal Deposit Insurance Corporation.</u>
- 2 SECTION 1.02. Subchapter A, Chapter 51, Education Code, is
- 3 amended by amending Section 51.005 and adding Sections 51.010,
- 4 51.011, and 51.012 to read as follows:
- 5 Sec. 51.005. REPORTS. Each institution of higher education
- 6 [(a) True and full accounts shall be kept by the governing board
- 7 and by the employees of the institution of all funds collected from
- 8 all sources and of all sums paid out and the persons to whom and the
- 9 purposes for which the sums are paid. The governing board shall
- 10 prepare [annually print] a complete annual financial report as
- 11 prescribed by Section 2101.011, Government Code [of all the sums
- 12 collected, all expenditures, and all sums remaining on hand. The
- 13 report shall show the true condition of all funds as of the August
- 14 31 preceding as well as the collections and expenditures for the
- 15 preceding year.
- 16 [(b) Reports under this section must be in a form approved
- 17 jointly by the coordinating board and the comptroller. The
- 18 accounting and classification procedures of each institution must
- 19 be consistent with uniform procedures prescribed for that purpose
- 20 by the coordinating board and the comptroller. The requirements
- 21 imposed by the coordinating board and the comptroller must be
- 22 designed to reduce paperwork and duplicative reports.
- 23 [(c) The governing board shall furnish one copy of the
- 24 report each to the governor, comptroller of public accounts, state
- 25 auditor, Texas Higher Education Coordinating Board, Legislative
- 26 Budget Board, House Appropriations Committee, Senate Finance
- 27 Committee, and Legislative Reference Library. A copy of the report

- 1 shall be submitted to the comptroller by the deadline established
- 2 by the comptroller or the General Appropriations Act as necessary
- 3 to prepare an audited comprehensive financial report. The governing
- 4 board shall retain five copies of the report for distribution to
- 5 legislators or other state officials on request].
- 6 Sec. 51.010. COLLECTION OF DELINQUENT OBLIGATIONS. If
- 7 under the rules adopted by the attorney general under Chapter 2107,
- 8 Government Code, an institution of higher education is not required
- 9 to refer a delinquent obligation for collection to the attorney
- 10 general, the institution is not required to expend resources for
- 11 further collection efforts if, considering the amount, security,
- 12 likelihood of collection, expense, and available resources, the
- 13 <u>institution</u> determines that further collection should not be
- 14 actively pursued.
- Sec. 51.011. DISPOSITION OF SMALL CREDIT BALANCES. (a)
- 16 This section applies to a credit balance of less than \$25 held by an
- 17 institution of higher education that is presumed abandoned under
- 18 Chapter 72, Property Code.
- 19 (b) An institution of higher education may maintain an
- 20 unclaimed money fund and transfer to that fund a credit balance to
- 21 which this section applies. A deposit to the unclaimed money fund
- 22 does not affect the ownership of the amount deposited. The
- 23 institution shall:
- 24 (1) adopt procedures for owners to make and receive
- 25 payments of claims against the fund; and
- 26 (2) maintain a database that permits members of the
- 27 public to search for ownership of unclaimed funds.

- 1 (c) The institution shall use the fund to pay the claims of
- 2 persons establishing ownership of amounts transferred to the fund
- 3 and shall hold and account for the unclaimed money fund as
- 4 educational and general funds of the institution. If the fund
- 5 balance is insufficient to pay a valid claim, the institution shall
- 6 pay the claim from the institution's other educational and general
- 7 funds.
- 8 <u>(d) Each fiscal year, after deducting funds sufficient to</u>
- 9 pay anticipated expenses of and claims against the unclaimed money
- 10 fund, the institution shall use the balance of the fund as other
- 11 educational and general funds of the institution.
- 12 (e) In consultation with institutions of higher education,
- 13 the comptroller by rule may establish minimum requirements for
- 14 notice to owners of unclaimed money deposited in the unclaimed
- 15 money fund and for charges for that notice. The rules may not
- 16 provide stricter requirements than the comptroller applies for
- 17 amounts of less than \$25 in the custody of the comptroller under
- 18 Chapter 74, Property Code.
- 19 (f) If an institution of higher education maintains an
- 20 unclaimed money fund under this section, Chapter 74, Property Code,
- 21 does not apply to a credit balance to which this section applies.
- Sec. 51.012. PAYMENTS BY ELECTRONIC FUNDS TRANSFER OR
- 23 ELECTRONIC PAY CARD. An institution of higher education may make
- 24 any payment, including a payment of salary or wages, through
- 25 electronic funds transfer or by electronic pay card.
- SECTION 1.03. Section 65.42, Education Code, is amended to
- 27 read as follows:

- 1 Sec. 65.42. DELINQUENT ACCOUNTS; VENUE. A suit by The
- 2 University of Texas System on its own behalf or on behalf of a
- 3 component institution of The University of Texas System to recover
- 4 a delinquent loan, account, or debt owed to The University of Texas
- 5 System or a component institution of The University of Texas System
- 6 must [may] be brought in Travis County.
- 7 SECTION 1.04. Section 1231.001, Government Code, is amended
- 8 by amending Subdivision (2) and adding Subdivision (3) to read as
- 9 follows:
- 10 (2) "State security" means:
- 11 (A) an obligation, including a bond, issued by:
- 12 (i) a state agency;
- 13 (ii) an entity that is expressly created by
- 14 statute and has statewide jurisdiction; or
- 15 (iii) an entity issuing the obligation on
- 16 behalf of this state or on behalf of an entity described by
- 17 Subparagraph (i) or (ii);
- 18 (B) an installment sale or lease-purchase
- 19 obligation that is issued by or on behalf of an entity described by
- 20 Paragraph (A) and that has:
- 21 (i) a stated term of more than five years;
- 22 or
- 23 (ii) an initial principal amount of more
- 24 than \$250,000; or
- (C) an obligation, including a bond, that is
- 26 issued under Chapter 53, Education Code, at the request of or for

- 7 Sec. 1231.041. APPROVAL OF STATE SECURITY. (a) Except as
- 8 otherwise provided by this section, an [An] entity, including a
- 9 state agency, may not issue a state security unless:
- 10 (1) the board approves the issuance; or
- 11 (2) the security is exempted under <u>law</u>, including a
- 12 board rule adopted under Section 1231.022(2).
- 13 (b) A state security issued by an institution of higher
- 14 education, or issued at the request of or for the benefit of an
- 15 institution of higher education, is not subject to board approval
- 16 unless the general revenue of the state is pledged to the payment of
- 17 the security.
- SECTION 1.06. Section 74.001, Property Code, is amended by
- 19 adding Subsection (c) to read as follows:
- 20 (c) This chapter does not apply to small credit balances
- 21 held by an institution of higher education in an unclaimed money
- 22 fund under Section 51.011, Education Code.
- SECTION 1.07. Section 51.011, Education Code, as added by
- 24 this Act, applies to credit balances held by a public institution of
- 25 higher education on or after the effective date of this Act.
- 26 ARTICLE 2. GOODS AND SERVICES
- SECTION 2.01. Section 51.923, Education Code, is amended to

- 2 Sec. 51.923. QUALIFICATIONS OF CERTAIN BUSINESS ENTITIES TO
- 3 ENTER INTO CONTRACTS WITH AN INSTITUTION OF HIGHER EDUCATION. (a)

- 16 (4) "Nonprofit corporation" means any organization
- 17 exempt from federal income tax under Section 501 of the Internal

- 20 (b) A nonprofit corporation is not disqualified from
- 21 entering into a contract or other transaction with an institution
- 22 of higher education even though one or more members of the governing
- 23 board of the institution of higher education also serves as a
- 24 member, [or] director, officer, or employee of the nonprofit
- 25 corporation.
- 26 (c) A <u>business entity</u> [<del>corporation</del>] is not disqualified
- 27 from entering into a contract or other transaction with an

- 1 institution of higher education even though one or more members of
- 2 the governing board of the institution of higher education have an
- 3 interest in the business entity, subject to Subsection (d) [also
- 4 serves as a stockholder or director of the corporation provided
- 5 that no member of the governing board owns or has a beneficial
- 6 interest in more than five percent of the corporation's outstanding
- 7 capital stock and further provided that the contract or transaction
- 8 <del>is:</del>

- 9 [(1) an affiliation, licensing, or sponsored research
- 10 agreement; or
- 11 [(2) awarded by competitive bidding or competitive
- 12 sealed proposals].
- 13 (d) An institution of higher education is not prohibited
- 14 from entering into a contract or other transaction with a business
- 15 entity in which a member of the governing board of the institution
- 16 of higher education has an interest if the interest is not a
- 17 substantial interest or, if the interest is a substantial interest,
- 18 the [described in this section if any] board member [having an

interest described in this section in the contract or transaction

- 20 discloses that interest in a meeting held in compliance with
- 21 Chapter 551, Government Code, and refrains from voting on the
- 22 contract or transaction requiring board approval. Any such
- 23 contract or transaction requiring board approval must be approved
- 24 by an affirmative majority of the board members voting on the
- 25 contract or transaction.
- (e) For purposes of this section, a member of a governing
- 27 board has a substantial interest in a business entity if:

- 1 (1) the member owns 10 percent or more of the voting
- 2 stock or shares of the business entity or owns either 10 percent or
- 3 more or \$15,000 or more of the fair market value of the business
- 4 entity;
- 5 (2) funds received by the member from the business
- 6 entity exceed 10 percent of the member's gross income for the
- 7 previous year;
- 8 (3) the member is an officer of the business entity or
- 9 a member of the governing board of the business entity; or
- 10 (4) an individual related to the member in the first
- 11 degree by consanguinity or affinity, as determined under Chapter
- 12 573, Government Code, has an interest in the business entity as
- described by Subdivision (1), (2), or (3).
- 14 (f) A violation of this section does not render an action of
- 15 the governing board voidable unless the contract or transaction
- 16 that was the subject of the action would not have been approved by
- 17 the governing board without the vote of the member who violated this
- 18 section.
- 19 SECTION 2.02. Section 51.9335, Education Code, is amended
- 20 by amending Subsections (d) and (f) and adding Subsections (g) and
- 21 (h) to read as follows:
- 22 (d) Subtitle D, Title 10, Government Code, and Subchapter B,
- 23 Chapter 2254, Government Code, do not apply to the acquisition of
- 24 goods and services under this section, except that an institution
- 25 must comply with any provision of those laws, or a rule adopted
- 26 under a provision of those laws, [To the extent of any conflict,
- 27 this section prevails over any other law, including Chapters 2155,

- 1 2156, 2157, 2158, 2167, and 2170, Government Code, except a law or
- 2 rule] relating to contracting with historically underutilized
- 3 businesses or relating to the procurement of goods and services
- 4 from persons with disabilities. An institution of higher education
- 5 may, but is not required to, acquire goods or services as provided
- 6 by <u>Subtitle D, Title 10</u> [<del>Chapters 2155, 2156, 2157, 2158, 2167, and</del>
- 7 2170], Government Code.
- 8 (f) This section does not apply to professional services as
- 9 defined by Section 2254.002, Government Code. Professional
- 10 services shall be procured in accordance with Subchapter A, Chapter
- 11 2254, Government Code.
- 12 (g) An institution of higher education may adopt rules and
- 13 procedures for the acquisition of goods or services.
- 14 (h) In any contract for the acquisition of goods and
- 15 services to which an institution of higher education is a party, a
- 16 provision required by applicable law to be included in the contract
- 17 is considered to be a part of the executed contract without regard
- 18 <u>to:</u>
- 19 (1) whether the provision appears on the face of the
- 20 contract; or
- 21 (2) whether the contract includes any provision to the
- 22 contrary.
- SECTION 2.03. Subchapter Z, Chapter 51, Education Code, is
- 24 amended by adding Sections 51.9336 and 51.9337 to read as follows:
- Sec. 51.9336. ELECTRONIC AND DIGITAL SIGNATURES. (a) An
- 26 <u>institution of higher education or university system</u>, as those
- 27 terms are defined by Section 61.003, shall determine whether, and

- 11 RESOURCE TECHNOLOGIES. (a) In this section, "institution of
- 12 higher education" and "university system" have the meanings
- 13 assigned by Section 61.003.
- 14 (b) Section 2054.119, Government Code, does not apply to an
- 15 interagency contract for information resources technologies
- 16 between two or more institutions of higher education or between an
- 17 institution of higher education or university system and one or
- 18 more state agencies, institutions of higher education, or
- 19 university systems.
- SECTION 2.04. Section 51.966, Education Code, is amended by
- 21 amending Subsection (c) and adding Subsection (d) to read as
- 22 follows:
- 23 (c) <u>Section 612.002(b)</u>, <u>Government Code</u>, <u>does not apply to</u>
- 24 an institution of higher education or university system purchasing
- 25 insurance under this section.
- 26 (d) In [As used in] this section, "governing board," [and]
- 27 "institution of higher education," and "university system" have the

- 1 meanings assigned by Section 61.003.
- 2 SECTION 2.05. Subchapter C, Chapter 791, Government Code,
- 3 is amended by adding Section 791.035 to read as follows:
- 4 Sec. 791.035. CONTRACTS WITH INSTITUTIONS OF HIGHER
- 5 EDUCATION OR UNIVERSITY SYSTEMS. (a) A local government and an

- 4 Sec. 51.9611. PAYROLL DEDUCTIONS FOR EMPLOYEES OF
- 5 UNIVERSITY SYSTEM OR INSTITUTION OF HIGHER EDUCATION. (a) In this
- 6 section, "institution of higher education" and "university system"
- 7 have the meanings assigned by Section 61.003.
- 8 (b) The governing board of a university system, or of an

- 25 fee to cover the costs of making a deduction.
- SECTION 3.02. Section 1601.004(a), Insurance Code, is

- 1 (a) In this chapter, "dependent," with respect to an 2 individual eligible to participate in the uniform program under
- 3 Section 1601.101 or 1601.102, means the individual's:
- 4 (1) spouse;
- 5 (2) unmarried child younger than 25 years of age; and
- 6 (3) child of any age who the system determines lives
  7 with or has the child's care provided by the individual on a regular
- 8 basis if the child is mentally retarded or physically incapacitated
- 9 to the extent that the child is dependent on the individual for care

- 12 child's coverage under this chapter has not lapsed, and the child
- 13 was enrolled as a participant in the health benefits coverage under

- 16 eligible to participate as an employee under Section 1601.101, at
- 17 the time of the individual's initial enrollment in health benefits
- 18 coverage under the uniform program the child is at least 25 years of
- 19 age and is enrolled in comparable coverage, as determined by the
- 20 system, under the individual's previous health benefits coverage.
- SECTION 3.03. Subchapter C, Chapter 1601, Insurance Code,
- 22 is amended by adding Section 1601.111 to read as follows:
- 23 <u>Sec. 1601.111. PROGRAMS PROMOTING DISEASE PREVENTION,</u>
- 24 WELLNESS, AND HEALTH. A system may establish premium discounts,
- 25 <u>surcharges</u>, rebates, or a revision in otherwise applicable
- 26 copayments, coinsurance, or deductibles, or any combination of
- 27 those incentives, for an individual who participates in

- 1 system-approved programs promoting disease prevention, wellness,
- 2 and health.
- 3 SECTION 3.04. Section 1601.201(d), Insurance Code, is
- 4 amended to read as follows:
- 5 (d) Subsection (c) does not prohibit a system from
- 6 contributing, from money not appropriated from the general revenue
- 7 fund, amounts in excess of the amount specified by that subsection
- 8 for:
- 9 <u>(1)</u> an individual employed by the system in a position
- 10 that as a condition of employment requires the individual to be
- 11 enrolled as a student in the system in graduate level courses; or
- 12 (2) an individual who is a tenured faculty member with
- 13 whom the system has entered into a phased retirement agreement
- 14 under which the individual will work less than 40 hours a week for a
- 15 specified period of time at the end of which the individual will
- 16 <u>retire</u>.
- 17 ARTICLE 4. REAL ESTATE AND CONSTRUCTION
- SECTION 4.01. Section 51.951(a), Education Code, is amended
- 19 to read as follows:
- 20 (a) Information related to the <u>development</u>, location,
- 21 purchase price, or sale price of real property developed,
- 22 purchased, or sold by or for an institution of higher education, as
- 23 defined by Section 61.003, including a contract provision related
- 24 to the development, purchase, or sale of the property, is
- 25 confidential and exempt from disclosure under Chapter 552,
- 26 Government Code, until all deeds for the property that are
- 27 applicable to the transaction or series of related transactions are

- 1 executed and until all substantive performance or executor
- 2 requirements of applicable contracts have been satisfied [a deed
- 3 for the property is executed]. Information that is confidential
- 4 and exempted from disclosure under this subsection includes an
- 5 appraisal, completed report, evaluation, investigation conducted
- 6 for the purpose of locating or determining the purchase or sale
- 7 price of the property, or any report prepared in anticipation of
- 8 purchasing or selling real property.
- 9 SECTION 4.02. Subchapter C, Chapter 61, Education Code, is
- 10 amended by adding Section 61.0573 to read as follows:
- 11 Sec. 61.0573. PROJECTS EXEMPT FROM BOARD APPROVAL. (a) In
- 12 this section, "project" means the acquisition of improved or
- 13 unimproved real property or the construction, repair, or
- 14 rehabilitation of a building or other facility.
- 15 (b) Board approval of a project at an institution of higher
- 16 <u>education is not required under Section 61.0572 or 61.058 if the</u>
- 17 institution notifies the board of the project and certifies to the
- 18 board that:
- 19 (1) the institution meets the current published board
- 20 standards applicable to the institution for space need, usage
- 21 <u>efficiency</u>, <u>deferred</u> <u>maintenance</u>, <u>and critical deferred</u>
- 22 maintenance or the board has approved the institution's plan to
- 23 correct any deficiencies in the institution's compliance with those
- 24 applicable standards;
- 25 (2) the project meets current published board
- 26 standards applicable to the project for cost, efficiency, and space
- 27 use;

- 1 (3) the project is identified on the institution's
- 2 campus master plan, as submitted to the board; and
- 3 (4) the institution has no deficiencies according to
- 4 the board's most recent facilities audit or the board has approved
- 5 the institution's plan to correct any such deficiencies.
- 6 (c) The board's staff shall promptly review a certification
- 7 submitted under Subsection (b) and notify the institution whether
- 8 the certification is sufficient and whether the information
- 9 certified is consistent with the records of the board. If the staff
- 10 review determines that the certification is sufficient and that the
- 11 information certified is consistent with the records of the board,
- 12 the project is considered approved by the board.
- 13 (d) This section does not apply to a project that is a new
- 14 branch campus, a new higher education unit, or a new higher
- 15 <u>education center.</u>
- SECTION 4.03. Section 2166.302(c), Government Code, is
- 17 amended to read as follows:
- 18 (c) Subsection (a) does not apply to a project constructed
- 19 by and for the Texas Department of Transportation or an institution
- 20 of higher education or university system. In this subsection,
- 21 "institution of higher education" and "university system" have the
- 22 meanings assigned by Section 61.003, Education Code.
- SECTION 4.04. Section 2166.403(c-1), Government Code, is
- 24 amended to read as follows:
- 25 (c-1) For a project constructed by and for a state
- 26 institution of higher education, the [governing body of the]
- 27 institution shall, during the planning phase of the proposed

- 1 construction for the project, verify [in an open meeting] the
- 2 economic feasibility of incorporating into the building's design
- 3 and proposed energy system alternative energy devices for space
