11	(1) "Charitable organization" means an organization
12	that is exempt from federal income tax under Section 501(a),
13	Internal Revenue Code of 1986, by being listed as an exempt
14	organization in Section 501(c) of that code. The term does not
15	include a property owners' or homeowners' association.
16	(2) "Grant-making organization" means an organization
17	that makes grants to charitable organizations but is not a private
18	foundation, private foundation trust, or split interest trust.
19	(3) "Private foundation" has the meaning assigned by
20	Section 509(a), Internal Revenue Code of 1986.
21	(4) "Split interest trust" means an irrevocable trust
22	in which the income is first dispersed to the beneficiaries of the
23	trust for a specified period and the remainder of the trust is
24	donated to a designated charity.

2 SECTION 2. Section 2252.906, Government Code, as added by 3 this Act, does not apply to or invalidate a contract in effect 4 before the effective date of this Act.

5 SECTION 3. This Act takes effect September 1, 2011.
