A BILL TO BE ENTITLED

1	AN ACT
2	relating to the Lower Colorado River Authority.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Chapter 8503, Special District Local Laws Code,
5	is amended by adding Section 8503.0031 to read as follows:
6	Sec. 8503.0031. APPLICATION OF SUNSET ACT. (a) The
7	authority is subject to review under Chapter 325, Government Code
8	(Texas Sunset Act), as if it were a state agency but is not
9	abolished under that chapter.
10	(b) The authority shall be reviewed during the period in
11	which state agencies scheduled to be reviewed or abolished in 2013
12	and every 12th year after that year are reviewed.
13	SECTION 2. Sections 8503.006(a), (c), (f), (g), and (h),
14	Special District Local Laws Code, are amended to read as follows:
15	(a) The powers, rights, privileges, and functions of the
16	authority shall be exercised by the board. The board shall consist
17	of 15 directors appointed as follows:
18	(1) the commissioners court of each county named in
19	Section 8503.003 shall appoint one director from that county; and
20	(2) the governor, with the advice and consent of the
21	senate, shall appoint:
22	(A) one director from Travis County;
23	(B) one director from the counties named in

Section 8503.003 other than Travis County; and

- (C) three directors [and shall include at least one director from each of the counties named in Section 8503.003 except Travis County, which shall have two directors. Three directors shall be appointed] at large from the counties served with electric power, other than the counties named [included] in Section 8503.003.
- 7 (c) All directors shall be appointed [by the governor with 8 the advice and consent of the senate] for staggered terms of six 9 years, with five directors' [members'] terms expiring on February 1 of each odd-numbered year.
- 11 (f) At the expiration of the term of a director, a successor
 12 shall be appointed in the manner provided by this section [by the
 13 governor with the advice and consent of the senate]. Each director
 14 shall hold office until the expiration of the term for which the
 15 director was appointed and until a successor has been appointed and
 16 has qualified, unless removed sooner as provided by this section.
- 17 (g) The entity that appointed a director may remove the [A]
 18 director [may be removed by the governor] for inefficiency, neglect
 19 of duty, or misconduct in office after at least 30 days' written
 20 notice of the charges against the director and an opportunity to be
 21 heard in person or by counsel at a public hearing.
- (h) A [The governor shall appoint a person to fill a] vacancy on the board shall be filled for the unexpired term in the manner provided by this section for the original appointment.
- 25 SECTION 3. Section 8503.007(a), Special District Local Laws 26 Code, is amended to read as follows:
- 27 (a) The board shall elect one of their number [governor

- 2 and [to serve in that capacity at the pleasure of the governor. The
- 3 board shall elect] one of their number as an assistant presiding
- 4 officer.
- 5 SECTION 4. Chapter 8503, Special District Local Laws Code,
- 6 is amended by adding Section 8503.032 to read as follows:
- 7 Sec. 8503.032. WATER PRESSURE SAFETY STANDARDS. In
- 8 accordance with commission rules for public water systems, the
- 9 authority shall ensure that for any area in which the authority owns
- 10 or operates the local water supply system, the water pressure for
- 11 service to fire hydrants in the area is adequate to protect public
- 12 safety.
- 13 SECTION 5. (a) The change in law made by this Act does not
- 14 affect the term of a member of the board of directors of the Lower
- 15 Colorado River Authority serving on the effective date of this Act.
- 16 Members appointed to fill vacancies occurring on or after the
- 17 effective date of this Act must be appointed in accordance with
- 18 Section 8503.006, Special District Local Laws Code, as amended by
- 19 this Act.
- 20 (b) The change in law made by this Act does not prohibit a
- 21 person who is a member of the Lower Colorado River Authority board
- 22 of directors before the effective date of this Act from being
- 23 appointed as a member of the board of directors under the new
- 24 composition of the board of directors if the person has the
- 25 qualifications required for the position under Section 8503.006,
- 26 Special District Local Laws Code, as amended by this Act.
- 27 SECTION 6. (a) The legal notice of the intention to

- 1 introduce this Act, setting forth the general substance of this
- 2 Act, has been published as provided by law, and the notice and a
- 3 copy of this Act have been furnished to all persons, agencies,
- 4 officials, or entities to which they are required to be furnished
- 5 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 6 Government Code.
- 7 (b) The governor, one of the required recipients, has
- 8 submitted the notice and Act to the Texas Commission on
- 9 Environmental Quality.
- 10 (c) The Texas Commission on Environmental Quality has filed
- 11 its recommendations relating to this Act with the governor, the
- 12 lieutenant governor, and the speaker of the house of
- 13 representatives within the required time.
- 14 (d) All requirements of the constitution and laws of this
- 15 state and the rules and procedures of the legislature with respect
- 16 to the notice, introduction, and passage of this Act are fulfilled
- 17 and accomplished.
- SECTION 7. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2011.
