(a) The civil and political rights of a person who resides inside 13 14 the boundaries of Big Bend National Park or the Rio Grande Wild and Scenic River are preserved and are not impaired by this state's 15 16 acceptance of concurrent jurisdiction under Section 23.051. (b) This section expires September 1, 2012, unless the 17 governor has received written acceptance of concurrent 18 jurisdiction under Section 23.051(b) by that date. 19 Sec. 23.003. RETROCESSION OF CONCURRENT JURISDICTION. (a) 20 21 Simultaneously with the cession of concurrent jurisdiction under Section 23.051, the governor, on behalf of the state, shall accept 22 23 from an authorized official of the National Park Service, United

shall send a copy of this Act to an authorized official of the
National Park Service, United States Department of the Interior, to
request consideration and acceptance of the changes in jurisdiction
proposed in this Act.

5 (b) If the governor receives written confirmation from an 6 authorized official of the National Park Service, United States 7 Department of the Interior, that the National Park Service accepts 8 the changes in jurisdiction made by this Act, the governor shall 9 implement Section 23.051(c), Parks and Wildlife Code, as added by 10 this Act.

SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2011.
