A BILL TO BE ENTITLED 1 AN ACT 2 relating to the date on which certain payments are made by the state 3 under the Foundation School Program. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Sections 42.259(c), (d), and (f), Education 5 Code, are amended to read as follows: 6 7 (c) Payments from the foundation school fund to each category 2 school district shall be made as follows: 8 9 (1)22 percent of the yearly entitlement of the district shall be paid in an installment to be made on or before the 10 11 25th day of September of a fiscal year; 12 (2) 18 percent of the yearly entitlement of the 13 district shall be paid in an installment to be made on or before the 14 25th day of October; (3) 9.5 percent of the yearly entitlement of the 15 16 district shall be paid in an installment to be made on or before the 25th day of November; 17 18 (4) 7.5 percent of the yearly entitlement of the district shall be paid in an installment to be made on or before the 19 20 25th day of April; 21 (5) five percent of the yearly entitlement of the 22 district shall be paid in an installment to be made on or before the 23 25th day of May; 10 percent of the yearly entitlement of 24 (6) the

district shall be paid in an installment to be made on or before the
 25th day of June;

3 (7) 13 percent of the yearly entitlement of the 4 district shall be paid in an installment to be made on or before the 5 25th day of July; and

6 (8) 15 percent of the yearly entitlement of the 7 district shall be paid in an installment to be made <u>after the 5th</u> 8 <u>day of September and not later than the 10th day of September of the</u> 9 <u>calendar year following the calendar year of the payment made under</u> 10 <u>Subdivision (1)</u> [on or before the 25th day of August].

11 (d) Payments from the foundation school fund to each 12 category 3 school district shall be made as follows:

(1) 45 percent of the yearly entitlement of the district shall be paid in an installment to be made on or before the 25th day of September of a fiscal year;

16 (2) 35 percent of the yearly entitlement of the 17 district shall be paid in an installment to be made on or before the 18 25th day of October; and

(3) 20 percent of the yearly entitlement of the district shall be paid in an installment to be made <u>after the 5th</u> <u>day of September and not later than the 10th day of September of the</u> <u>calendar year following the calendar year of the payment made under</u> <u>Subdivision (1)</u> [on or before the 25th day of August].

(f) Except as provided by Subsection (c)(8) or (d)(3), any
[Any] previously unpaid additional funds from prior <u>fiscal</u> years
owed to a district shall be paid to the district together with the
September payment of the current <u>fiscal</u> year entitlement.

1 SECTION 2. Section 466.355(c), Government Code, is
2 repealed.

3 SECTION 3. The changes made by this Act to Section 42.259, 4 Education Code, apply only to a payment from the foundation school 5 fund that is made on or after the effective date of this Act. A 6 payment to a school district from the foundation school fund that is 7 made before that date is governed by Section 42.259, Education 8 Code, as it existed before amendment by this Act, and the former law 9 is continued in effect for that purpose.
