

1 AN ACT

2 relating to the creation of the Cottonwood Municipal Utility
3 District No. 2 of Grayson County; providing authority to impose a
4 tax and issue bonds; granting a limited power of eminent domain.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subtitle F, Title 6, Special District Local Laws
7 Code, is amended by adding Chapter 8309 to read as follows:

8 CHAPTER 8309. COTTONWOOD MUNICIPAL UTILITY DISTRICT NO. 2 OF
9 GRAYSON COUNTY

10 SUBCHAPTER A. GENERAL PROVISIONS

11 Sec. 8309.001. DEFINITIONS. In this chapter:

12 (1) "Board" means the district's board of directors.

13 (2) "Commission" means the Texas Commission on
14 Environmental Quality.

15 (3) "Director" means a board member.

16 (4) "District" means the Cottonwood Municipal Utility
17 District No. 2 of Grayson County.

18 Sec. 8309.002. NATURE OF DISTRICT. The district is a
19 municipal utility district created under Section 59, Article XVI,
20 Texas Constitution.

21 Sec. 8309.003. CONFIRMATION AND DIRECTORS' ELECTION
22 REQUIRED. The temporary directors shall hold an election to
23 confirm the creation of the district and to elect five permanent
24 directors as provided by Section 49.102, Water Code.

1 Sec. 8309.004. CONSENT OF MUNICIPALITY REQUIRED. The
2 temporary directors may not hold an election under Section 8309.003
3 until each municipality in whose corporate limits or
4 extraterritorial jurisdiction the district is located has
5 consented by ordinance or resolution to the creation of the
6 district and to the inclusion of land in the district.

7 Sec. 8309.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
8 The district is created to serve a public purpose and benefit.

9 (b) The district is created to accomplish the purposes of:

10 (1) a municipal utility district as provided by
11 general law and Section 59, Article XVI, Texas Constitution; and

12 (2) Section 52, Article III, Texas Constitution, that
13 relate to the construction, acquisition, improvement, operation,
14 or maintenance of macadamized, graveled, or paved roads, or
15 improvements, including storm drainage, in aid of those roads.

16 Sec. 8309.006. INITIAL DISTRICT TERRITORY. (a) The
17 district is initially composed of the territory described by
18 Section 2 of the Act enacting this chapter.

19 (b) The boundaries and field notes contained in Section 2 of
20 the Act enacting this chapter form a closure. A mistake made in the
21 field notes or in copying the field notes in the legislative process
22 does not affect the district's:

23 (1) organization, existence, or validity;

24 (2) right to issue any type of bond for the purposes
25 for which the district is created or to pay the principal of and
26 interest on a bond;

27 (3) right to impose a tax; or

1 (4) legality or operation.

2 Sec. 8309.007. ELIGIBILITY FOR INCLUSION IN TAX INCREMENT
3 REINVESTMENT ZONE. (a) The district is eligible to be included in
4 a tax increment reinvestment zone created under Chapter 311, Tax
5 Code.

6 (b) If the City of Dorchester creates a tax increment
7 reinvestment zone described by Subsection (a) that includes all or
8 part of the territory of the district, the City of Dorchester and
9 the board of directors of the zone, by contract with the district,
10 may grant money to the district from the tax increment fund to be
11 used for a permissible purpose of the district, including the right
12 to pledge the money as security for a bond or other obligation
13 issued by the district and for any permissible purpose of a
14 corporation under Section 380.002(b), Local Government Code.

16 SUBCHAPTER B. BOARD OF DIRECTORS

17 Sec. 8309.051. GOVERNING BODY; TERMS. (a) The district is
18 governed by a board of five elected directors.

19 (b) Except as provided by Section 8309.052, directors serve
20 staggered four-year terms.

21 Sec. 8309.052. TEMPORARY DIRECTORS. (a) On or after
22 September 1, 2011, the owner or owners of a majority of the assessed
23 value of the real property in the district may submit a petition to
24 the commission requesting that the commission appoint as temporary
25 directors the five persons named in the petition. The commission
26 shall appoint as temporary directors the five persons named in the
27 petition.

1 (b) Temporary directors serve until the earlier of:

2 (1) the date permanent directors are elected under
3 Section 8309.003; or

4 (2) September 1, 2015.

5 (c) If permanent directors have not been elected under
6 Section 8309.003 and the terms of the temporary directors have
7 expired, successor temporary directors shall be appointed or
8 reappointed as provided by Subsection (d) to serve terms that
9 expire on the earlier of:

10 (1) the date permanent directors are elected under
11 Section 8309.003; or

12 (2) the fourth anniversary of the date of the
13 appointment or reappointment.

14 (d) If Subsection (c) applies, the owner or owners of a
15 majority of the assessed value of the real property in the district
16 may submit a petition to the commission requesting that the
17 commission appoint as successor temporary directors the five
18 persons named in the petition. The commission shall appoint as
19 successor temporary directors the five persons named in the
20 petition.

21 [Sections 8309.053-8309.100 reserved for expansion]

22 SUBCHAPTER C. POWERS AND DUTIES

23 Sec. 8309.101. GENERAL POWERS AND DUTIES. The district has
24 the powers and duties necessary to accomplish the purposes for
25 which the district is created.

26 Sec. 8309.102. MUNICIPAL UTILITY DISTRICT POWERS AND
27 DUTIES. The district has the powers and duties provided by the

1 general law of this state, including Chapters 49 and 54, Water Code,
2 applicable to municipal utility districts created under Section 59,
3 Article XVI, Texas Constitution.

4 Sec. 8309.103. AUTHORITY FOR ROAD PROJECTS. Under Section
5 52, Article III, Texas Constitution, the district may design,
6 acquire, construct, finance, issue bonds for, improve, operate,
7 maintain, and convey to this state, a county, or a municipality for
8 operation and maintenance macadamized, graveled, or paved roads, or
9 improvements, including storm drainage, in aid of those roads.

10 Sec. 8309.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road
11 project must meet all applicable construction standards, zoning and
12 subdivision requirements, and regulations of each municipality in
13 whose corporate limits or extraterritorial jurisdiction the road
14 project is located.

15 (b) If a road project is not located in the corporate limits
16 or extraterritorial jurisdiction of a municipality, the road
17 project must meet all applicable construction standards,
18 subdivision requirements, and regulations of each county in which
19 the road project is located.

20 (c) If the state will maintain and operate the road, the
21 Texas Transportation Commission must approve the plans and
22 specifications of the road project.

23 Sec. 8309.105. COSTS OF ROAD PROJECT. The district shall
24 bear the cost of maintaining, improving, operating, and repairing a
25 road located in the district and authorized by Section 8309.103 in
26 accordance with all applicable ordinances and rules of the
27 political subdivision authorized to exercise jurisdiction over the

1 road, regardless of whether the district conveys the road to this
2 state, a county, or a municipality.

3 Sec. 8309.106. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
4 OR RESOLUTION. (a) The district shall comply with all applicable
5 requirements of any ordinance or resolution that is adopted under
6 Section 54.016 or 54.0165, Water Code, and that consents to the
7 creation of the district or to the inclusion of land in the
8 district.

9 (b) In addition to all the rights and remedies provided by
10 other law, if the district violates the terms of an ordinance or
11 resolution described by Subsection (a), the municipality is
12 entitled to injunctive relief or a writ of mandamus issued by a
13 court requiring the district and the district's officials to
14 observe and comply with the terms of the ordinance or resolution.

15 Sec. 8309.107. MUNICIPAL CONSENT. Municipal consent to the
16 creation of the district and to the inclusion of land in the
17 district granted under Section 8309.004 acts as municipal consent
18 to the creation of any new district created by the division of the
19 district and to the inclusion of land in the new district.

20 Sec. 8309.108. EFFECT OF ANNEXATION BY CITY OF DORCHESTER.
21 Notwithstanding Section 54.016(f)(2), Water Code, an allocation
22 agreement between the City of Dorchester and the district that
23 provides for the allocation of the taxes or revenues of the district
24 and the city following the date of inclusion of all the district's
25 territory in the corporate limits of the city may provide that the
26 total annual ad valorem taxes collected by the city and the district
27 from taxable property in the district may exceed the city's ad

1 valorem tax on that property.

2 Sec. 8309.109. LIMITATION ON USE OF EMINENT DOMAIN. The
3 district may not exercise the power of eminent domain outside the
4 district to acquire a site or easement for:

- 5 (1) a road project authorized by Section 8309.103; or
6 (2) a recreational facility as defined by Section
7 49.462, Water Code.

8 [Sections 8309.110-8309.150 reserved for expansion]

9 SUBCHAPTER D. DIVISION OF DISTRICT INTO MULTIPLE DISTRICTS

10 Sec. 8309.151. DIVISION OF DISTRICT; PREREQUISITES. The
11 district may be divided into two or more new districts only if the
12 district:

- 13 (1) has never issued any bonds; and
14 (2) is not imposing ad valorem taxes.

15 Sec. 8309.152. LAW APPLICABLE TO NEW DISTRICT. This
16 chapter applies to any new district created by division of the
17 district, and a new district has all the powers and duties of the
18 district.

19 Sec. 8309.153. LIMITATION ON AREA OF NEW DISTRICT. A new
20 district created by the division of the district may not, at the
21 time the new district is created, contain any land outside the area
22 described by Section 2 of the Act enacting this chapter.

23 Sec. 8309.154. DIVISION PROCEDURES. (a) The board, on its
24 own motion or on receipt of a petition signed by the owner or owners
25 of a majority of the assessed value of the real property in the
26 district, may adopt an order dividing the district.

27 (b) The board may adopt an order dividing the district

1 before or after the date the board holds an election under Section
2 8309.003 to confirm the district's creation.

3 (c) An order dividing the district must:

4 (1) name each new district;

5 (2) include the metes and bounds description of the
6 territory of each new district;

7 (3) appoint temporary directors for each new district;

8 and

9 (4) provide for the division of assets and liabilities
10 between the new districts.

11 (d) On or before the 30th day after the date of adoption of
12 an order dividing the district, the district shall file the order
13 with the commission and record the order in the real property
14 records of each county in which the district is located.

15 Sec. 8309.155. CONFIRMATION ELECTION FOR NEW DISTRICT. (a)
16 A new district created by the division of the district shall hold a
17 confirmation and directors' election as required by Section
18 8309.003.

19 (b) If the creation of the new district is confirmed, the
20 new district shall provide the election date and results to the
21 commission.

22 Sec. 8309.156. TAX OR BOND ELECTION. Before a new district
23 created by the division of the district may impose a maintenance tax
24 or issue bonds payable wholly or partly from ad valorem taxes, the
25 new district must hold an election as required by this chapter to
26 obtain voter approval.

27 [Sections 8309.157-8309.200 reserved for expansion]

1 SUBCHAPTER E. GENERAL FINANCIAL PROVISIONS

2 Sec. 8309.201. ELECTIONS REGARDING TAXES OR BONDS. (a) The
3 district may issue, without an election, bonds and other
4 obligations secured by:

5 (1) revenue other than ad valorem taxes; or

6 (2) contract payments described by Section 8309.203.

7 (b) The district must hold an election in the manner
8 provided by Chapters 49 and 54, Water Code, to obtain voter approval
9 before the district may impose an ad valorem tax or issue bonds
10 payable from ad valorem taxes.

11 (c) The district may not issue bonds payable from ad valorem
12 taxes to finance a road project unless the issuance is approved by a
13 vote of a two-thirds majority of the district voters voting at an
14 election held for that purpose.

15 Sec. 8309.202. OPERATION AND MAINTENANCE TAX. (a) If
16 authorized at an election held under Section 8309.201, the district
17 may impose an operation and maintenance tax on taxable property in
18 the district in accordance with Section 49.107, Water Code.

19 (b) The board shall determine the tax rate. The rate may not
20 exceed the rate approved at the election.

21 Sec. 8309.203. CONTRACT TAXES. (a) In accordance with
22 Section 49.108, Water Code, the district may impose a tax other than
23 an operation and maintenance tax and use the revenue derived from
24 the tax to make payments under a contract after the provisions of
25 the contract have been approved by a majority of the district voters
26 voting at an election held for that purpose.

27 (b) A contract approved by the district voters may contain a

1 provision stating that the contract may be modified or amended by
2 the board without further voter approval.

3 [Sections 8309.204-8309.250 reserved for expansion]

4 SUBCHAPTER F. BONDS AND OTHER OBLIGATIONS

5 Sec. 8309.251. AUTHORITY TO ISSUE BONDS AND OTHER
6 OBLIGATIONS. The district may issue bonds or other obligations
7 payable wholly or partly from ad valorem taxes, impact fees,
8 revenue, contract payments, grants, or other district money, or any
9 combination of those sources, to pay for any authorized district
10 purpose.

11 Sec. 8309.252. TAXES FOR BONDS. At the time the district
12 issues bonds payable wholly or partly from ad valorem taxes, the
13 board shall provide for the annual imposition of a continuing
14 direct ad valorem tax, without limit as to rate or amount, while all
15 or part of the bonds are outstanding as required and in the manner
16 provided by Sections 54.601 and 54.602, Water Code.

17 Sec. 8309.253. BONDS FOR ROAD PROJECTS. At the time of
18 issuance, the total principal amount of bonds or other obligations
19 issued or incurred to finance road projects and payable from ad
20 valorem taxes may not exceed one-fourth of the assessed value of the
21 real property in the district.

22 SECTION 2. The Cottonwood Municipal Utility District No. 2

9 vote of two-thirds of all the members elected to each house, as
10 provided by Section 39, Article III, Texas Constitution; and

11 (2) if this Act does not receive the vote necessary for
12 immediate effect, this Act takes effect September 1, 2011.
