- 13 JUVENILE BOARD. (a) The McLennan County Juvenile Board may accept a
- 14 gift, grant, or donation from a public or private source for any
- 15 lawful purpose, including support of a local enrichment of juvenile
- 16 services program.
- 17 (b) The juvenile board shall place a donation of money under
- 18 <u>Subsection (a) in a special fund that is:</u>
- 19 <u>(1)</u> subject to all reporting or procedural
- 20 requirements of the county auditor; and
- 21 (2) audited annually by the county auditor.
- (c) Notwithstanding Subsection (b), the juvenile board is
- 23 not required to establish or adopt a budget for expenditures under
- 24 the special fund described by this section.

- 1 (d) The special fund described by Subsection (b) may be used
- 2 only to pay expenses of and related to programs, services, and items
- 3 approved by the juvenile board.
- 4 (e) An expenditure from the special fund described by
- 5 Subsection (b) must comply with the requirements of Chapter 262,
- 6 Local Government Code, that apply to the juvenile board's other
- 7 <u>expenditures.</u>
- 8 SECTION 2. This Act takes effect immediately if it receives
- 9 a vote of two-thirds of all the members elected to each house, as
- 10 provided by Section 39, Article III, Texas Constitution. If this
- 11 Act does not receive the vote necessary for immediate effect, this
- 12 Act takes effect September 1, 2011.
