A BILL TO BE ENTITLED

AN ACT
relating to the creation of the Bridgeland Management District;
providing authority to levy an assessment, impose a tax, and issue
bonds.
BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
SECTION 1. Subtitle C, Title 4, Special District Local Laws
Code, is amended by adding Chapter 3901 to read as follows:
CHAPTER 3901. BRIDGELAND MANAGEMENT DISTRICT
SUBCHAPTER A. GENERAL PROVISIONS
Sec. 3901.001. DEFINITIONS. In this chapter:
(1) "Board" means the district's board of directors.
(2) "City" means the City of Houston, Texas.
(3) "Commission" means the Texas Commission on
Environmental Quality.
(4) "County" means Harris County.
(5) "Director" means a board member.
(6) "District" means the Bridgeland Management
District.
Sec. 3901.002. CREATION AND NATURE OF DISTRICT. The
district is a special district created under Section 59, Article
XVI, Texas Constitution.
Sec. 3901.003. CONFIRMATION AND DIRECTORS' ELECTION
REQUIRED. The temporary directors shall hold an election to
confirm the creation of the district and to elect five permanent

- 1 <u>directors as provided by Section 49.102, Water Code.</u>
- 2 Sec. 3901.004. CONSENT OF MUNICIPALITY REQUIRED. The
- 3 temporary directors may not hold an election under Section 3901.003
- 4 until each municipality in whose corporate limits or
- 5 extraterritorial jurisdiction the district is located has
- 6 consented by ordinance or resolution to the creation of the
- 7 district and to the inclusion of land in the district.
- 8 Sec. 3901.005. PURPOSE; DECLARATION OF INTENT. (a) The
- 9 creation of the district is essential to accomplish the purposes of
- 10 Sections 52 and 52-a, Article III, and Section 59, Article XVI,
- 11 Texas Constitution, and other public purposes stated in this
- 12 chapter. By creating the district, the legislature has established
- 13 a program to accomplish the public purposes set out in Sections 52
- 14 and 52-a, Article III, Texas Constitution.
- 15 (b) The creation of the district is necessary to promote,
- 16 develop, encourage, and maintain employment, commerce,
- 17 transportation, housing, tourism, recreation, the arts,
- 18 entertainment, economic development, safety, and the public
- 19 welfare in the district.
- 20 (c) This chapter and the creation of the district may not be
- 21 interpreted to relieve the city, the county, or another
- 22 governmental entity from providing the level of services provided
- 23 as of the effective date of the Act enacting this chapter to the
- 24 area in the district. The district is created to supplement and not
- 25 to supplant governmental services provided in the district.
- Sec. 3901.006. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
- 27 The district is created to serve a public use and benefit.

- 1 (b) All land and other property included in the district
- 2 will benefit from the improvements and services to be provided by
- 3 the district under powers conferred by Sections 52 and 52-a,
- 4 Article III, and Section 59, Article XVI, Texas Constitution, and
- 5 other powers granted under this chapter.
- 6 (c) The creation of the district is in the public interest
- 7 and is essential to further the public purposes of:
- 8 (1) developing and diversifying the economy of the
- 9 state;
- 10 (2) eliminating unemployment and underemployment; and
- 11 (3) developing or expanding transportation and
- 12 commerce.
- 13 (d) The district will:
- 14 (1) promote the health, safety, and general welfare of
- 15 residents, employers, potential employees, employees, visitors,
- 16 and consumers in the district, and of the public;
- 17 (2) provide needed funding for the district to
- 18 preserve, maintain, and enhance the economic health and vitality of
- 19 the district territory as a community and business center; and
- 20 (3) promote the health, safety, welfare, and enjoyment
- 21 of the public by providing pedestrian ways, road facilities, and
- 22 recreational facilities and by landscaping and developing certain
- 23 areas, which are necessary for the restoration, preservation, and
- 24 enhancement of scenic beauty.
- (e) Pedestrian ways along or across a street, whether at
- 26 grade or above or below the surface, and street lighting, street
- 27 landscaping, parking, and street art objects are parts of and

- 1 necessary components of a street and are considered to be a street
- 2 or road improvement.
- 3 (f) The district will not act as the agent or
- 4 instrumentality of any private interest even though the district
- 5 will benefit many private interests as well as the public.
- 6 Sec. 3901.007. DISTRICT TERRITORY. (a) The district is
- 7 initially composed of the territory described by Section 2 of the
- 8 Act enacting this chapter, as that territory may have been modified
- 9 under Section 3901.114 or other law.
- 10 (b) The boundaries and field notes of the district contained
- 11 in Section 2 of the Act enacting this chapter form a closure. A
- 12 mistake in the field notes or in copying the field notes in the
- 13 legislative process does not affect the district's:
- 14 (1) organization, existence, or validity;
- 15 (2) right to issue any type of bond, note, or other
- 16 obligation for a purpose for which the district is created or to pay
- 17 the principal of and interest on the bond;
- 18 (3) right to impose or collect an assessment or tax; or
- 19 (4) legality or operation.
- Sec. 3901.008. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.
- 21 All or any part of the area of the district is eligible to be
- 22 included in:
- 23 <u>(1) a tax increment reinvestment zone created under</u>
- 24 Chapter 311, Tax Code;
- 25 (2) a tax abatement reinvestment zone created under
- 26 Chapter 312, Tax Code;
- 27 (3) an enterprise zone created under Chapter 2303,

- 1 Government Code; or
- 2 (4) an industrial district created under Chapter 42,
- 3 Local Government Code.
- 4 Sec. 3901.009. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 5 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 6 Chapter 375, Local Government Code, applies to the district.
- 7 Sec. 3901.010. LIBERAL CONSTRUCTION OF CHAPTER. This
- 8 chapter shall be liberally construed in conformity with the
- 9 findings and purposes stated in this chapter.
- Sec. 3901.011. CONFLICTS OF LAW. This chapter prevails
- 11 over any provision of general law, including a provision of Chapter
- 12 375, Local Government Code, that is in conflict or inconsistent
- 13 with this chapter.
- 14 [Sections 3901.012-3901.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 3901.051. GOVERNING BODY; TERMS. (a) The district is
- 17 governed by a board of five directors elected or appointed as
- 18 provided by this chapter and Subchapter D, Chapter 49, Water Code.
- 19 (b) Except as provided by Section 3901.053, directors serve
- 20 staggered four-year terms.
- 21 Sec. 3901.052. COMPENSATION. A director is entitled to
- 22 receive fees of office and reimbursement for actual expenses as
- 23 provided by Section 49.060, Water Code. Sections 375.069 and
- 24 375.070, Local Government Code, do not apply to the board.
- Sec. 3901.053. TEMPORARY DIRECTORS. (a) On or after the
- 26 effective date of the Act creating this chapter, the owner or owners
- 27 of a majority of the assessed value of the real property in the

- 1 district may submit a petition to the commission requesting that
- 2 the commission appoint as temporary directors the five persons
- 3 named in the petition. The commission shall appoint as temporary
- 4 directors the five persons named in the petition.
- 5 (b) Temporary directors serve until the earlier of:
- 6 (1) the date permanent directors are elected under
- 7 <u>Section 3901.003; or</u>
- 8 (2) the fourth anniversary of the effective date of
- 9 the Act creating this chapter.
- 10 (c) If permanent directors have not been elected under
- 11 Section 3901.003 and the terms of the temporary directors have
- 12 expired, successor temporary directors shall be appointed or
- 13 reappointed as provided by Subsection (d) to serve terms that
- 14 expire on the earlier of:
- 15 (1) the date permanent directors are elected under
- 16 <u>Section 3901.003; or</u>
- 17 (2) the fourth anniversary of the date of the
- 18 appointment or reappointment.
- 19 (d) If Subsection (c) applies, the owner or owners of a
- 20 majority of the assessed value of the real property in the district
- 21 may submit a petition to the commission requesting that the
- 22 commission appoint as successor temporary directors the five
- 23 persons named in the petition. The commission shall appoint as
- 24 successor temporary directors the five persons named in the
- 25 petition.
- 26 (e) This section expires September 1, 2019.
- 27 [Sections 3901.054-3901.100 reserved for expansion]

1 SUBCHAPTER C. POWERS AND DUTIES

- 2 Sec. 3901.101. GENERAL POWERS AND DUTIES. The district has
- 3 the powers and duties necessary to accomplish the purposes for
- 4 which the district is created.
- 5 Sec. 3901.102. IMPROVEMENT PROJECTS AND SERVICES. (a) The
- 6 district may provide, design, construct, acquire, improve,
- 7 relocate, operate, maintain, or finance an improvement project or
- 8 service using money available to the district, or contract with a
- 9 governmental or private entity to provide, design, construct,
- 10 acquire, improve, relocate, operate, maintain, or finance an
- 11 improvement project or service authorized under this chapter or
- 12 under Chapter 375, Local Government Code.
- (b) An improvement project described by Subsection (a) may
- 14 be located inside or outside the district.
- Sec. 3901.103. RECREATIONAL FACILITIES. The district may
- 16 <u>develop or finance recreational facilities as authorized by Chapter</u>
- 17 375, Local Government Code, Sections 52 and 52-a, Article III,
- 18 Texas Constitution, and any other law that applies to the district.
- 19 Sec. 3901.104. AUTHORITY FOR ROAD PROJECTS. Under Section
- 20 52, Article III, Texas Constitution, the district may design,
- 21 acquire, construct, finance, issue bonds, notes, or other
- 22 <u>obligations for, improve, and convey to this state, a county, or a</u>
- 23 municipality for operation and maintenance macadamized, graveled,
- 24 or paved roads or improvements, including storm drainage, in aid of
- 25 those roads.
- Sec. 3901.105. CONVEYANCE AND APPROVAL OF ROAD PROJECT.
- 27 (a) The district shall convey a road project authorized by Section

- 1 <u>3901.104 to:</u>
- 2 (1) the municipality or county that will operate and
- 3 maintain the road if the municipality or county has approved the
- 4 plans and specifications of the road project; or
- 5 (2) the state if the state will operate and maintain
- 6 the road and the Texas Transportation Commission has approved the
- 7 plans and specifications of the road project.
- 8 (b) Except as provided by Subsection (c), the district shall
- 9 operate and maintain a road project authorized by Section 3901.104
- 10 that the district implements and is not approved by a municipality,
- 11 <u>a county</u>, or this state under Subsection (a).
- 12 (c) The district may agree in writing with a municipality, a
- 13 county, or this state to assign operation and maintenance duties to
- 14 the district, the municipality, the county, or this state in a
- 15 manner other than the manner described in Subsections (a) and (b).
- 16 Sec. 3901.106. DEVELOPMENT CORPORATION POWERS. The
- 17 district, using money available to the district, may exercise the
- 18 powers given to a development corporation under Chapter 505, Local
- 19 Government Code, including the power to own, operate, acquire,
- 20 construct, lease, improve, or maintain a project under that
- 21 <u>chapter.</u>
- Sec. 3901.107. NONPROFIT CORPORATION. (a) The board by
- 23 resolution may authorize the creation of a nonprofit corporation to
- 24 assist and act for the district in implementing a project or
- 25 providing a service authorized by this chapter.
- 26 (b) The nonprofit corporation:
- 27 (1) has each power of and is considered to be a local

- 1 government corporation created under Subchapter D, Chapter 431,
- 2 Transportation Code; and
- 3 (2) may implement any project and provide any service
- 4 authorized by this chapter.
- 5 (c) The board shall appoint the board of directors of the
- 6 nonprofit corporation. The board of directors of the nonprofit
- 7 corporation shall serve in the same manner as the board of directors
- 8 of a local government corporation created under Subchapter D,
- 9 Chapter 431, Transportation Code, except that a board member is not
- 10 required to reside in the district.
- 11 Sec. 3901.108. AGREEMENTS; GRANTS. (a) As provided by
- 12 Chapter 375, Local Government Code, the district may make an
- 13 agreement with or accept a gift, grant, or loan from any person.
- 14 (b) The implementation of a project is a governmental
- 15 <u>function or service for the purposes of Chapter 791, Government</u>
- 16 <u>Code</u>.
- Sec. 3901.109. LAW ENFORCEMENT SERVICES. To protect the
- 18 public interest, the district may contract with a qualified party,
- 19 including the county or the city, to provide law enforcement
- 20 services in the district.
- Sec. 3901.110. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
- 22 <u>district may join and pay dues to a charitable or nonprofit</u>
- 23 organization that performs a service or provides an activity
- 24 consistent with the furtherance of a district purpose.
- Sec. 3901.111. ECONOMIC DEVELOPMENT. (a) The district may
- 26 engage in activities that accomplish the economic development
- 27 purposes of the district.

- 1 (b) The district may establish and provide for the
- 2 administration of one or more programs to promote state or local
- 3 economic development and to stimulate business and commercial
- 4 activity in the district, including programs to:
- 5 (1) make loans and grants of public money; and
- 6 (2) provide district personnel and services.
- 7 (c) The district may create economic development programs
- 8 and exercise the economic development powers that:
- 9 (1) Chapter 380, Local Government Code, provides to a
- 10 municipality; and
- 11 (2) Subchapter A, Chapter 1509, Government Code,
- 12 provides to a municipality.
- 13 Sec. 3901.112. STRATEGIC PARTNERSHIP AGREEMENT. The
- 14 district may negotiate and enter into a written strategic
- 15 partnership agreement with the city under Section 43.0751, Local
- 16 Government Code.
- 17 Sec. 3901.113. REGIONAL PARTICIPATION AGREEMENT. The
- 18 district may negotiate and enter into a written regional
- 19 participation agreement with the city under Section 43.0754, Local
- 20 Government Code.
- Sec. 3901.114. ANNEXATION OR EXCLUSION OF LAND. (a) The
- 22 district may annex land as provided by Subchapter J, Chapter 49,
- 23 Water Code.
- 24 (b) The district may exclude land as provided by Subchapter
- 25 J, Chapter 49, Water Code. Section 375.044(b), Local Government
- 26 Code, does not apply to the district.
- (c) The district may include and exclude land as provided by

- 1 <u>Sections 54.739-54.747</u>, Water Code.
- 2 Sec. 3901.115. APPLICABILITY OF OTHER LAW TO CERTAIN
- 3 CONTRACTS. (a) Subchapter I, Chapter 49, Water Code, applies to a
- 4 district contract for construction work, equipment, materials, or
- 5 machinery. The district may use a project delivery method
- 6 described by Subchapter I, Chapter 49, Water Code, or Subchapter H,
- 7 Chapter 271, Local Government Code.
- 8 (b) Sections 375.221 and 375.223, Local Government Code, do
- 9 not apply to the district.
- Sec. 3901.116. TERMS OF EMPLOYMENT; COMPENSATION. The
- 11 board may employ and establish the terms of employment and
- 12 compensation of an executive director or general manager and any
- 13 other district employees the board considers necessary.
- 14 Sec. 3901.117. NO EMINENT DOMAIN POWER. The district may
- 15 not exercise the power of eminent domain.
- 16 [Sections 3901.118-3901.150 reserved for expansion]
- 17 SUBCHAPTER C-1. PUBLIC TRANSIT SYSTEM AND PARKING FACILITIES
- 18 Sec. 3901.151. PUBLIC TRANSIT SYSTEM; PETITION REQUIRED.
- 19 (a) The district may acquire, lease as lessor or lessee, construct,
- 20 develop, own, operate, and maintain a public transit system to
- 21 serve the area in the district.
- (b) The board may not act under Subsection (a) unless a
- 23 written petition requesting the action has been filed with the
- 24 board.
- 25 (c) The petition must be signed by:
- 26 (1) the owners of property representing a majority of
- 27 the total assessed value of the real property in the district that

- 1 abuts the right-of-way in which the public transit system is
- 2 proposed to be located; or
- 3 (2) the owners of a majority of the area of the real
- 4 property in the district that abuts the right-of-way in which the
- 5 public transit system is proposed to be located.
- 6 (d) For purposes of Subsection (c), the determination of a
- 7 majority is based on the property owners along the entire
- 8 right-of-way of the proposed transit project and may not be
- 9 calculated on a block-by-block basis.
- Sec. 3901.152. PARKING FACILITIES. (a) The district may
- 11 acquire, lease as lessor or lessee, construct, develop, own,
- 12 operate, and maintain parking facilities or a system of parking
- 13 facilities, including lots, garages, parking terminals, or other
- 14 structures or accommodations for parking motor vehicles off the
- 15 <u>streets and related appurtenances.</u>
- 16 (b) The district's parking facilities serve the public
- 17 purposes of the district and are owned, used, and held for a public
- 18 purpose even if leased or operated by a private entity for a term of
- 19 years.
- 20 (c) The district's parking facilities are parts of and
- 21 necessary components of a street and are considered to be a street
- 22 or road improvement.
- 23 <u>(d) The development and operation of the district's parking</u>
- 24 facilities may be considered an economic development program.
- Sec. 3901.153. RULES. The district may adopt rules
- 26 covering its public transit system or its public parking
- 27 facilities, except that a rule relating to or affecting the use of

- 1 the public right-of-way or a requirement for off-street parking is
- 2 subject to all applicable county requirements.
- 3 Sec. 3901.154. FEES. The district may impose a fee for the
- 4 use of the public transit system and associated parking facilities.
- 5 Sec. 3901.155. AGREEMENT WITH RAPID TRANSIT AUTHORITY. (a)
- 6 In this section, "authority" means a rapid transit authority
- 7 <u>created under Chapter 451, Transportation Code.</u>
- 8 (b) The district and an authority may agree to jointly
- 9 construct, own, operate, and maintain a transit facility or a
- 10 parking facility under the terms the authority and district desire.
- 11 (c) The agreement may provide that the district and the
- 12 authority exchange or trade land provided that each party to the
- 13 agreement receives fair market value. The authority is not
- 14 required to offer any property that it proposes to trade to the
- 15 <u>district for sale to the public or for sale to any abutting property</u>
- 16 <u>owner.</u>
- [Sections 3901.156-3901.200 reserved for expansion]
- 18 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS; ASSESSMENTS
- 19 Sec. 3901.201. MONEY USED FOR IMPROVEMENTS OR SERVICES.
- 20 The district may acquire, construct, finance, operate, maintain, or
- 21 provide any improvement or service authorized under this chapter or
- 22 Chapter 375, Local Government Code, using any money available to
- 23 the district.
- Sec. 3901.202. PETITION REQUIRED FOR FINANCING SERVICES AND
- 25 IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a
- 26 service or improvement project with assessments under this chapter
- 27 unless a written petition requesting that service or improvement

- 1 has been filed with the board.
- 2 (b) The petition must be signed by:
- 3 (1) the owners of a majority of the assessed value of
- 4 real property in the district subject to assessment according to
- 5 the most recent certified tax appraisal roll for the county; or
- 6 (2) at least 50 persons who own real property in the
- 7 district subject to assessment, if more than 50 persons own real
- 8 property in the district according to the most recent certified tax
- 9 appraisal roll for the county.
- Sec. 3901.203. METHOD OF NOTICE FOR HEARING. The district
- 11 may mail the notice required by Section 375.115(c), Local
- 12 Government Code, by certified or first class United States mail.
- 13 The board shall determine the method of notice.
- 14 Sec. 3901.204. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)
- 15 The board by resolution may impose and collect an assessment for any
- 16 purpose authorized by this chapter in all or any part of the
- 17 district.
- 18 <u>(b) An assessment, a reassessment, or an</u> assessment
- 19 resulting from an addition to or correction of the assessment roll
- 20 by the district, penalties and interest on an assessment or
- 21 reassessment, an expense of collection, and reasonable attorney's
- 22 fees incurred by the district are:
- 23 (1) a first and prior lien against the property
- 24 assessed;
- 25 (2) superior to any other lien or claim other than a
- 26 lien or claim for county, school district, or municipal ad valorem
- 27 taxes; and

- 1 (3) the personal liability of and a charge against the
- 2 owners of the property even if the owners are not named in the
- 3 assessment proceedings.
- 4 (c) The lien is effective from the date of the board's
- 5 resolution imposing the assessment until the date the assessment is
- 6 paid. The board may enforce the lien in the same manner that the
- 7 board may enforce an ad valorem tax lien against real property.
- 8 (d) The board may make a correction to or deletion from the
- 9 assessment roll that does not increase the amount of assessment of
- 10 any parcel of land without providing notice and holding a hearing in
- 11 the manner required for additional assessments.
- 12 Sec. 3901.205. TAX AND ASSESSMENT ABATEMENTS. The district
- 13 may designate reinvestment zones and may grant abatements of a tax
- 14 or assessment on property in the zones.
- 15 Sec. 3901.206. UTILITY PROPERTY EXEMPT FROM ASSESSMENTS.
- 16 The district may not impose an assessment on the property,
- 17 including the equipment, rights-of-way, facilities, or
- 18 improvements, of:
- 19 (1) an electric utility or a power generation company
- 20 as defined by Section 31.002, Utilities Code;
- 21 (2) a gas utility as defined by Section 101.003 or
- 22 121.001, Utilities Code;
- 23 (3) a telecommunications provider as defined by
- 24 Section 51.002, Utilities Code; or
- 25 (4) a person who provides to the public cable
- 26 television or advanced telecommunications services.
- 27 <u>Sec. 3901.207. AUTHORITY TO ISSUE BONDS AND OTHER</u>

- 1 OBLIGATIONS. (a) The district may issue by competitive bid or
- 2 negotiated sale bonds, notes, or other obligations payable wholly
- 3 or partly from taxes, assessments, fees, revenue, contract
- 4 payments, grants, or other district money, or any combination of
- 5 those sources of money, to pay for any authorized district purpose.
- 6 (b) In addition to any other terms authorized by the board
- 7 by bond order or resolution, the proceeds of the district's bonds
- 8 may be used for a reserve fund, credit enhancement, or capitalized
- 9 interest for the bonds.
- 10 (c) The limitation on the outstanding principal amount of
- 11 bonds, notes, and other obligations provided by Section 49.4645,
- 12 Water Code, does not apply to the district.
- Sec. 3901.208. MUNICIPALITY NOT REQUIRED TO PAY DISTRICT
- 14 OBLIGATIONS. Except as provided by Section 375.263, Local
- 15 Government Code, a municipality is not required to pay a bond, note,
- 16 or other obligation of the district.
- 17 [Sections 3901.209-3901.250 reserved for expansion]
- 18 SUBCHAPTER E. SALES AND USE TAX
- 19 Sec. 3901.251. APPLICABILITY OF CERTAIN TAX CODE
- 20 PROVISIONS. (a) Chapter 321, Tax Code, governs the imposition,
- 21 computation, administration, enforcement, and collection of the
- 22 sales and use tax authorized by this subchapter except to the extent
- 23 Chapter 321, Tax Code, is inconsistent with this chapter.
- 24 (b) A reference in Chapter 321, Tax Code, to a municipality
- 25 or the governing body of a municipality is a reference to the
- 26 <u>district or the board, respectively.</u>
- 27 <u>Sec. 3901.252.</u> <u>ELECTION; ADOPTION</u> OF TAX. (a) The district

- 1 may adopt a sales and use tax if authorized by a majority of the
- 2 voters of the district voting at an election held for that purpose.
- 3 (b) The board by order may call an election to authorize the
- 4 adoption of the sales and use tax. The election may be held on any
- 5 uniform election date and in conjunction with any other district
- 6 election.
- 7 (c) The ballot shall be printed to provide for voting for or
- 8 against the proposition: "Authorization of a sales and use tax in
- 9 the Bridgeland Management District at a rate not to exceed ____
- 10 percent" (insert rate of one or more increments of one-eighth of one
- 11 percent).
- 12 Sec. 3901.253. SALES AND USE TAX RATE. (a) On or after the
- 13 date the results are declared of an election held under Section
- 14 3901.252, at which the voters approved imposition of the tax
- 15 authorized by this subchapter, the board shall determine and adopt
- 16 by resolution or order the initial rate of the tax, which must be in
- 17 one or more increments of one-eighth of one percent.
- 18 (b) After the <u>election held under Section 3901.252</u>, the
- 19 board may increase or decrease the rate of the tax by one or more
- 20 increments of one-eighth of one percent.
