H.B. No. 3842

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Bridgeland Management District;  
providing authority to levy an assessment, impose a tax, and issue  
bonds.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle C, Title 4, Special District Local Laws  
Code, is amended by adding Chapter 3901 to read as follows:

CHAPTER 3901. BRIDGELAND MANAGEMENT DISTRICT

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 3901.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "City" means the City of Houston, Texas.

(3) "Commission" means the Texas Commission on  
Environmental Quality.

(4) "County" means Harris County.

(5) "Director" means a board member.

(6) "District" means the Bridgeland Management  
District.

Sec. 3901.002. CREATION AND NATURE OF DISTRICT. The  
district is a special district created under Section 59, Article  
XVI, Texas Constitution.

Sec. 3901.003. CONFIRMATION AND DIRECTORS' ELECTION  
REQUIRED. The temporary directors shall hold an election to  
confirm the creation of the district and to elect five permanent

1 directors as provided by Section 49.102, Water Code.

2 Sec. 3901.004. CONSENT OF MUNICIPALITY REQUIRED. The  
3 temporary directors may not hold an election under Section 3901.003  
4 until each municipality in whose corporate limits or  
5 extraterritorial jurisdiction the district is located has  
6 consented by ordinance or resolution to the creation of the  
7 district and to the inclusion of land in the district.

8 Sec. 3901.005. PURPOSE; DECLARATION OF INTENT. (a) The  
9 creation of the district is essential to accomplish the purposes of  
10 Sections 52 and 52-a, Article III, and Section 59, Article XVI,  
11 Texas Constitution, and other public purposes stated in this  
12 chapter. By creating the district, the legislature has established  
13 a program to accomplish the public purposes set out in Sections 52  
14 and 52-a, Article III, Texas Constitution.

15 (b) The creation of the district is necessary to promote,  
16 develop, encourage, and maintain employment, commerce,  
17 transportation, housing, tourism, recreation, the arts,  
18 entertainment, economic development, safety, and the public  
19 welfare in the district.

20 (c) This chapter and the creation of the district may not be  
21 interpreted to relieve the city, the county, or another  
22 governmental entity from providing the level of services provided  
23 as of the effective date of the Act enacting this chapter to the  
24 area in the district. The district is created to supplement and not  
25 to supplant governmental services provided in the district.

26 Sec. 3901.006. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)  
27 The district is created to serve a public use and benefit.

1       (b) All land and other property included in the district  
2 will benefit from the improvements and services to be provided by  
3 the district under powers conferred by Sections 52 and 52-a,  
4 Article III, and Section 59, Article XVI, Texas Constitution, and  
5 other powers granted under this chapter.

6       (c) The creation of the district is in the public interest  
7 and is essential to further the public purposes of:

8           (1) developing and diversifying the economy of the  
9 state;

10           (2) eliminating unemployment and underemployment; and

11           (3) developing or expanding transportation and  
12 commerce.

13       (d) The district will:

14           (1) promote the health, safety, and general welfare of  
15 residents, employers, potential employees, employees, visitors,  
16 and consumers in the district, and of the public;

17           (2) provide needed funding for the district to  
18 preserve, maintain, and enhance the economic health and vitality of  
19 the district territory as a community and business center; and

20           (3) promote the health, safety, welfare, and enjoyment  
21 of the public by providing pedestrian ways, road facilities, and  
22 recreational facilities and by landscaping and developing certain  
23 areas, which are necessary for the restoration, preservation, and  
24 enhancement of scenic beauty.

25       (e) Pedestrian ways along or across a street, whether at  
26 grade or above or below the surface, and street lighting, street  
27 landscaping, parking, and street art objects are parts of and

1 necessary components of a street and are considered to be a street  
2 or road improvement.

3 (f) The district will not act as the agent or  
4 instrumentality of any private interest even though the district  
5 will benefit many private interests as well as the public.

6 Sec. 3901.007. DISTRICT TERRITORY. (a) The district is  
7 initially composed of the territory described by Section 2 of the  
8 Act enacting this chapter, as that territory may have been modified  
9 under Section 3901.114 or other law.

10 (b) The boundaries and field notes of the district contained  
11 in Section 2 of the Act enacting this chapter form a closure. A  
12 mistake in the field notes or in copying the field notes in the  
13 legislative process does not affect the district's:

14 (1) organization, existence, or validity;

15 (2) right to issue any type of bond, note, or other  
16 obligation for a purpose for which the district is created or to pay  
17 the principal of and interest on the bond;

18 (3) right to impose or collect an assessment or tax; or

19 (4) legality or operation.

20 Sec. 3901.008. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES.

21 All or any part of the area of the district is eligible to be  
22 included in:

23 (1) a tax increment reinvestment zone created under  
24 Chapter 311, Tax Code;

25 (2) a tax abatement reinvestment zone created under  
26 Chapter 312, Tax Code;

27 (3) an enterprise zone created under Chapter 2303,

1 Government Code; or

2 (4) an industrial district created under Chapter 42,  
3 Local Government Code.

4 Sec. 3901.009. APPLICABILITY OF MUNICIPAL MANAGEMENT  
5 DISTRICTS LAW. Except as otherwise provided by this chapter,  
6 Chapter 375, Local Government Code, applies to the district.

7 Sec. 3901.010. LIBERAL CONSTRUCTION OF CHAPTER. This  
8 chapter shall be liberally construed in conformity with the  
9 findings and purposes stated in this chapter.

10 Sec. 3901.011. CONFLICTS OF LAW. This chapter prevails  
11 over any provision of general law, including a provision of Chapter  
12 375, Local Government Code, that is in conflict or inconsistent  
13 with this chapter.

14 [Sections 3901.012-3901.050 reserved for expansion]

15 SUBCHAPTER B. BOARD OF DIRECTORS

16 Sec. 3901.051. GOVERNING BODY; TERMS. (a) The district is  
17 governed by a board of five directors elected or appointed as  
18 provided by this chapter and Subchapter D, Chapter 49, Water Code.

19 (b) Except as provided by Section 3901.053, directors serve  
20 staggered four-year terms.

21 Sec. 3901.052. COMPENSATION. A director is entitled to  
22 receive fees of office and reimbursement for actual expenses as  
23 provided by Section 49.060, Water Code. Sections 375.069 and  
24 375.070, Local Government Code, do not apply to the board.

25 Sec. 3901.053. TEMPORARY DIRECTORS. (a) On or after the  
26 effective date of the Act creating this chapter, the owner or owners  
27 of a majority of the assessed value of the real property in the

1 district may submit a petition to the commission requesting that  
2 the commission appoint as temporary directors the five persons  
3 named in the petition. The commission shall appoint as temporary  
4 directors the five persons named in the petition.

5 (b) Temporary directors serve until the earlier of:

6 (1) the date permanent directors are elected under  
7 Section 3901.003; or

8 (2) the fourth anniversary of the effective date of  
9 the Act creating this chapter.

10 (c) If permanent directors have not been elected under  
11 Section 3901.003 and the terms of the temporary directors have  
12 expired, successor temporary directors shall be appointed or  
13 reappointed as provided by Subsection (d) to serve terms that  
14 expire on the earlier of:

15 (1) the date permanent directors are elected under  
16 Section 3901.003; or

17 (2) the fourth anniversary of the date of the  
18 appointment or reappointment.

19 (d) If Subsection (c) applies, the owner or owners of a  
20 majority of the assessed value of the real property in the district  
21 may submit a petition to the commission requesting that the  
22 commission appoint as successor temporary directors the five  
23 persons named in the petition. The commission shall appoint as  
24 successor temporary directors the five persons named in the  
25 petition.

26 (e) This section expires September 1, 2019.

27 [Sections 3901.054-3901.100 reserved for expansion]

1                   SUBCHAPTER C. POWERS AND DUTIES

2           Sec. 3901.101. GENERAL POWERS AND DUTIES. The district has  
3 the powers and duties necessary to accomplish the purposes for  
4 which the district is created.

5           Sec. 3901.102. IMPROVEMENT PROJECTS AND SERVICES. (a) The  
6 district may provide, design, construct, acquire, improve,  
7 relocate, operate, maintain, or finance an improvement project or  
8 service using money available to the district, or contract with a  
9 governmental or private entity to provide, design, construct,  
10 acquire, improve, relocate, operate, maintain, or finance an  
11 improvement project or service authorized under this chapter or  
12 under Chapter 375, Local Government Code.

13           (b) An improvement project described by Subsection (a) may  
14 be located inside or outside the district.

15           Sec. 3901.103. RECREATIONAL FACILITIES. The district may  
16 develop or finance recreational facilities as authorized by Chapter  
17 375, Local Government Code, Sections 52 and 52-a, Article III,  
18 Texas Constitution, and any other law that applies to the district.

19           Sec. 3901.104. AUTHORITY FOR ROAD PROJECTS. Under Section  
20 52, Article III, Texas Constitution, the district may design,  
21 acquire, construct, finance, issue bonds, notes, or other  
22 obligations for, improve, and convey to this state, a county, or a  
23 municipality for operation and maintenance macadamized, graveled,  
24 or paved roads or improvements, including storm drainage, in aid of  
25 those roads.

26           Sec. 3901.105. CONVEYANCE AND APPROVAL OF ROAD PROJECT.

27 (a) The district shall convey a road project authorized by Section

1 3901.104 to:

2 (1) the municipality or county that will operate and  
3 maintain the road if the municipality or county has approved the  
4 plans and specifications of the road project; or

5 (2) the state if the state will operate and maintain  
6 the road and the Texas Transportation Commission has approved the  
7 plans and specifications of the road project.

8 (b) Except as provided by Subsection (c), the district shall  
9 operate and maintain a road project authorized by Section 3901.104  
10 that the district implements and is not approved by a municipality,  
11 a county, or this state under Subsection (a).

12 (c) The district may agree in writing with a municipality, a  
13 county, or this state to assign operation and maintenance duties to  
14 the district, the municipality, the county, or this state in a  
15 manner other than the manner described in Subsections (a) and (b).

16 Sec. 3901.106. DEVELOPMENT CORPORATION POWERS. The  
17 district, using money available to the district, may exercise the  
18 powers given to a development corporation under Chapter 505, Local  
19 Government Code, including the power to own, operate, acquire,  
20 construct, lease, improve, or maintain a project under that  
21 chapter.

22 Sec. 3901.107. NONPROFIT CORPORATION. (a) The board by  
23 resolution may authorize the creation of a nonprofit corporation to  
24 assist and act for the district in implementing a project or  
25 providing a service authorized by this chapter.

26 (b) The nonprofit corporation:

27 (1) has each power of and is considered to be a local



1 government corporation created under Subchapter D, Chapter 431,  
2 Transportation Code; and

3 (2) may implement any project and provide any service  
4 authorized by this chapter.

5 (c) The board shall appoint the board of directors of the  
6 nonprofit corporation. The board of directors of the nonprofit  
7 corporation shall serve in the same manner as the board of directors  
8 of a local government corporation created under Subchapter D,  
9 Chapter 431, Transportation Code, except that a board member is not  
10 required to reside in the district.

11 Sec. 3901.108. AGREEMENTS; GRANTS. (a) As provided by  
12 Chapter 375, Local Government Code, the district may make an  
13 agreement with or accept a gift, grant, or loan from any person.

14 (b) The implementation of a project is a governmental  
15 function or service for the purposes of Chapter 791, Government  
16 Code.

17 Sec. 3901.109. LAW ENFORCEMENT SERVICES. To protect the  
18 public interest, the district may contract with a qualified party,  
19 including the county or the city, to provide law enforcement  
20 services in the district.

21 Sec. 3901.110. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The  
22 district may join and pay dues to a charitable or nonprofit  
23 organization that performs a service or provides an activity  
24 consistent with the furtherance of a district purpose.

25 Sec. 3901.111. ECONOMIC DEVELOPMENT. (a) The district may  
26 engage in activities that accomplish the economic development  
27 purposes of the district.

1       (b) The district may establish and provide for the  
2 administration of one or more programs to promote state or local  
3 economic development and to stimulate business and commercial  
4 activity in the district, including programs to:

5               (1) make loans and grants of public money; and

6               (2) provide district personnel and services.

7       (c) The district may create economic development programs  
8 and exercise the economic development powers that:

9               (1) Chapter 380, Local Government Code, provides to a  
10 municipality; and

11               (2) Subchapter A, Chapter 1509, Government Code,  
12 provides to a municipality.

13       Sec. 3901.112. STRATEGIC PARTNERSHIP AGREEMENT. The  
14 district may negotiate and enter into a written strategic  
15 partnership agreement with the city under Section 43.0751, Local  
16 Government Code.

17       Sec. 3901.113. REGIONAL PARTICIPATION AGREEMENT. The  
18 district may negotiate and enter into a written regional  
19 participation agreement with the city under Section 43.0754, Local  
20 Government Code.

21       Sec. 3901.114. ANNEXATION OR EXCLUSION OF LAND. (a) The  
22 district may annex land as provided by Subchapter J, Chapter 49,  
23 Water Code.

24               (b) The district may exclude land as provided by Subchapter  
25 J, Chapter 49, Water Code. Section 375.044(b), Local Government  
26 Code, does not apply to the district.

27               (c) The district may include and exclude land as provided by

1 Sections 54.739-54.747, Water Code.

2 Sec. 3901.115. FIREFIGHTING AND EMERGENCY MEDICAL  
3 SERVICES. Subchapter L, Chapter 49, Water Code, applies to the  
4 district.

5 Sec. 3901.116. APPLICABILITY OF OTHER LAW TO CERTAIN  
6 CONTRACTS. (a) Subchapter I, Chapter 49, Water Code, applies to a  
7 district contract for construction work, equipment, materials, or  
8 machinery. The district may use a project delivery method  
9 described by Subchapter I, Chapter 49, Water Code, or Subchapter H,  
10 Chapter 271, Local Government Code.

11 (b) Sections 375.221 and 375.223, Local Government Code, do  
12 not apply to the district.

13 Sec. 3901.117. TERMS OF EMPLOYMENT; COMPENSATION. The  
14 board may employ and establish the terms of employment and  
15 compensation of an executive director or general manager and any  
16 other district employees the board considers necessary.

17 Sec. 3901.118. NO EMINENT DOMAIN POWER. The district may  
18 not exercise the power of eminent domain.

19 [Sections 3901.119-3901.150 reserved for expansion]

20 SUBCHAPTER C-1. PUBLIC TRANSIT SYSTEM AND PARKING FACILITIES

21 Sec. 3901.151. PUBLIC TRANSIT SYSTEM; PETITION REQUIRED.

22 (a) The district may acquire, lease as lessor or lessee, construct,  
23 develop, own, operate, and maintain a public transit system to  
24 serve the area in the district.

25 (b) The board may not act under Subsection (a) unless a  
26 written petition requesting the action has been filed with the  
27 board.

1       (c) The petition must be signed by:

2               (1) the owners of property representing a majority of  
3 the total assessed value of the real property in the district that  
4 abuts the right-of-way in which the public transit system is  
5 proposed to be located; or

6               (2) the owners of a majority of the area of the real  
7 property in the district that abuts the right-of-way in which the  
8 public transit system is proposed to be located.

9       (d) For purposes of Subsection (c), the determination of a  
10 majority is based on the property owners along the entire  
11 right-of-way of the proposed transit project and may not be  
12 calculated on a block-by-block basis.

13       Sec. 3901.152. PARKING FACILITIES. (a) The district may  
14 acquire, lease as lessor or lessee, construct, develop, own,  
15 operate, and maintain parking facilities or a system of parking  
16 facilities, including lots, garages, parking terminals, or other  
17 structures or accommodations for parking motor vehicles off the  
18 streets and related appurtenances.

19       (b) The district's parking facilities serve the public  
20 purposes of the district and are owned, used, and held for a public  
21 purpose even if leased or operated by a private entity for a term of  
22 years.

23       (c) The district's parking facilities are parts of and  
24 necessary components of a street and are considered to be a street  
25 or road improvement.

26       (d) The development and operation of the district's parking  
27 facilities may be considered an economic development program.

1       Sec. 3901.153. RULES. The district may adopt rules  
2 covering its public transit system or its public parking  
3 facilities, except that a rule relating to or affecting the use of  
4 the public right-of-way or a requirement for off-street parking is  
5 subject to all applicable county requirements.

6       Sec. 3901.154. FEES. The district may impose a fee for the  
7 use of the public transit system and associated parking facilities.

8       Sec. 3901.155. AGREEMENT WITH RAPID TRANSIT AUTHORITY. (a)  
9 In this section, "authority" means a rapid transit authority  
10 created under Chapter 451, Transportation Code.

11       (b) The district and an authority may agree to jointly  
12 construct, own, operate, and maintain a transit facility or a  
13 parking facility under the terms the authority and district desire.

14       (c) The agreement may provide that the district and the  
15 authority exchange or trade land provided that each party to the  
16 agreement receives fair market value. The authority is not  
17 required to offer any property that it proposes to trade to the  
18 district for sale to the public or for sale to any abutting property  
19 owner.

20       [Sections 3901.156-3901.200 reserved for expansion]

21       SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS; ASSESSMENTS

22       Sec. 3901.201. MONEY USED FOR IMPROVEMENTS OR SERVICES.  
23 The district may acquire, construct, finance, operate, maintain, or  
24 provide any improvement or service authorized under this chapter or  
25 Chapter 375, Local Government Code, using any money available to  
26 the district.

27       Sec. 3901.202. PETITION REQUIRED FOR FINANCING SERVICES AND

1 IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a  
2 service or improvement project with assessments under this chapter  
3 unless a written petition requesting that service or improvement  
4 has been filed with the board.

5 (b) The petition must be signed by:

6 (1) the owners of a majority of the assessed value of  
7 real property in the district subject to assessment according to  
8 the most recent certified tax appraisal roll for the county; or

9 (2) at least 50 persons who own real property in the  
10 district subject to assessment, if more than 50 persons own real  
11 property in the district according to the most recent certified tax  
12 appraisal roll for the county.

13 Sec. 3901.203. METHOD OF NOTICE FOR HEARING. The district  
14 may mail the notice required by Section 375.115(c), Local  
15 Government Code, by certified or first class United States mail.  
16 The board shall determine the method of notice.

17 Sec. 3901.204. ASSESSMENTS; LIENS FOR ASSESSMENTS. (a)  
18 The board by resolution may impose and collect an assessment for any  
19 purpose authorized by this chapter in all or any part of the  
20 district.

21 (b) An assessment, a reassessment, or an assessment  
22 resulting from an addition to or correction of the assessment roll  
23 by the district, penalties and interest on an assessment or  
24 reassessment, an expense of collection, and reasonable attorney's  
25 fees incurred by the district are:

26 (1) a first and prior lien against the property  
27 assessed;

1           (2) superior to any other lien or claim other than a  
2 lien or claim for county, school district, or municipal ad valorem  
3 taxes; and

4           (3) the personal liability of and a charge against the  
5 owners of the property even if the owners are not named in the  
6 assessment proceedings.

7           (c) The lien is effective from the date of the board's  
8 resolution imposing the assessment until the date the assessment is  
9 paid. The board may enforce the lien in the same manner that the  
10 board may enforce an ad valorem tax lien against real property.

11           (d) The board may make a correction to or deletion from the  
12 assessment roll that does not increase the amount of assessment of  
13 any parcel of land without providing notice and holding a hearing in  
14 the manner required for additional assessments.

15           Sec. 3901.205. TAX AND ASSESSMENT ABATEMENTS. The district  
16 may designate reinvestment zones and may grant abatements of a tax  
17 or assessment on property in the zones.

18           Sec. 3901.206. UTILITY PROPERTY EXEMPT FROM ASSESSMENTS.  
19 The district may not impose an assessment on the property,  
20 including the equipment, rights-of-way, facilities, or  
21 improvements, of:

22           (1) an electric utility or a power generation company  
23 as defined by Section 31.002, Utilities Code;

24           (2) a gas utility as defined by Section 101.003 or  
25 121.001, Utilities Code;

26           (3) a telecommunications provider as defined by  
27 Section 51.002, Utilities Code; or

1           (4) a person who provides to the public cable  
2 television or advanced telecommunications services.

3           Sec. 3901.207. AUTHORITY TO ISSUE BONDS AND OTHER  
4 OBLIGATIONS. (a) The district may issue by competitive bid or  
5 negotiated sale bonds, notes, or other obligations payable wholly  
6 or partly from taxes, assessments, fees, revenue, contract  
7 payments, grants, or other district money, or any combination of  
8 those sources of money, to pay for any authorized district purpose.

9           (b) In addition to any other terms authorized by the board  
10 by bond order or resolution, the proceeds of the district's bonds  
11 may be used for a reserve fund, credit enhancement, or capitalized  
12 interest for the bonds.

13           (c) The limitation on the outstanding principal amount of  
14 bonds, notes, and other obligations provided by Section 49.4645,  
15 Water Code, does not apply to the district.

16           Sec. 3901.208. MUNICIPALITY NOT REQUIRED TO PAY DISTRICT  
17 OBLIGATIONS. Except as provided by Section 375.263, Local  
18 Government Code, a municipality is not required to pay a bond, note,  
19 or other obligation of the district.

20           [Sections 3901.209-3901.250 reserved for expansion]

21                   SUBCHAPTER E. SALES AND USE TAX

22           Sec. 3901.251. APPLICABILITY OF CERTAIN TAX CODE  
23 PROVISIONS. (a) Chapter 321, Tax Code, governs the imposition,  
24 computation, administration, enforcement, and collection of the  
25 sales and use tax authorized by this subchapter except to the extent  
26 Chapter 321, Tax Code, is inconsistent with this chapter.

27           (b) A reference in Chapter 321, Tax Code, to a municipality



1 or the governing body of a municipality is a reference to the  
2 district or the board, respectively.

3 Sec. 3901.252. ELECTION; ADOPTION OF TAX. (a) The district  
4 may adopt a sales and use tax if authorized by a majority of the  
5 voters of the district voting at an election held for that purpose.

6 (b) The board by order may call an election to authorize the  
7 adoption of the sales and use tax. The election may be held on any  
8 uniform election date and in conjunction with any other district  
9 election.

10 (c) The ballot shall be printed to provide for voting for or  
11 against the proposition: "Authorization of a sales and use tax in  
12 the Bridgeland Management District at a rate not to exceed \_\_\_\_\_  
13 percent" (insert rate of one or more increments of one-eighth of one  
14 percent).

15 Sec. 3901.253. SALES AND USE TAX RATE. (a) On or after the  
16 date the results are declared of an election held under Section  
17 3901.252, at which the voters approved imposition of the tax  
18 authorized by this subchapter, the board shall determine and adopt  
19 by resolution or order the initial rate of the tax, which must be in  
20 one or more increments of one-eighth of one percent.

21 (b) After the election held under Section 3901.252, the  
22 board may increase or decrease the rate of the tax by one or more  
23 increments of one-eighth of one percent.

24 (c) The initial rate of the tax or any rate resulting from  
25 subsequent increases or decreases may not exceed the lesser of:

26 (1) the maximum rate authorized by the district voters  
27 at the election held under Section 3901.252; or

1           (2) a rate that, when added to the rates of all sales  
2 and use taxes imposed by other political subdivisions with  
3 territory in the district, would result in the maximum combined  
4 rate prescribed by Section 321.101(f), Tax Code, at any location in  
5 the district.

6           Sec. 3901.254. TAX AFTER ANNEXATION. (a) This section  
7 applies to the district after a municipality annexes part of the  
8 territory in the district and imposes the municipality's sales and  
9 use tax in the annexed territory.

10           (b) If at the time of annexation the district has  
11 outstanding debt or other obligations payable wholly or partly from  
12 district sales and use tax revenue, Section 321.102(g), Tax Code,  
13 applies to the district.

14           (c) If at the time of annexation the district does not have  
15 outstanding debt or other obligations payable wholly or partly from  
16 district sales and use tax revenue, the district may:

17           (1) exclude the annexed territory from the district,  
18 if the district has no outstanding debt or other obligations  
19 payable from any source; or

20           (2) reduce the sales and use tax in the annexed  
21 territory by resolution or order of the board to a rate that, when  
22 added to the sales and use tax rate imposed by the municipality in  
23 the annexed territory, is equal to the sales and use tax rate

7 or other obligations and combine the pledged revenue with revenue

9       Sec. 3901.307. ABOLITION OF TAX. (a) Except as provided by  
10 Subsection (b), the board may abolish the tax imposed under this  
11 subchapter.

1           SECTION 3. (a) The legal notice of the intention to  
2 introduce this Act, setting forth the general substance of this  
3 Act, has been published as provided by law, and the notice and a  
4 copy of this Act have been furnished to all persons, agencies,  
5 officials, or entities to which they are required to be furnished  
6 under Section 59, Article XVI, Texas Constitution, and Chapter 313,  
7 Government Code.

8           (b) The governor, one of the required recipients, has  
9 submitted the notice and Act to the Texas Commission on  
10 Environmental Quality.

11           (c) The Texas Commission on Environmental Quality has filed  
12 its recommendations relating to this Act with the governor,  
13 lieutenant governor, and speaker of the house of representatives  
14 within the required time.

15           (d) The general law relating to consent by political  
16 subdivisions to the creation of districts with conservation,  
17 reclamation, and road powers and the inclusion of land in those  
18 districts has been complied with.

19           (e) All requirements of the constitution and laws of this  
20 state and the rules and procedures of the legislature with respect  
21 to the notice, introduction, and passage of this Act have been  
22 fulfilled and accomplished.

23           SECTION 4. This Act takes effect immediately if it receives  
24 a vote of two-thirds of all the members elected to each house, as  
25 provided by Section 39, Article III, Texas Constitution. If this  
26 Act does not receive the vote necessary for immediate effect, this  
27 Act takes effect September 1, 2011.
