2	relating to excluding certain territory from the Harris County Road
3	Improvement District No. 2.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. EXCLUDING TERRITORY. (a) In this section,
6	"district" means the Harris County Road Improvement District No. 2.
7	(b) The boundaries and field notes contained in Subsection
8	(c) of this section form a closure and the remainder of the property
9	in the district closes. A mistake made in the field notes or in
10	copying the field notes in the legislative process does not affect
11	the district's:
12	(1) organization, existence, or validity;
13	(2) right to issue any type of bond for the purposes
14	for which the district is created or to pay the principal of and
15	interest on a bond;
16	(3) right to impose a tax; or
17	(4) legality or operation.
18	(c) All of the territory in the following area is excluded
19	from the district:
20	All that certain tract or parcel of land containing 59.785
21	acres, (2,604.219 square feet) out of a 89.8417 acre tract being
22	situated in the James Strange Survey, 695, Harris County, Texas,
23	being out of a called 500 acre tract that is described as "First
24	Tract" in that conveyance to Invincible Oil Company by deed dated

1 December 1, 1961, and recorded in Volume 372, Page 388 of the Harris County Deed Records, being out of a called 101.2965 acre tract as 2 described in Deed recorded under Harris County Clerks File No. 3 N-838827 and being out of a called 101.04907 acre tract of land as 4 5 described in deed recorded under Harris County Clerk's File No. L-042670, Said 59.785 acre tract being all of a 9.662 acre tract as 6 described under Clerk's File No. V772991. A portion of a 55.503 as 7 8 described under Clerk's File No. V201632 and a portion of a 71.0561 as described under Clerk's File No. V324025 and being more 9 10 particularly described by metes and bounds as follows:

THENCE, North, 89 degrees 12 minutes 30 seconds West with the north line of said 37.002 acre tract a distance of 155.96 feet to a 3/4 inch iron rod found for corner marking the southeast corner of a called 8.00 acre tract to Humble I.S.D. recorded under Harris County Clerks File No. R-748181;

THENCE, North, 00 degrees 24 minutes 46 seconds east, along the east line of said 8.00 acre tract, a distance of 712.36 feet to a 5/8 inch capped iron rod set for the northwest corner of the herein

THENCE, South, 89 degrees 15 minutes 30 seconds east, a distance of 1227.76 feet to a 5/8 inch capped iron rod set for the most northerly northeast corner of the herein described tract;

5 THENCE, South, 00 degrees 44 minutes 30 seconds west, a 6 distance of 284.30 feet to a 5/8 inch capped iron rod set for corner 7 of the here-in described tract;

8 THENCE, East, a distance of 704.97 feet to a 5/8 inch capped 9 iron rod set for the most easterly northeast corner of the herein 10 described tract;

11 THENCE, South, a distance of 450.38 feet to a 5/8 inch capped 12 iron rod set from the most easterly southeast corner of the herein 13 described tract;

3 THENCE, South, O1 degrees 23 minutes 46 seconds East, a 4 distance of 118.15 feet to a 5/8 inch capped iron rod set for 5 corner;

6 THENCE, North, 88 degrees 36 minutes 14 seconds East, a 7 distance of 187.08 feet to a 5/8 inch capped iron rod set for 8 corner;

9 THENCE, South, 10 degrees 48 minutes 08 seconds West, a 10 distance of 462.67 feet to a 5/8 inch capped iron rod set for the 11 southeast corner of the herein described tract;

12 THENCE North, 89 degrees 35 minutes 24 seconds West, a 13 distance of 720.69 feet to the POINT OF BEGINNING and containing 14 59.785 acres, (2,604,219 square feet) of land.

15 SECTION 2. LEGAL NOTICE. (a) The legal notice of the 16 intention to introduce this Act, setting forth the general 17 substance of this Act, has been published as provided by law, and 18 the notice and a copy of this Act have been furnished to all 19 persons, agencies, officials, or entities to which they are 20 required to be furnished under Chapter 313, Government Code.

(b) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

25 SECTION 3. EFFECTIVE DATE. This Act takes effect 26 immediately if it receives a vote of two-thirds of all the members 27 elected to each house, as provided by Section 39, Article III, Texas

Constitution. If this Act does not receive the vote necessary for
immediate effect, this Act takes effect September 1, 2011.
