

HOUSE CONCURRENT RESOLUTION

1           WHEREAS, A life made rich by family, career, and community  
2 service has drawn to a close with the death of Lindley Paul Latham  
3 of Midland on December 11, 2010, at the age of 58; and

4           WHEREAS, Paul Latham was born in Midland on December 18,  
5 1951, and graduated from Midland High School in 1970; he then  
6 entered Texas Tech University, where he earned his bachelor's  
7 degree in 1974 and his doctor of jurisprudence degree in 1978; and

8           WHEREAS, After law school, Mr. Latham accepted a position  
9 with the Midland firm of Bullock, Scott & Neisig; he subsequently  
10 joined Clayton Williams Energy, Inc., and remained with that  
11 company for 29 years, until his passing; in 1991 he was appointed  
12 chief operating officer and executive vice president, and in those  
13 capacities he managed the firm's oil and gas, real estate, and other  
14 ventures; Mr. Latham also served on the company's board of  
15 directors; and

16           WHEREAS, Paul Latham married the former Debbie Favor and  
17 together they were blessed with four children, Ryan, Andrew, Kate,  
18 and Hunter; Mr. Latham shared his love of hunting with his family  
19 and enjoyed boating with them on Lake LBJ and traveling with them  
20 the world over; he also gave of his time to worthy causes, serving  
21 as director of numerous charities and as the board president of  
22 Trinity School of Midland for six years; and

23           WHEREAS, Paul Latham was a man on whom people could rely; his  
24 love of his family, his kindness toward others, and his sense of

1 responsibility were defining characteristics, and the greatness of  
2 his heart will continue to inspire all those who knew and loved him;  
3 now, therefore, be it

4       RESOLVED, That the 82nd Legislature of the State of Texas  
5 hereby pay tribute to the life of Lindley Paul Latham and extend  
6 sincere sympathy to the members of his family: to his wife, Debbie;  
7 to his children, Ryan, Andrew, Kate, and Hunter; to his sister,  
8 Linda Satterwhite, and her husband, Rodney; to his mother-in-law  
9 and father-in-law, Beth and Bob Favor, to his sisters-in-law and  
10 brothers-in-law, Lynn Priess and Dr. Chuck Priess, Vanessa and  
11 Adolph Micklethwait, and Sherry Favor; and to his many other  
12 relatives and friends; and, be it further
