

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Dr. Kelly Overley has been recognized with a 2011
2 Woman of Excellence award from the YWCA of Lubbock for her
3 professional achievements; and

4 WHEREAS, An annual project that has honored 185 individuals
5 since 1989, the YWCA Women of Excellence awards are given to women
6 leaders whose contributions to business, industry, and area
7 associations are crucial to the success of those organizations and
8 the Lubbock community; the awards program is in keeping with the
9 YWCA's goal to empower women and their families and to establish
10 strong role models for the next generation of South Plains women;
11 and

12 WHEREAS, Dr. Kelly Overley has served as vice chancellor for
13 institutional advancement with the Texas Tech University System and
14 as chief operating officer of the Texas Tech Foundation since 2007;
15 she leads a team of 120 development officers and oversees the
16 fund-raising initiatives of every component of the TTU System:
17 Texas Tech University, the Texas Tech University Health Sciences
18 Center, and Angelo State University; her stellar performance is
19 reflected in the fact that, under her guidance, her office has
20 achieved four of its top five fund-raising years; Dr. Overley is
21 currently directing an ambitious system-wide campaign to raise \$1
22 billion, a goal that is already more than halfway within reach; and

23 WHEREAS, A native of El Paso, Dr. Overley received her
24 bachelor's degree in public relations from Texas Tech University

1 and went on to earn a master's degree in educational administration
2 and a doctoral degree in educational leadership and foundations
3 from The University of Texas at El Paso; she began her professional
4 career as an elementary school teacher and as director of gifted and
5 talented education with the Socorro Independent School District,
6 and she subsequently worked as a major gifts officer at UTEP; in
7 2003, she joined the Texas Tech University Health Sciences Center
8 as senior director of development for the Paul L. Foster School of
9 Medicine; and

10 WHEREAS, In addition to her work with the TTU System, Dr.
11 Overley plays an active role in the community and has helped to lead
12 a number of worthy organizations, including the Alzheimer's
13 Association and the Foundation for Women's Resources; and

14 WHEREAS, This esteemed Texan is the recipient of many
15 well-deserved accolades, among them selection as an Outstanding
16 Alumna of 2010 by the Texas Tech University College of Mass
17 Communications and as an Outstanding Fundraising Professional by
18 the Lubbock Area Chapter of the Association of Fundraising
19 Professionals; in 2009 she was honored by the Lubbock Economic
20 Development Alliance as one of its "20 Under 40" leaders; and

21 WHEREAS, Inspiring others with her notable accomplishments,
22 Dr. Kelly Overley stands at the forefront of those individuals who
23 are making a positive difference in their communities, and she is
24 indeed deserving of this prestigious honor; now, therefore, be it

26 hereby congratulate Dr. Kelly Overley on her selection as a 2011
