## HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Parkinson's disease is a progressive neurological 2 movement disorder of the central nervous system that has an immense 3 impact on the lives of numerous individuals all around the world; and 4 5 WHEREAS, Symptoms of Parkinson's include tremors, difficulty with balance and speaking, slowness, rigidity of the limbs and 6 7 trunk, and cognitive and memory problems; more than one million Americans have been diagnosed with the disease, and it is the second 8 most common neurodegenerative condition in the United States; and 9 WHEREAS, The exact cause of Parkinson's disease is unknown, 10 11 and though new medicines and therapies may enhance life for 12 sufferers for a period of time, there is presently no cure; and 13 WHEREAS, Increased education and research are needed to find 14 more effective treatments with fewer side effects and also to reach the ultimate goal of ending this debilitating disease; and 15 WHEREAS, Providing assistance to individuals and families as 16 the disorder is 17 they cope with another priority; multidisciplinary approach that includes local wellness, support, 18 and caregiver groups in addition to medical treatment can play an 19 essential role in improving the quality of life for Parkinson's 20 21 sufferers; and 22 WHEREAS, All of these initiatives are being advanced thanks 23 to the dedicated staff and supporters of several organizations and

agencies, including the Parkinson's Action Network, the Parkinson's
