- 1 WHEREAS, Mount St. Michael Catholic School in the Oak Cliff
- 2 community of Dallas is celebrating its 25th anniversary on

- 4 WHEREAS, An educational apostolate of the Christian
- 5 Community of God's Delight, MSMCS began as the Prince of Peace
- 6 Community School in 1986; classes were initially held for preschool
- 7 through fourth-grade students, and one grade level was added during
- 8 each of the next four years until the current eighth-grade level was
- 9 reached; the name was changed to Mount St. Michael Catholic School
- 10 in 2007; and
- 11 WHEREAS, The school's Montessori educational program and
- 12 strong academic standards draw students from across the Metroplex;
- 13 children from 42 different zip codes and diverse socioeconomic
- 14 backgrounds attend the school, and enrollment has increased by more
- 15 than 50 percent in the past four years; and
- 16 WHEREAS, MSMCS employs a classical curriculum known as the
- 17 trivium, a three-phased approach that emphasizes grammar, logic,
- 18 and rhetoric and includes the mandatory study of Latin starting in
- 19 the first grade; in addition, students have the opportunity to
- 20 participate in artistic pursuits such as band, art, and dance while
- 21 also taking part in traditional religious studies; and
- WHEREAS, Because of the thorough work of MSMCS educators, 100
- 23 percent of the school's graduates who have applied have been
- 24 accepted to the high school of their choice; many alumni are already
