- 3 to be cherished by her family and friends; and
- WHEREAS, Born in Ruston, Louisiana, on August 21, 1924, the
- 5 former Eleanor Ruth Roye was the daughter of Jesse and Carrie Ruth
- 6 Roye; she moved with her family to West Monroe, where she
- 7 participated in equestrian shows, played in the marching band at
- 8 Ouachita Parish High School, and won state awards for her talent as
- 9 an oboe player; and
- 10 WHEREAS, She met William E. "Bill" Dozier, Jr., while
- 11 attending Louisiana Tech University and they married after he
- 12 enlisted in the U.S. Navy during World War II; while her husband
- 13 served in the Pacific, Mrs. Dozier drove for officers at the Selman
- 14 Army Air Field in Monroe, the site of the nation's largest
- 15 navigation school at that time; and
- WHEREAS, At war's end, Mr. and Mrs. Dozier made their home in
- 17 New Orleans, where they became the parents of two beloved
- 18 daughters, Martha Carolyn and Sarah Rebecca; this devoted mother
- 19 designed and sewed clothing for her daughters and was a gourmet
- 20 cook; and
- 21 WHEREAS, During the 12 years the family lived in Tyler, Mrs.
- 22 Dozier took an active role in civic affairs as a director of the
- 23 East Texas Symphony Orchestra, president of the Rosemary Garden
- 24 Club, and congregant of Marvin United Methodist Church; prompted by

- 1 Mr. Dozier's newspaper career, the couple next moved to Kerrville,
- 2 where they were among buyers of the Kerrville Daily Times; Mr.
- 3 Dozier served as president, publisher, and editor and Mrs. Dozier
- 4 held the office of secretary-treasurer and worked at the newspaper
- 5 for 15 years, successfully learning to typeset and sell
- 6 advertising; together, the Doziers went on to purchase and oversee
- 7 the production of newspapers in Boerne, Bandera, Pearsall, Dilley,
- 8 Cotulla, and Leakey; and
- 9 WHEREAS, Mrs. Dozier's enthusiasm and dedication further
- 10 benefited her board work at the Hill Country Youth Ranch, the
- 11 Kerrville Performing Arts Society, and the Riverside Nature Center
- 12 as well as various endeavors at First United Methodist Church and
- 13 the Schreiner Oaks Society; and
- 14 WHEREAS, Gracious, elegant, and intelligent, Eleanor Dozier
- 15 touched many lives during her time on this earth, and she will
- 16 forever hold a special place in the hearts of those who knew and
- 17 loved her; now, therefore, be it
