RESOLUTION

1 WHEREAS, A full and generous life drew to a close with the 2 death of journalist, publisher, and Kerr County commissioner 3 William H. Williams of Kerrville on December 5, 2010, at the age of 4 79; and

5 WHEREAS, Bill Williams was born on October 21, 1931, in 6 Birmingham, Alabama, to Calvin and Lillian Levy Williams; raised in 7 Indiana, he attended Gulf Coast Military Academy in Mississippi; 8 and

9 WHEREAS, Mr. Williams first came to Texas as a young man, when 10 he took a job as a printer at the *Waco Tribune-Herald*; in 1955, he 11 met his future wife, Lew, who was an editor at the paper and they 12 were married in 1958; together, they were blessed with a son, Will, 13 and two granddaughters, Erin and Caille; and

14 WHEREAS, A veteran newspaperman, Mr. Williams edited the 15 newspaper of the International Typographical Union in Colorado 16 Springs, Colorado; he then started working at the *Daily Racing Form* 17 in New York as the labor relations director and retired in the 1990s 18 as the paper's publisher; he and his wife moved to Kerrville in 1993 19 and purchased the *Kerrville Mountain Sun*, which they ran for three 20 years; and

21 WHEREAS, Throughout his life, Mr. Williams actively 22 participated in civic affairs; while he was working for the *Racing* 23 *Form*, he served three terms as a committeeman and three terms as 24 mayor of Freehold Township, New Jersey; in Texas, he was appointed

1 by Governor George Bush to the Upper Guadalupe River Authority, and 2 he was also named to serve on the Alamo Work Force Development 3 Board; and

WHEREAS, In 1998, Mr. Williams was elected as Kerr County commissioner for Precinct 2, and at the time of his death, he had just been reelected to his fourth term; during his tenure, he played a leading role in creating the Kerrville South Wastewater Project, providing sewer service for the first time to 250 homes; and

9 WHEREAS, This outstanding civic leader also served as a 10 director of the Alamo Area Council of Governments, the Alamo Area 11 Development Corporation, and the Kerr County/Kerrville Joint 12 Airport Board; he was a past president of the Host Lions Club and a 13 member of the Alliance for Progress in Center Point; he sat on the 14 executive committee of the Kerr Economic Development Foundation, 15 and he was a member of the Baylor University Alumni Foundation; and

16 WHEREAS, Mr. Williams was active with Zion Lutheran Church, 17 serving as congregation president during the construction of the 18 church's new sanctuary; he was also a talented pianist who enjoyed 19 performing at the church; and

20 WHEREAS, Bill Williams worked to better his community, and he 21 leaves behind a record of achievement and service that his loved 22 ones can look to with great pride; now, therefore, be it

RESOLVED, That the House of Representatives of the 82nd Texas Legislature hereby pay tribute to the life of the Honorable William H. Williams and extend sincere condolences to the members of his family: to his wife of 52 years, Lew Williams; to his son, Will Williams and his wife, Pam; to his brother, Calvin T. Williams; to
