- 13 Wright, and together they were blessed with three children, five
- 14 grandchildren, and three great-grandchildren; and
- WHEREAS, After the war, Mr. Roussel became a businessman, and
- 16 for almost half a century he owned and operated automotive service
- 17 stations in the Gretna, Belle Chasse, and Algiers neighborhoods of
- 18 New Orleans; he was active in his profession as a member of the
- 19 board of directors of the Service Station Association of Louisiana
- 20 and a member of the Texaco Dealer Advisory Board; and
- 21 WHEREAS, Mr. Roussel attended St. Andrew the Apostle Catholic
- 22 Church and was a member of Santa Maria Council No. 1724 of the
- 23 Knights of Columbus, which recognized him with the Family of the
- 24 Month Award in 1998 and the Gold Knight Award in 2004; he continued

- 1 to honor his military service as a member of American Legion Post
- 2 218; and
