- 7 for all she has done to help people rebuild their lives, and in 2009
- 8 she was invited to a special forum with Presidents George H. W. Bush
- 9 and Barack Obama that celebrated the 20th anniversary of the Point
- 10 of Light program; the many other accolades bestowed on her include
- 11 the Outstanding Community Involvement Award from the State Agency
- 12 Council of the Office of the Governor, the Humanitarian and
- 13 Volunteer of the Year Awards from the Texas Department of Health and
- 14 Human Services, the Volunteer of the Year Award from the Austin Area
- 15 Urban League, and a Five Who Care Award from television station
- 16 KVUE; and
- WHEREAS, Now poised to begin a new chapter in her life, Lisa
- 18 is busy charting goals for the future; her plans include
- 19 transforming the old Aycock High School in Rockdale into a
- 20 community center and teaching classes in healthy cooking to area
- 21 children; and

- 23 support of her husband of 32 years, Thurman Benford, her children,
- 24 Lucretia, Sedria, and Mark, and her grandchildren, Farrah, Brierra,
